Bill Introduction

A bill was requested by the Revisor's Office (Attachment 1).

Senator Emler moved, with a second by Senator Teichman, to conceptually introduce a bill concerning certain sections of the statutes which contain open records exceptions subject to the provisions of K.S.A. 45-229, and amendments thereto, which provides for legislative review of these exceptions in order to continue these exceptions for one year to allow the legislature an opportunity to review the required exceptions. Motion carried on a voice vote (7rs2561).

On May 2, 2008, copies of ten sets of minutes were distributed to the Committee for review with an approval date of May 12, 2008 (Attachment 2).

The meeting adjourned at 10:33 a.m. This was the last meeting of the Senate Ways and Means Committee for the 2008 Legislative Session.
