The following bills were introduced:

Representative Goyle introduced three bills:

- 1) Credit freeze in relation to identify theft
- 2) Rules of evidence regarding child sex crimes
- 3) Prepaid funeral notification

Representative Watkins requested two bills regarding notification of family members and interested parties and the Protective Parent Act

Representative Patton requested three bills:

- 1) On behalf of Representative Brown and a constituent; assistance in collection of child support, in particular dealing with licensed attorneys
- 2) Unlawful hosting of minors, drinking under age; add the word "reckless"
- 3) MIKI's Law; registered offenders and assist the public in receiving public notification

Representative Pauls requested two bills regarding Uniform Guardianship Law

Chairman Kinzer introduced four bills:

- 1) Judges reaching retirement age of 75 being allowed to complete current term
- 2) Time, Place and Manner regarding restrictions for adult oriented businesses
- 3) Evidence collection and maintenance of evidence at sex crimes
- 4) Conforming Kansas Definition - Child pornography to match the Federal definitions

Chairman Kinzer accepted the new bills without objection.

Richard Gannon, Kansas Press Association, requested a bill concerning public records with regards to criminal procedure relating to the issuance of warrants or summons. This was a reintroduction of a previous bill, year 2006 **HB 2742**.

The next meeting is scheduled for February 2, 2009.
