### **Rule Modifications:**

Subsection (b) of House Rule 1101 was changed to reflect new committees which are the successors to prior committees.

Two rules were changed to reflect the new voting machine capabilities. Rule 1701 is changed to provide that any member requesting the floor is to press the member's "speak bill" button; Rule 1906 is changed to provide that any member desiring to speak on a bill or offer an amendment is to press the member's "speak bill" button and to speak on a pending amendment is to press the member's "speak amendment" button.
