Approval of Minutes

Senator Schmidt moved to approve the minutes of March 16, March 17 and March 18 as written. The motion was seconded by Senator Umbarger. Motion carried on a voice vote.

Hearing on HB 2195 - Public records; certification of electronic records by the state archivist.

Daniel Yoza, Revisor, explained that **HB 2195** concerns the electronic preservation of state records (Attachment 1). The bill directs the state archivist to present recommendations to the state records board regarding the preservation process for maintaining the authenticity of electronic government records. When certified by the electronic signature of the state archivist, the electronic records shall have the same legal effect as the original record. The bill allows for reasonable fees to be charged for the preparation and certification of electronic copies.

Patricia Michaelis, Director, State Archives and Library Division, Kansas State Historical Society, presented testimony in support of **HB 2195** (Attachment 2). Ms. Michaelis stated that accountability and transparency are essential foundations of government, noting that the transformation into digital technology, necessitates a need to address the highly complex issue of preserving and providing access to authentic electronic government records.

Matt Veatch, State Archivist, Kansas State Historical Society, presented testimony in support of **HB 2195** (Attachment 2). Mr. Veatch stated that the Historical Society is currently engaged in a collaborative project to create a trusted digital repository for authentic Kansas government records. A pilot project initiated in 2004, called KSPACe is continuing to operate and provide digital publications. Mr. Veatch noted that Kansas Enterprise Electronic Preservation (KEEP) is partnering with the Legislature, Secretary of State and others to design, develop and implement the required software and hardware infrastructure to support the long-term preservation of state electronic records. The legislation would authorize the state records board to establish standards for preserving and maintaining the authenticity of digital records.

Responding to a question from the Committee, Mr. Veatch stated that digital records would be stamped with a digital fingerprint to provide authenticity. If any information is changed or dropped from the record, the digital fingerprint would change. Mr. Veatch indicated that there should be no cost involved with **HB 2195**. Funding for the KEEP project includes \$150,000, as an enhancement to the Kansas Historical Society budget

in FY 2009, and a \$175,000 grant from the Information Network of Kansas. Currently, they are pursuing grants from the federal government.

There were no other conferees to come before the Committee.

The hearing on **HB 2195** was closed.

Senator Kelly moved to amend **HB 2195** by adding language to allow for updating current statutes in which the word "facsimile" appears by adding "or electronic copy" or a similar phrasing (Attachment 3). The motion was seconded by Senator Wysong. Motion carried on a voice vote.

Senator Teichman moved to recommend **HB 2195** as amended favorable for passage. The motion was seconded by Senator Wysong. Motion carried on a voice vote.

Hearing on SB 326 - Increasing allowed transfer from crime victims compensation fund to crime victims assistance fund; from \$100,000 to \$300,000.

Reagan Cussimano, Kansas Legislative Research Department, explained that **SB 326** would allow the Office of the Attorney General to transfer additional funds from the crime victim's compensation fund to the crime victim's assistance fund, not to exceed \$300,000.

Dorothy Halley, Victim's Services Director, Office of the Attorney General, presented testimony in support of **SB 326** (Attachment 4). Ms. Halley noted that the passage of **SB 326** would allow the Attorney General's office to have the flexibility to continue balancing the needs of those victims needing compensation and those needing other services. Due to the economy crisis, it is anticipated that there will be less federal funding available.

There were no other conferees to come before the Committee.

The hearing on **SB 326** was closed.

Senator Lee moved to recommend **SB 326** favorable for passage. The motion was seconded by Senator Wysong. Motion carried on a voice vote.

Discussion and Action on SB 308 - State agencies; relating to the 20% administrative fee charged to agencies; cap increased from \$200,000 to \$350,000.

The Committee noted that an amendment added to the budget bill, **S Sub for HB 2354**, would reduce fee-funded agencies budgets by 10.0 percent, if **SB 308** does not become law.

Senator Masterson moved to recommend **SB 308** favorable for passage. The motion was seconded by Senator Lee. Motion carried on a vote of 7-4. Senator McGinn and Senator Umbarger requested to be recorded as voting "no".

Adjournment

Subject: HB 2195, concerning electronic records and the state archivist

House Bill 2195 concerns electronic preservation of state records. The bill creates a new statute and amends K.S.A. 45-406 and 75-3519.

New Section 1 of the bill directs the state archivist to present recommendations to the state records board regarding the preservation process for maintaining the authenticity of electronic government records. When certified by the electronic signature of the state archivist, the electronic records shall have the same legal effect as the original record. Reasonable fees may be charged for the preparation and certification of such electronic copies.

Section 2 amends K.S.A. 45-406 to direct that the state archivist's activities regarding electronic records. There are 3 changes. 1) In lines 16 through 19, the bill directs the archivist to certify by an electronic signature that any electronic government record maintained by the preservation process is authentic. 2) In lines 25 through 27, the archivist is permitted to charge reasonable fees for a copy of a document which is electronically certified. 3) Lines 29 through 31 authorize the state archivist to recommend rules and regulations to the state records board.

Section 3 amends K.S.A. 75-3519 in line 39 to deem electronically authenticated documents as original records.

The act would take effect after publication in the Kansas register.

There is a fiscal note which states that this bill will have a negligible impact on the state historical society, and can be implemented within existing resources.

Testimony by Patricia Michaelis

Chairman Emler; Vice Chairpersons McGinn and Vratil, and members of the committee: Thank you for the opportunity to speak with you today about House Bill 2195 which relates to the preservation and authenticity of electronic government records. My name is Pat Michaelis and I am director of the State Archives and Library Division at the Kansas State Historical Society (KSHS).

Accountability and transparency -- essential foundations of democratic government -- can only be achieved if citizens have access to authentic government records. Ironically, the rapidly evolving information technology that has enhanced citizen access to government also presents inherent risks to the preservation of and long-term access to government records. These risks are intimately tied to the ever-changing technology used to create records. While digital technologies have transformed the way we work, the way we manage the records of that work has not kept pace. Information systems are often funded, designed, implemented, and, now, even replaced without adequate thought for the records they create and how those records will be managed over time. As a result, Kansas government risks retaining electronic records and information for longer than needed and destroying electronic records and information with permanent administrative, legal, and historical value. In fact, we can no longer access the content of some early digital records. There is a need for the state of Kansas to address the highly complex issue of preserving and providing access to authentic electronic government records if we are to avoid what I refer to as the "archival black hole." While this bill is only one part of creating a digital State Archives, it is an important first step in declaring that electronic records preserved under processes established though this bill would have the same legal authority as those records transferred to the State Archives in paper form.

I want to introduce Matt Veatch, my assistant division director and the State Archivist.

Testimony by Matt Veatch

Thank you for the opportunity to speak with you today about House Bill 2195. My name is Matt Veatch and I am the State Archivist, employed by the Kansas State Historical Society (KSHS).

Since 1905, the Kansas State Historical Society, under authority granted in the Government Records Preservation Act (KSA 45-401 through 45-413), has served as the official archives for Kansas state government records. The transition from a paper-based to a digital state archives

presents significant technological, organizational, and resource challenges. For more than a decade, KSHS staff have worked closely with Kansas government entities to improve electronic records management and preservation practices. However, the Historical Society has not had the ability to properly authenticate electronic records with permanent value.

A pilot project initiated in 2004, called KSPACE, provided the KSHS with some experience in acquiring and providing access to digital content in the form of electronic state government publications. KSPACE continues to operate and new digital publications are added to the repository on a regular basis. Yet KSPACE does not possess all the elements of a trusted digital repository -- it is not fully compliant with national and professional standards for a digital archives.

The Historical Society is currently engaged in a collaborative project to create a trusted digital repository for authentic Kansas government records -- an electronic state archives. Using the acronym KEEP (Kansas Enterprise Electronic Preservation), project partners include the Kansas Legislature and the Secretary of State's Office. We have initiated discussions with the Kansas Judicial Branch about joining the project. Over the next year, we will use an ISO standard (the Open Archival Information System Reference Model -- ISO 14721:2003) to design, develop, and implement the required software and hardware infrastructure to support the long-term preservation of state electronic records. In parallel, the KSHS will be developing the necessary policy and regulatory framework required to support state organizations in their participation in the digital archives. The KEEP archives project represents a key element in a larger effort to develop a shared roadmap to guide electronic records and information management in Kansas government -- an effort that received legislative support in FY 2009. While one size won't fit all, the magnitude of the problem requires partnerships at all levels to resolve the challenges of managing electronic records and information and to avoid expensive duplication of efforts. The electronic archives envisioned by the KEEP project is an important step in enabling the state archives to make the transition from an analog to a digital repository.

HB 2195 would provide an important statutory foundation to support this transition to a digital archives and to digital government. Electronic records are now ubiquitous -- they are the norm in both the private and public sectors. For government to remain fully accountable and transparent and to continue to protect the legal rights of citizens, we must maintain electronic records that are authentic and trustworthy representations of our actions. Maintaining authentic records in a digital environment requires a careful and disciplined approach to their management -- particularly when digital records with long-term value must be transferred from one generation of technology to another. This bill would authorize the state records board to establish standards for preserving and maintaining the authenticity of digital records. Moreover, it would recognize that electronic records maintained in accordance with these standards can be certified by the State Archivist and, thus, have the same legal status as paper records maintained in the State Archives.

RE: Statutory uses of the word “facsimile”

Of the numerous places in which the word “facsimile” appears in statute, I have compiled a list of those uses that could be updated by adding “or electronic copy,” or similar phrasing. They are:

- K.S.A. 38-2305
- K.S.A. 59-29a08
- K.S.A. 59-29a19
- K.S.A. 59-29b67
- K.S.A. 59-29b71
- K.S.A. 59-2967
- K.S.A. 59-2971

The uses of the word “facsimile” in the above statutes are of the form that refers to a physical “fax” document. In most cases, the above statutes refer to transmitting some form of document in either written or facsimile form. By adding some reference to “electronic copy,” these statutes could definitely be “modernized” to include documents that could be transmitted via email and other electronic mediums.

As far as a course of action for this information, I would probably recommend drafting a bill for next session that would amend these statutes to include the “or electronic copy” language. Since these statutes are all “court-related,” in that they deal with court procedures, we could also speak to OJA if you would like us to do so, just to get further input. If you have any further questions, please do not hesitate to ask.

Mr. Chairman and members of the committee, thank you for allowing a hearing on this bill at this late date in the session. SB 326 simply allows our office to transfer additional funds from the crime victim's compensation fund to the crime victim's assistance fund. While there is no fiscal cost to the state as a result of this bill, there is much to gain: with passage of SB 326, our office will avoid reducing grant distributions from these very important funds during the budget crisis.

We are hearing from some of our grantees that the economic crisis is creating an increased demand for their services. It would be an unfortunate hardship for these agencies and the victims they serve if grant distributions were reduced. Due to current availability of Federal funds for Crime Victim Compensation, such a transfer would not create a hardship on victims requesting compensation from the state. Having the ability to transfer up to \$300,000 creates the flexibility necessary for the Victim Services Division to continue balancing the needs of those victims needing compensation, and those needing other services.
