HOUSE BILL No. 2134

AN ACT concerning workers compensation; amending K.S.A. 44-503a, 44-510c, 44-510d, 44-510e, 44-510f, 44-515, 44-516, 44-520, 44-525, 44-528, 44-531, 44-534a, 44-536 and 44-5a01 and K.S.A. 2010 Supp. 44-501, 44-508, 44-510b, 44-510h, 44-510k, 44-511, 44-523 and repealing the existing sections; also repealing K.S.A. 44-510a and 44-520a.

Be it enacted by the Legislature of the State of Kansas:

New Section 1. (a) It is the intent of the legislature that the workers compensation act shall be liberally construed only for the purpose of bringing employers and employees within the provisions of the act. The provisions of the workers compensation act shall be applied impartially to both employers and employees in cases arising thereunder.

(b) If in any employment to which the workers compensation act applies, an employee suffers personal injury by accident, repetitive trauma or occupational disease arising out of and in the course of employment, the employer shall be liable to pay compensation to the employee in accordance with the provisions of the workers compensation act.

(c) The burden of proof shall be on the claimant to establish the claimant's right to an award of compensation and to prove the various conditions on which the claimant's right depends. In determining whether the claimant has satisfied this burden of proof, the trier of fact shall consider the whole record.

(d) Except as provided in the workers compensation act, no employer, or other employee of such employer, shall be liable for any injury, whether by accident, repetitive trauma, or occupational disease, for which compensation is recoverable under the workers compensation act nor shall an employer be liable to any third party for any injury or death of an employee which was caused under circumstances creating a legal liability against a third party and for which workers compensation is payable by such employer.

Sec. 2. K.S.A. 2010 Supp. 44-501 is hereby amended to read as follows: 44-501. (a) If in any employment to which the workers compensation act applies, personal injury by accident arising out of and

(b) (1) (A) The employer shall not be liable under the workers compensation act where the injury, disability or death was contributed to by the employee's use or consumption of alcohol or any drugs, chemicals or any other compounds or substances, including, but not limited to, any drugs or medications which are available to the public without a prescription from a health care provider, prescription drugs or medications, any form or type of narcotic drugs, marijuana, stimulants, depressants or hallucinogens.

(B) In the case of drugs or medications which are available to the public without a prescription from a health care provider and prescription drugs or medications, compensation shall not be denied if the employee can show that such drugs or medications were being taken or used in therapeutic doses and there have been no prior incidences of the employee's impairment on the job as the result of the use of such drugs or medications within the previous 24 months.

(C) It shall be conclusively presumed that the employee was impaired due to alcohol or drugs if it is shown that, at the time of the injury, ~~that~~ the employee had an alcohol concentration of .04 or more, or a GCMS confirmatory test by quantitative analysis showing a concentration at or above the levels shown on the following chart for the drugs of abuse listed:

(D) If it is shown that the employee was impaired pursuant to subsection (b)(1)(C) at the time of the injury, there shall be a rebuttable presumption that the accident, injury, disability or death was contributed to by such impairment. The employee may overcome the presumption of

1 contribution by clear and convincing evidence.

2 (E) An employee's refusal to submit to a chemical test ~~shall not be~~
3 ~~admissible evidence to prove impairment unless there was probable cause~~
4 ~~to believe that the employee used, possessed or was impaired by a drug or~~
5 ~~alcohol while working at the request of the employer shall result in the~~
6 ~~forfeiture of benefits under the workers compensation act if the employer~~
7 ~~had sufficient cause to suspect the use of alcohol or drugs by the~~
8 ~~claimant or if the employer's policy clearly authorizes post-injury testing.~~

14 (2) The results of a chemical test shall ~~not~~ be admissible evidence to
15 prove impairment ~~unless the following conditions were met if the~~
16 ~~employer establishes that the testing was done under any of the following~~
17 ~~circumstances:~~

18 (A) As a result of an employer mandated drug testing policy, in
19 place in writing prior to the date of accident or injury, requiring any
20 worker to submit to testing for drugs or alcohol;

21 (B) during an autopsy or in the normal course of medical treatment
22 for reasons related to the health and welfare of the injured worker and
23 not at the direction of the employer;

24 (C) the worker, prior to the date and time of the accident or injury,
25 gave written consent to the employer that the worker would voluntarily

36 evidence to prove impairment unless the following conditions are met:

4 tested for alcohol content by a laboratory commonly used for that purpose
5 by state law enforcement agencies;

6 ~~(E)~~(D) the test was confirmed by gas chromatography-mass
7 spectroscopy or other comparably reliable analytical method, except that
8 no such confirmation is required for a blood alcohol sample; ~~and~~

9 ~~(F)~~(E) the foundation evidence must establish, beyond a reasonable
10 doubt, that the test results were from the sample taken from the

29 ~~(A) The testing was done as a result of an employer mandated drug~~
30 ~~testing policy, in place in writing prior to the date of accident, requiring~~
31 ~~any worker to submit to testing for drugs or alcohol if they are involved~~
32 ~~in an accident which requires medical attention;~~

33 ~~(B) the testing was done in the normal course of medical treatment~~

11 than the employee's usual work in the course of the employee's regular
12 employment.

13 (f)(d) Except as provided in the workers compensation act, no
14 construction design professional who is retained to perform professional
15 services on a construction project or any employee of a construction
16 design professional who is assisting or representing the construction
17 design professional in the performance of professional services on the site
18 of the construction project, shall be liable for any injury resulting from
19 the employer's failure to comply with safety standards on the construction
20 project for which compensation is recoverable under the workers
21 compensation act, unless responsibility for safety practices is specifically
22 assumed by contract. The immunity provided by this subsection to any
23 construction design professional shall not apply to the negligent
24 preparation of design plans or specifications.

6 work disability, or permanent total disability shall be reduced by the
7 amount of functional impairment determined to be preexisting. Any such
8 reduction shall not apply to temporary total disability, nor shall it apply
9 to compensation for medical treatment.

10 (1) Where workers compensation benefits have previously been
11 awarded through settlement or judicial or administrative determination
12 in Kansas, the percentage basis of the prior settlement or award shall
13 conclusively establish the amount of functional impairment determined to
14 be preexisting. Where workers compensation benefits have not previously
15 been awarded through settlement or judicial or administrative
16 determination in Kansas, the amount of preexisting functional
17 impairment shall be established by competent evidence.

18 (2) In all cases, the applicable reduction shall be calculated as
19 follows:

20 (A) If the preexisting impairment is the result of injury sustained
21 while working for the employer against whom workers compensation
22 benefits are currently being sought, any award of compensation shall be
23 reduced by the current dollar value attributable under the workers
24 compensation act to the percentage of functional impairment determined
25 to be preexisting. The "current dollar value" shall be calculated by
26 multiplying the percentage of preexisting impairment by the
27 compensation rate in effect on the date of the accident or injury against
28 which the reduction will be applied.

29 (B) In all other cases, the employer against whom benefits are
30 currently being sought shall be entitled to a credit for the percentage of
31 preexisting impairment.

32 [REDACTED] If the employee ~~is receiving~~ receives, whether periodically or
33 by lump sum, retirement benefits under the federal social security act or
34 retirement benefits from any other retirement system, program, policy or
35 plan which is provided by the employer against which the claim is being
36 made, any compensation benefit payments which the employee is eligible
37 to receive under the workers compensation act for such claim shall be
38 reduced by the weekly equivalent amount of the total amount of all such
39 retirement benefits, less any portion of any such retirement benefit, other
40 than retirement benefits under the federal social security act, that is
41 attributable to payments or contributions made by the employee, but in no
42 event shall the workers compensation benefit be less than the workers
43 compensation benefit payable for the employee's percentage of functional

1 impairment. *Where the employee elects to take retirement benefits in a*

3 *year over the employee's life expectancy to determine the weekly*
4 *equivalent value of the benefits.*

6 503a. Whenever an employee is engaged in multiple employment, in
7 which such employee performs the same or a very similar type of work
8 on a part-time basis for each of two (2) or more employers, and such
9 employee sustains an injury ~~by accident~~ which arose out of and in the
10 course of the multiple employment with all such employers, and which
11 did not clearly arise out of and in the course of employment with any
12 particular employer, all such employers shall be liable to pay a
13 proportionate amount of the compensation payable under the workmen's
14 compensation act as follows: Each such employer shall be liable for such
15 proportion of the total amount of compensation which is required to be
16 paid by all such employers, as the average ~~gross~~ weekly wages paid to the
17 employee by such employer, bears to the total average ~~gross~~ weekly
18 wages paid to the employee by all such employers, determined as
19 provided in subsection (b) ~~(7)~~(3) of K.S.A. 44-511, ~~as amended and~~
20 ~~amendments thereto~~.

21 Sec. 4. K.S.A. 2010 Supp. 44-508 is hereby amended to read as
22 follows: 44-508. As used in the workers compensation act:

23 (a) "Employer" includes: (1) Any person or body of persons,
24 corporate or unincorporate, and the legal representative of a deceased
25 employer or the receiver or trustee of a person, corporation, association or
26 partnership; (2) the state or any department, agency or authority of the
27 state, any city, county, school district or other political subdivision or
28 municipality or public corporation and any instrumentality thereof; and
29 (3) for the purposes of community service work, the entity for which the
30 community service work is being performed and the governmental
31 agency which assigned the community service work, if any, if either such
32 entity or such governmental agency has filed a written statement of
33 election with the director to accept the provisions under the workers
34 compensation act for persons performing community service work and in
35 such case such entity and such governmental agency shall be deemed to
36 be the joint employer of the person performing the community service
37 work and both shall have the rights, liabilities and immunities provided
38 under the workers compensation act for an employer with regard to the
39 community service work, except that the liability for providing benefits
40 shall be imposed only on the party which filed such election with the
41 director, or on both if both parties have filed such election with the
42 director; for purposes of community service work, "governmental
43 agency" shall not include any court or any officer or employee thereof

1 and any case where there is deemed to be a "joint employer" shall not be
2 construed to be a case of dual or multiple employment.

3 (b) "Workman" or "employee" or "worker" means any person who
4 has entered into the employment of or works under any contract of
5 service or apprenticeship with an employer. Such terms shall include but
6 not be limited to: Executive officers of corporations; professional
7 athletes; persons serving on a volunteer basis as duly authorized law
8 enforcement officers, attendants, as defined in subsection (d) of K.S.A.
9 65-6112, and amendments thereto, drivers of ambulances as defined in
10 subsection (b) of K.S.A. 65-6112, and amendments thereto, firefighters,
11 but only to the extent and during such periods as they are so serving in
12 such capacities; persons employed by educational, religious and
13 charitable organizations, but only to the extent and during the periods that
14 they are paid wages by such organizations; persons in the service of the
15 state, or any department, agency or authority of the state, any city, school
16 district, or other political subdivision or municipality or public
17 corporation and any instrumentality thereof, under any contract of
18 service, express or implied, and every official or officer thereof, whether
19 elected or appointed, while performing official duties; persons in the
20 service of the state as volunteer members of the Kansas department of
21 civil air patrol, but only to the extent and during such periods as they are
22 officially engaged in the performance of functions specified in K.S.A. 48-
23 3302, and amendments thereto; volunteers in any employment, if the
24 employer has filed an election to extend coverage to such volunteers;
25 minors, whether such minors are legally or illegally employed; and
26 persons performing community service work, but only to the extent and
27 during such periods as they are performing community service work and
28 if an election has been filed an election to extend coverage to such
29 persons. Any reference to an employee who has been injured shall, where
30 the employee is dead, include a reference to the employee's dependents,
31 to the employee's legal representatives, or, if the employee is a minor or
32 an incapacitated person, to the employee's guardian or conservator.
33 Unless there is a valid election in effect which has been filed as provided
34 in K.S.A. 44-542a, and amendments thereto, such terms shall not include
35 individual employers, limited liability company members, partners or
36 self-employed persons.

37 (c) (1) "Dependents" means such members of the employee's family
38 as were wholly or in part dependent upon the employee at the time of the
39 accident or injury.

40 (2) "Members of a family" means only surviving legal spouse and
41 children; or if no surviving legal spouse or children, then parents or
42 grandparents; or if no parents or grandparents, then grandchildren; or if
43 no grandchildren, then brothers and sisters. In the meaning of this section,

1 parents include stepparents, children include stepchildren, grandchildren
2 include stepgrandchildren, brothers and sisters include stepbrothers and
3 stepsisters, and children and parents include that relation by legal
4 adoption. In the meaning of this section, a surviving spouse shall not be
5 regarded as a dependent of a deceased employee or as a member of the
6 family, if the surviving spouse shall have for more than six months
7 willfully or voluntarily deserted or abandoned the employee prior to the
8 date of the employee's death.

9 (3) "Wholly dependent child or children" means:

10 (A) A birth child or adopted child of the employee except such a
11 child whose relationship to the employee has been severed by adoption;

12 (B) a stepchild of the employee who lives in the employee's
13 household;

14 (C) any other child who is actually dependent in whole or in part on
15 the employee and who is related to the employee by marriage or
16 consanguinity; or

17 (D) any child as defined in subsection (c)(3)(A), (3)(B)
18 or (3)(C) who is less than 23 years of age and who is not physically or
19 mentally capable of earning wages in any type of substantial and gainful
20 employment or who is a full-time student attending an accredited
21 institution of higher education or vocational education.

22 (d) "Accident" means an undesigned, sudden and unexpected
23 traumatic event or events, usually of an afflictive or unfortunate nature
24 and often, but not necessarily, accompanied by a manifestation of force.
25 The elements of an accident, as stated herein, are not to be construed in a
26 strict and literal sense, but in a manner designed to effectuate the purpose
27 of the workers compensation act that the employer bear the expense of
28 accidental injury to a worker caused by the employment. In cases where
29 the accident occurs as a result of a series of events, repetitive use,
30 cumulative traumas or microtraumas, the date of accident shall be the
31 date the authorized physician takes the employee off work due to the
32 condition or restricts the employee from performing the work which is
33 the cause of the condition. In the event the worker is not taken off work
34 or restricted as above described, then the date of injury shall be the
35 earliest of the following dates: (1) The date upon which the employee
36 gives written notice to the employer of the injury; or (2) the date the
37 condition is diagnosed as work related, provided such fact is
38 communicated in writing to the injured worker. In cases where none of
39 the above criteria are met, then the date of accident shall be determined
40 by the administrative law judge based on all the evidence and
41 circumstances; and in no event shall the date of accident be the date of, or
42 the day before the regular hearing. Nothing in this subsection shall be
43 construed to preclude a worker's right to make a claim for aggravation of

1 ~~injuries under the workers compensation act.~~ An accident shall be
2 identifiable by time and place of occurrence, at the time produce
3 symptoms of an injury, and occur during a single work shift. The accident
4 must be the prevailing factor in causing the injury. "Accident" shall in no
5 case be construed to include repetitive trauma in any form.

6 (e) "Repetitive trauma" refers to cases where an injury occurs as a
7 result of repetitive use, cumulative traumas or microtraumas. The
8 repetitive nature of the injury must be demonstrated by diagnostic or
9 clinical tests. The repetitive trauma must be the prevailing factor in
10 causing the injury. "Repetitive trauma" shall in no case be construed to
11 include occupational disease, as defined in K.S.A. 44-5a01, and
12 amendments thereto.

13 In the case of injury by repetitive trauma, the date of injury shall be
14 the earliest of:

15 (1) The date the employee, while employed for the employer against
16 whom benefits are sought, is taken off work by a physician due to the
17 diagnosed repetitive trauma;

18 (2) the date the employee, while employed for the employer against
19 whom benefits are sought, is placed on modified or restricted duty by a
20 physician due to the diagnosed repetitive trauma;

21 (3) the date the employee, while employed for the employer against
22 whom benefits are sought, is advised by a physician that the condition is
23 work-related; or

24 (4) the last day worked, if the employee no longer works for the
25 employer against whom benefits are sought.

26 In no case shall the date of accident be later than the last date
27 worked.

(i)(j) "Health care provider" means any person licensed, by the proper licensing authority of this state, another state or the District of Columbia, to practice medicine and surgery, osteopathy, chiropractic, dentistry, optometry, podiatry, audiology or psychology.

(j)(k) "Secretary" means the secretary of labor.

(k)(l) "Construction design professional" means any person who is an architect, professional engineer, landscape architect or land surveyor who has been issued a license by the state board of technical professions to practice such technical profession in Kansas or any corporation organized to render professional services through the practice of one or more of such technical professions in Kansas under the professional corporation law of Kansas or any corporation issued a certificate of authorization under K.S.A. 74-7036, and amendments thereto, to practice one or more of such technical professions in Kansas.

24 (b) The commissioner of insurance, acting as administrator of the
25 workers compensation fund, shall have a cause of action against the
26 employer for recovery of any amounts paid from the workers
27 compensation fund pursuant to this section. Such action shall be filed in
28 the district court of the county in which the accident occurred or where
29 the contract of employment was entered into.

28 follows: 44-552. (a) The director with the approval of the secretary of
29 labor shall at each hearing under the workers compensation act appoint a
30 certified shorthand reporter, who may be within the classified service of
31 the Kansas civil service act, to attend each hearing where testimony is
32 introduced, and preserve a complete record of all oral or documentary
33 evidence introduced and all proceedings had at such hearing unless such
34 appointment is waived by mutual agreement. At the conclusion of the
35 hearing in any case, if neither party has requested opportunity to file
36 briefs, the administrative law judge may read into the record for
37 certification and filing in the office of the director such stipulations,
38 findings, rulings or orders the administrative law judge deems expedient
39 to the early disposition of the case. If the administrative law judge uses
40 such procedure, with the consent of the parties, no transcript of the record
41 of the hearing shall be made, except that part which is read into the record
42 by the administrative law judge.

43 (b) All testimony introduced and proceedings had in hearings shall

1 be taken down by the certified shorthand reporter, and if an action for
2 review is commenced or if the director, or either party or the best interests
3 of the administration of justice, so instructs, the certified shorthand
4 reporter shall transcribe the certified shorthand reporter's notes of such
5 hearing. If an action for review is commenced, the cost of preparing a
6 transcript shall be paid as provided by K.S.A. 77-620 and amendments
7 thereto. If no action for review is commenced, the cost of preparing a
8 transcript shall be taxed as costs in the case at the discretion of the
9 director in accordance with fair and customary rates charged in the state
10 of Kansas. All official notes of such certified shorthand reporters shall be
11 preserved and filed in the office of the director. Any transcript prepared as
12 above provided and duly certified shall be received as evidence by the
13 board and by any court with the same effect as if the certified shorthand
14 reporter were present and testified to the records so certified.

15 (c) The director or administrative law judge, whoever is conducting
16 the hearing, may make the findings, awards, decisions, rulings or
17 modifications of findings or awards and do all acts at any time without
18 awaiting the transcription of the testimony of the certified shorthand
19 reporter if the director or administrative law judge deems it expedient and
20 advisable to do so.
