Approval of Minutes

Senator Abrams moved to approve the minutes of January 12, 13, and 18, 2011 as written. The motion was seconded by Senator Marshall. Motion carried on a voice vote.

Presentation: Midwestern Higher Education Compact

Lana Oleen, Interim President, Midwestern Higher Education Compact (MHEC), appeared before the members of the committee with a presentation. MHEC is a nonprofit regional organization comprised of twelve Midwestern states established by compact statute to assist Midwestern states in advancing higher education through interstate cooperation and resource sharing. The compact fulfills its interstate mission through three core functions of cost savings, student access, and policy research by

- reducing administrative costs;
- encouraging student access, completion, and affordability;
- facilitating public policy analysis and information exchange;
- enhancing regional academic cooperation; and
- encouraging quality educational programs and services in higher education

Included in her presentation was a chart (<u>Attachment 1</u>) showing program commitment costs for each of the twelve states as well as program savings for the twelve months ending June 30, 2010, and cumulative savings for member states through June, 2010.

As required by statute, she next presented a report for the State of Kansas (<u>Attachment 2</u>). Items covered included cost savings for items such as property insurance, computer hardware, and computer software. Other programs include the e-transcript initiative which is available to all secondary and postsecondary schools; a student exchange program offering reduced tuition to attend out-of-state institutions; and research conducted on educational requirements in the workforce, postsecondary enrollment, retention and completion rates, earnings rates by educational levels, and tuition costs.

A short question and answer session followed.

Senator Teichman introduced members of the Edwards County Leadership Program spending the day in the Statehouse.

The next meeting is scheduled for January 24, 2011.

Cost Savings

MHEC's cost savings function addresses areas of regional need through the development of programs intended to offer the best pricing, support, and contract terms in the region. Pricing is established for quantity-one purchases, but additional discounts are also often available from vendors for bulk purchases. MHEC selectively and strategically pursues only those initiatives that would greatly benefit a large segment of colleges, universities, and state/local governments and cannot generally be replicated by any single entity acting on its own. Current programs are available for property insurance, computer hardware, and computer software.

 Cost savings programs saved the MHEC region \$30.8 million for FY10.

Master Property Program

 The property insurance program insures over 100 campuses nationwide with property values exceeding \$73 billion.

Technology

Because of the benefits and savings achieved as a result of its current cost savings programs, MHEC is working with Lumina Foundation for Education to explore additional cost savings programs in two new areas. MHEC has been awarded a three-year, \$800,000 grant from Lumina to work with institutional and industry experts to research, develop, and implement health care and energy cost savings programs. MHEC is working with three separate committees—one each for energy, student health benefits, and employee health benefits exploring current market conditions and opportunities, gathering relevant information and data, and analyzing the data for cost savings program possibilities. All three committees are currently in the program development stage and plan to launch corresponding initiatives during 2011.

Cost Savings in Kansas

- Johnson County Community College is the sole Kansas participant in the Master Property Program.
- Overall cost savings increased \$800,000 from the previous year due to an increase in usage by Kansas entities of MHEC technologies contracts.
- MHEC statutes allow entities to use the MHEC contracts. Many institutions may not be aware that the MHEC contracts are a legal and endorsed alternative.
- Hardware programs are also available to state and local governments.






During the 2009-10 School Year

- 1,504 (or 45%) of MSEP students were enrolled in programs corresponding to those with the most job openings between 2008-2018.
- 1,826 (or 55%) of MSEP students were not enrolled in programs corresponding to those with the most job openings between 2008-2018.
- These ratios have remained consistent over the past years.



Workforce Demands


- Technological advancement, global competition, and other labor market forces are driving an increasing demand for postsecondary education and training.
- In the nation as a whole, 63% of all jobs in 2018 will require some level of postsecondary education; the figure is higher in 8 of the 12 MHEC states.
- Among MHEC states, the proportion of all jobs that will require some level of postsecondary education in 2018 ranges from 58% in Indiana to 70% in Minnesota.
- In 9 of the 12 MHEC states, more than half of all jobs in 2018 will require at least an associate's degree.
- Proportionally, associate's degrees will be in greatest demand in North Dakota, bachelor's degrees will be in greatest demand in Minnesota, and graduate degrees will be in greatest demand in Illinois.



Postsecondary Enrollment

- Nationally, 72% of undergraduate students are enrolled in public institutions; among MHEC states the figure ranges from 58% in Missouri to 86% in Kansas and North Dakota.
- Among public enrollments, the proportion of students in community colleges ranges from 13% in South Dakota and 21% in North Dakota to 56% in Iowa and 63% in Illinois; nationally, the figure is 49%.





Retention and Completion

- Nationally, the first to second year persistence rate among students at 2-year public institutions is 59%; only 4 of the 12 MHEC states exceed this figure (Michigan, 59%; Nebraska, 62%; South Dakota, 67%; and North Dakota, 69%).
- The first to second year persistence rate among students at 4-year public institutions across the U.S. is 78%; half of the 12 MHEC states meet or exceed this figure, led by lowa at 83%.
- Nationally, the first to second year persistence rate among students at 4-year private, not-for-profit institutions is 80%; only 2 of the 12 MHEC states exceed this figure (Indiana, 81%; and Minnesota, 84%).
- Across the U.S., 56.1% of first-time, full-time bachelor's degree-seeking students earn their degrees within six years; 4 of 12 MHEC states exceed this figure, led by lowa at 63.1%.



Benefits

- States benefit from an educated citizenry through increases in labor force participation, personal income, civic involvement, tax revenues, and charitable giving, as well as in other areas.
- Nationally, the median income of citizens with a high school credential is \$26,140, while the median income of citizens with a bachelor's degree is \$47,510, a premium of 81.8%.
- Among MHEC states, the difference in income by education level (bachelor's degree vs. high school credential) is most pronounced in Michigan (94.3%) and least pronounced in North Dakota (50.9%).
- Nationally, citizens with a high school diploma are 3 times more likely to be in poverty, and citizens without a high school diploma are 6.5 times more likely to be in poverty, than are citizens with a bachelor's degree.
- Among MHEC states, median state income tax revenues generated from citizens with bachelor's degrees are nearly double the median generated from citizens with only a high school credential; the differences range from 62.5% in Indiana to 182% in North Dakota.



Affordability


- The proportion of higher education costs borne by students and families has steadily increased over the past 20 years.
- Nationally, inflation adjusted net tuition (sticker price minus grants and scholarships) at all institutions increased 16.6% between 2004 and 2009; MHEC states ranged from a negligible increase in South Dakota to a 36.5% increase in North Dakota.

Student Borrowing

- The average total student loan indebtedness of 2009 bachelor's degree recipients at public and private not-for-profit institutions nationwide is estimated to have been \$24,000; the estimate for graduates in MHEC states ranged from \$20,454 in Kansas to \$28,883 in Iowa.
- Among MHEC states, the proportion of 2009 bachelor's degree recipients with education debt ranged from 58% in Kansas to 78% in South Dakota; nationwide, approximately 67% of graduates had some student loan debt.





Obstacles to Participation

 In a study conducted for the Institute for Higher Education Policy, college qualified students who did not enroll in a four-year institution overwhelmingly identified financial variables as

the primary reason for their decision; "not enough financial aid" and "tuition too high" were cited three times as often as the closest non-financial variable in the study.

Kansas Policy Facts

- By 2018, 66% of all jobs in KS will require some form of postsecondary education; 52% of all jobs will require at least an associate's degree.
- Presently, 66% of all Kansans ages 25-64 have some postsecondary education, but only 41% of Kansans in this age group have at least an associate's degree.
- In KS, the poverty rate among bachelor's degree holders is 3.5%, compared to 11.3% for individuals with a high school diploma; bachelor's degree workers also generate 72% more state income tax revenue on average than workers with a high school diploma.
- KS ranks near the middle of MHEC states in the percentage of citizens ages 25-64 who have earned a high school credential (91%) and 3rd regionally in the percentage of citizens ages 25-64 who have earned a bachelor's degree (32%).
- 25% of KS citizens ages 25-64 have some college credits but no college degree.
- KS ranks 4th regionally in National Assessment of Educational Progress (NAEP) scores in 8th grade mathematics, with 39% of test takers scoring at the proficient or advanced levels (compared to the national average of 34%); KS has the smallest achievement gap of any MHEC state between all test takers and test takers from low-income families (15 points).
- KS ranks in the middle third regionally in National Assessment of Educational Progress (NAEP) scores in 8th grade reading, with 33% of all test takers scoring at the proficient or advanced levels (compared to the national average of 32%); KS has the third smallest achievement gap between all test takers and test takers from low-income families (14 points).
- 44.5% of KS citizens ages 18-24 are enrolled in some form of postsecondary education, which ranks 4th highest among MHEC states and is nearly three points above the national figure of 41.7%.
- 14% of KS undergraduates are enrolled in private institutions, which along with ND is the lowest proportion among MHEC states.
- Among students enrolled in KS public institutions, 43% are in community colleges, 17% are in master's level institutions, and 38% are in research universities.

- Student retention from the first to second year at KS public two-year colleges (56%) ranks in the bottom third of MHEC states but is only three points off the national average of 59%.
- Similarly, retention rate at KS public four-year institutions (75%) ranks in the bottom third of MHEC states but is only three points off the national average of 78%.
- The retention rate at KS four-year private colleges (66%) ranks second lowest among MHEC states and is 14 points lower than the national average of 80%.
- The six-year bachelor's degree completion rate for KS, which includes both public and private institutions, ranks 3rd lowest among MHEC states at 52.6%; lowa leads the region on this measure at 63.1%.
- The share of public higher education operating revenues borne by KS families increased from 30.2% in 1999 to 42.2% in 2009.
- KS ranks 2rd lowest regionally in the student share of expenditures at public master's institutions, and 5th lowest regionally in the student share of expenditures at public research universities.
- KS ranks 3rd highest regionally in total fiscal support for higher education per capita, and near the middle of MHEC states in state and local support for public higher education operating expenses per FTE; the KS figure of \$5,591 on the latter measure is 19% below the national average of \$6,928.
- Between 1994 and 2009, KS experienced an 8% drop in inflation-adjusted appropriations for higher education and a 61% increase in net tuition per FTE at public institutions.
- KS awarded \$19M in student grant aid in 2008-09, nearly all of which was awarded on the sole basis of need.
