MINUTES OF THE ETHICS AND ELECTIONS COMMITTEE

The meeting was called to order by Chairman Terrie Huntington at 9:34 a.m. on January 27, 2011, in Room 159-S of the Capitol.

The Chairman called the meeting to order and asked for bill introductions. The Chairman recognized Sherrie L. Riebel, Election Legislation Committee Chairman, Kansas County Clerk's and Election Officials, who requested two bills. The first would establish the number of candidates that would continue on to the General Election if a primary were to be held. The second bill request was to change the candidate-filing deadline from June 10 to June 1. (Attachment 1)

Motion moved by Senator Schmidt, seconded by Senator Kelsey. Motion carried.

The Chairman introduced and welcomed Kris Kobach, Kansas Secretary of State. He made introductory remarks and introduced his staff members who were present, Brad Bryant, Ryan Kriegshauser and Eric Rucker. Secretary Kobach indicated the willingness of his department to work closely with the Ethics and Elections Committee. Secretary Kobach summarized what has happened in voting in Kansas over the last two decades, so that the Committee will better understand the trends that have been reported by his agency. Secretary Kobach presented a request for the introduction of four bills: the first would allow overseas voters to vote a full ballot at all elections; apply for, receive and return their ballots by electronic means; and vote a write-in ballot, if needed. (Attachment 3)

Senator Schmidt moved, seconded by Senator Petersen.

The second bill would cancel the Presidential preference primary election in 2012; maintain the law to have the primary in 2016 and beyond.

Senator Schmidt moved, seconded by Senator Brungardt.

The third bill would remedy a confusing situation that arose with the resignation of a state senator and the need for an expedited election.

Senator Brungardt, seconded by Senator Schmidt.

The fourth bill would change candidate filing deadlines in redistricting years.

Senator Schmidt moved, seconded by Senator Petersen. All motions carried.

Secretary Kobach spoke about the Secure And Fair Elections (SAFE) Act that is in the House Omnibus Bill and that he anticipated that the Committee will hear this act.

The Chairman thanked Secretary Kobach for appearing.

The Chairman reminded the Committee that January 31 is the last day to request individual bill drafts.

Request for Bill Introduction Secretary of State Kris W. Kobach

January 27, 2011

Madam Chair and Members of the Committee:

I request introduction of four committee bills.

1. Military & overseas voter bill

I am proposing a bill identical to Senate Bill 426 in 2010. This bill would accomplish the following:

- Comply with the federal MOVE Act
- Allow military & overseas voters to cast ballots by email or other electronic means
- Allow a full ballot for military & overseas voters

 (Currently their ballots do not include ballot questions in local jurisdictions or political party precinct committee positions in the August primary)
- 2. Presidential Preference Primary cancellation bill

Recognizing that today's state budget climate might make it difficult to obtain the \$1.5 million to \$2 million needed to pay for a statewide PPP, I wish to raise the issue with the Legislature by proposing a bill to cancel the 2012 PPP but maintain the laws on the books to have the primary in 2016 and beyond.

3. Kansas Senate vacancy bill

A confusing situation arose last year with the resignation of Sen. Jim Barnett in early October, requiring an expedited election. The compressed schedule prescribed in K.S.A. 25-321 does not allow for a candidate filing period or a primary election. I have drafted legislation to raise the issue and give the Legislature an opportunity to remedy the situation.

4. Candidate filing deadline in redistricting years

The Legislature will redraw its district lines in 2012. There are special filing deadlines in current law for candidates who file for federal or state offices in redistricting years. I propose legislation to alter these special deadlines to make them fit better in the overall election process.

I have drafted proposed language for these bills, and I offer the assistance of my office as necessary. Thank you for your consideration.
