Approval of Senate Transportation Committee minutes as written for March, 8, 9 and 10, 2011 were made with a motion by Senator Reitz. Seconded by Senator Marshall. Motion passed.

HB 2172 - Registration of vehicles; renewal; certification of financial security

Chairman opened the hearing on **HB2172**.

Daniel Yoza, Revisor, presented the ballooned amendment to the committee members that is inclusive of **SB218** to be inserted into **HB2172** in addition to the small fee requested by Kansas Automobile Dealers Association in recovery of their expenses.

Chairman closed the hearing on HB2172.

Senator Reitz made a motion to amend **HB2172** per the ballooned amendment. Seconded by Senator Kultala. Motion carried.

Senator Schmidt motioned to pass the bill favorably as amended. Seconded by Reitz. Motion carried.

HB 2132 - Issuance of gold star family license plates

Chairman stated there would be no action on the bill today due to the absence of Lt. Col. Meier. The bill will be resumed Wednesday, March 16, at Transportation Committee meeting when she is available.

HB2192 - Making seat belt regulations part of uniform act regulating traffic on highways

Chairman opened the hearing on **HB2192**.

Daniel Yoza presented the ballooned amendment for the bill stating the seat belt inclusion has been omitted, and "Dead Red" traffic signals with a three feet rule regarding cyclists has been included. Senator Huntington expressed her concerns regarding traffic safety for cycles turning left on a red light. Jill Shelley commented legal right of way would apply in the event of a wreck. Left turns on red would apply to bicycles and motorcycles only.

Chairman closed the hearing on HB2192.

Senator Schmidt made a motion to adopt the ballooned amendment and pass amended **HB2192** favorably out of committee. Seconded by Senator Hensley. Motion carried.

The next meeting is scheduled for March 16, 2011.
