SESSION OF 2002

CONFERENCE COMMITTEE REPORT HOUSE SUBSTITUTE FOR SENATE BILL NO. 9

As Agreed to May 15, 2002

Brief *

The Conference Committee agreed to delete the contents of House Sub. for SB 9 dealing with the membership of the Joint Committee on Corrections and Juvenile Justice Oversight and insert provisions of SB 648 requiring a day reporting center to be established in Wyandotte County, the contents of HB 3010 which establishes a pilot program in Johnson County for adult offenders sentenced to community supervision, and the contents of HB 3041 creating the Kansas Council for Interstate Adult Offender Supervision.

The bill requires the Kansas Department of Corrections to establish a day reporting center in Wyandotte County with a capacity not to exceed 60 placements. If the Secretary of Corrections picks a site that does not meet local zoning requirements, the Unified Government of Wyandotte County/Kansas City, Kansas, has 45 days to pick an alternative site. If the alternative site meets the requirements of the Secretary of Corrections and the budget for the site, the alternate site must be used.

The bill provides that adult offenders sentenced to community supervision in Johnson County for felony crimes that occur between July 1, 2002 and July 1, 2004, shall be placed under court services or community corrections supervision, subject to available funding. Court rules issued by the 10th Judicial District Chief Judge will govern these situations. These provisions are subject to available funding and will sunset on July 1, 2004.

The bill would create the Kansas Council for Interstate Adult Offender Supervision which would have the responsibility to oversee and administer the state's participation in the interstate compact for adult offenders supervision enacted by 2002 SB 95, and shall develop

policies concerning the operations and procedures of the compact within the state.

The Kansas council for interstate adult offender supervision shall consist of the following members:

- 1. The governor or governor's designee;
- 2. The chief justice of the supreme court or the chief justice's designee;
- 3. The attorney general or the attorney general's designee;
- A person representing crime victims groups appointed by the attorney general;
- One county attorney or district attorney appointed by the governor:
- 6. One private defense counsel appointed by the governor;
- The chairperson of the Kansas parole board or such chairperson's designee;
- 8. The secretary of corrections of the secretary's designee;
- Two senators, one shall be appointed by the president of the senate and one shall be appointed by the minority leader of the senate; and
- Two representatives, one shall be appointed by the speaker of the house of representatives and one shall be appointed by the minority leader of the house of representatives.

The Secretary of Corrections advised that the bill was necessary to implement provisions of the interstate compact for adult offender supervision.
