## **Adolescent Brain Development**

The adolescent brain undergoes significant changes that influence how they experience the world. Research has shown that the prefrontal cortex, the area of the brain responsible for executive functions such as impulse control, emotional regulation, introspection, planning, attention, and critical thinking, develops into our mid-20s.

During adolescence, the brain is highly malleable, which means that experiences and interventions can have profound effects on development. Positive experiences, such as supportive environments, strong relationships, and achievement, enhance cognitive and emotional functioning while negative experiences can hinder them.

Additionally, it is important to understand the adolescent's need for effective regulation, positive peer relationships, and reward-based learning throughout this period of brain development.

## **Benefits of ABD and Coaching**

- Applicable to all permanency plans
- Focused on older youth, including authentic partnerships with young people.
- Centers cultural connections, values, and young people thriving in their communities.
- Locally sustainable thanks to their train-the-trainer model.
- Can be provided in-person, virtually, or hybrid.
- Coaching is available to assist participants in how they utilize brain science in their relationships with the young people they serve.
- Adolescent Brain Development and coaching has demonstrated a positive track record in other child welfare jurisdictions.

Adolescence is a critical period for brain development, offering a unique opportunity for child welfare professionals to support growth and healing via authentic engagement.

It has been an honor to be a small part of Kansas' historical passage of HOUSE BILL 2536 and a privilege to serve our amazing Lived Experts. I am excited to support the successful and sustainable implementation of the SOUL Family Legal Permanency Option statewide.
