The Senate was called to order pro forma by Senator Larry Alley.

REFERENCE OF BILLS AND CONCURRENT RESOLUTIONS

The following bills were referred to Committees as indicated:

CHANGE OF REFERENCE

Under the authority of the President, Senator Alley withdrew **SB 177** from the Committee on **Local Government, Transparency and Ethics**, and referred the bill to the Committee on **Federal and State Affairs**.

Under the authority of the President, Senator Alley withdrew **SB 229** from the Committee on **Commerce**, and referred the bill to the Committee on **Ways and Means**.

Under the authority of the President, Senator Alley withdrew **SB 119** from the Committee on **Transportation**, and referred the bill to the Committee on **Ways and Means**.

REPORTS OF STANDING COMMITTEES

Committee on **Commerce** recommends **SB 117** be passed.

Also, **SB 52** be amended on page 13, in line 37, by striking "\$10,000,000" and inserting "\$5,000,000";

On page 57, in line 17, after the period by inserting "The aggregate total amount of sales exempt from tax pursuant to this subsection shall not exceed \$1,000,000 per year per production company including any contractors of the production company pursuant to paragraph (2)."; and the bill be passed as amended.

SB 199 be amended on page 5, in line 33, by striking all after "(j)"; in line 34, by striking all before "All"; also in line 34, after "sales" by inserting "or transfers"; in line 35, by striking "seasonal or"; also in line 35, after "retailer" by inserting "or a seasonal retailer"; in line 36, by striking all before the period; in line 38, by striking all before "permanent"; in line 39, by striking all before "permanent"; in line 42, by striking all after "a"; in line 43, by striking "respectively,";

On page 6, in line 2, by striking all before "permanent"; also in line 2, by striking ", as applicable";

On page 1, in the title, in line 4, by striking "such seasonal and"; in line 5, by striking "prohibiting internet sales of consumer fireworks;"; and the bill be passed as amended.

The Committee on **Judiciary** recommends **SB 70** be amended on page 2, in line 24, after "per" by inserting "printed"; also in line 24, by striking "A" and inserting "No per page or copy"; also in line 24, after "fee" by inserting "shall be charged"; in line 25, by striking all after "records"; in line 26, by striking all before the period; also in line 26, after the period by inserting "If a fee is charged for the cost of staff time required to make information available, no fee for printed copies of public records shall be charged pursuant to this paragraph.";

On page 12, in line 20, by striking "December" and inserting "October";

On page 14, in line 2, by striking all after "a"; by striking all in lines 3 and 4; in line 5, by striking "meeting" and inserting "subcommittee or other subordinate group is created by a public body or agency, whenever a majority of such subcommittee or other subordinate group meets, such subcommittee or other subordinate group shall be subject to the requirements of this act";

On page 1, in the title, in line 2, by striking "providing for reasonable" and inserting "prohibiting"; in line 5, by striking "December" and inserting "October"; and the bill be passed as amended.
