Bill Title: Authorizing National Criminal History Background Checks for Final Applicants for

Certain Sensitive Positions with the Kansas Department of Commerce

Brief Summary - What problem(s) is the bill intended to solve, and how does it do that?

HB 2342 addresses the issue of ensuring that employees in sensitive positions with the Kansas Department of Commerce meet minimum standards of integrity and security. The bill allows the Secretary of Commerce to request state and national criminal history background checks on final applicants and employees for specific sensitive positions. These checks will be conducted by the Kansas Bureau of Investigation (KBI), ensuring that individuals with histories of theft, fraud, forgery, or other financial crimes are not employed in positions with significant financial or data access responsibilities. This enhances the integrity and security of financial management, confidential information, and overall department operations.

## Minimum Standards and Scope:

- 1. **Criminal Background Checks:** Final applicants and employees in sensitive positions must undergo state and national criminal history record checks.
- 2. **Exclusions for Employment:** Applicants or employees with misdemeanor convictions involving theft, fraud, forgery, or other financial crimes, or any felony convictions, are prohibited from being employed or continuing employment in sensitive positions.
- 3. **Definition of Sensitive Positions:** Includes division director, assistant secretary, deputy secretary, IT manager, chief counsel, grant or loan program managers, and other positions with significant financial or confidential data responsibilities.

## **Oversight and Confidentiality Provisions:**

 Criminal history information is confidential and exempt from the Kansas Open Records Act.

- Unauthorized disclosure or misuse of information will be punishable as a class A
  misdemeanor and could result in removal from office.
- Fees may be charged by the Kansas Bureau of Investigation for conducting criminal history checks.

## Repealed and Amended Provisions:

The bill amends K.S.A. 2024 Supp. 22-4714 to reflect the addition of the Department of Commerce as an agency authorized to request criminal history checks. It repeals the existing K.S.A. 2024 Supp. 22-4714 to incorporate the changes.
