The current system for appointing Supreme Court Justices in Kansas keeps partisan politics out of the court, and it should stay that way.

This proposed amendment will replace merit-based experts with extreme politicians and special interest groups. We should keep the courts non-partisan and ensure experts, not politicians, make these calls.

Switching to partisan elections for state Supreme Court justices will not actually give power to the people; it will give power to those with the most money. One need only to look to the state of Ohio which switched to partisan Supreme Court elections in 2022, and hundreds of thousands of dollars from out-of-state special interest groups poured into Ohio to buy their preferred candidate's success. This is also playing out in Wisconsin as I write this letter. We should keep special interest and dark money groups out of our judicial system.

Let us be clear, the extremists backing this amendment are only trying to remake the court so they can ban abortion without exceptions in Kansas. Attorney General Kobach gave an entire speech arguing that the court's decision to uphold abortion protections proves a change in the system is needed, making the intentions behind this amendment crystal clear. We must protect the right of all Kansans to make personal decisions without government getting involved. Attorney General Kobach is only trying to overhaul the court because he does not like that they

don't bend to his will. Kobach has openly stated that the makeup of the court makes it "very difficult" for him to win cases and advance his preferred policies.

One of the proudest votes I have ever cast was to vote "no" on the proposed amendment and keep abortion safe and legal in the State of Kansas. I was overjoyed that evening with the news the amendment was soundly rejected.

The people of Kansas have already made their voices loud and clear in August 2022, where voters overwhelmingly rejected efforts to strip away reproductive rights in Kansas. Despite this decisive outcome, these current efforts to politicize the court seek to undermine the will of the people, with one singular goal in mind.

That August 2022 vote made clear Kansans do not want politicians interfering with their personal healthcare decisions, and they have explicitly said so at the ballot box. I urge you to respect the mandate given by the people. Continuing this relentless pursuit of abortion restrictions will not only erode public trust in the legislature but also further divide our communities.

If the justice system is able to be bought, we will no longer have reason to trust their rulings or their legitimacy, and Kansans will be harmed in the long run. We know that there are groups that would like to remove civil rights from immigrants, harm women with unsafe and non-scientific abortion bans, and remove funding from education that benefits the vast majority of kids in our state. Passing these changes would amount to handing the reins of our justice system over to whomever has the most cash to spend. It subverts the very purpose of the courts and of our Constitutional protections, and must be opposed.


Thank you for reviewing my opposition testimony on SCR 1611. My name is Pat Gouger and I'm a 30+ year resident and voter in Johnson County.


Thank you for reviewing my opposition testimony on SCR 1611. My name is Pat Gouger and I'm a 30+ year resident and voter in Johnson County.

Chair Humphries and members of the committee,

I am writing to voice my opposition to SCR 1611.

Our current system of selecting supreme court judges in our state is merit based – making use of a nominating commission composed of a) lawyers selected from across the state (and therefore providing the needed legal expertise and experience for such a task) and b) non-lawyers selected by the governor (providing input from Kansas citizens through their election of the Governor).

Additional input is provided from Kansas citizens through a) their election of the Governor who then makes the final choice from the three recommendations provided by the nominating commission and b) the opportunity to vote to retain or remove a judge after their first year and again every 6 years. In addition, there is an existing mandatory retirement age of 75.

No system is perfect, but this system that combines input from a) knowledgeable, experienced legal experts b) voters through the governor's selections and directly via a retention vote is a far cry better than politicizing our state's supreme court by having judges elected via partisan elections. We don't want a Supreme Court that sets our state's constitution and legal precedent aside to make unfair decisions based on partisan leanings. Justices have a constitutional obligation to consider cases in the interest of all Kansans who appear before them. They must have greater protections from improper influence than any other constitutional officers, and partisan elections will undermine that.

The Brennan Center for Justice, after conducting a three-year project taking a look at judicial selections for state supreme courts, concluded that states should do away with state supreme court elections completely. It concluded that the system Kansas currently uses — one where justices are appointed through a publicly accountable process conducted by an independent nominating commission — is what all states should be using.

And as Kansans for Fair Courts has stated: ... the merit system is an effective and time-tested process that has helped insulate judicial selection in the state from financial and political pressures that endanger fair and impartial courts.

In closing, I again reiterate my ask that you vote no on SCR 1611. Kansans deserve to have fair and impartial courts that operate independently from partisan leanings and the undue influence of political parties.


