



Community Foundations across Kansas provide key services to charitably minded donors and our hard-working charities, with the ultimate benefit of improving the lives of the citizens of our great State. Our mission "Building Stronger Communities Through Charitable Giving" is not always an easy task to achieve. Our grants to causes that matter rely on the generosity of donations we receive.
