
Who We Are

Cornerstones of Care is a behavioral health organization with a 155-year history of providing prevention, treatment, education, and support services to children and their families. The children that we serve have all experienced trauma. Trauma resulting from events, such as abuse or neglect, separation from/loss of a loved one, and witnessing or experiencing violence in their community, as well as trauma stemming from ongoing, cumulative experiences like poverty, addiction, and mental illness.


Cornerstones of Care is a certified trauma-informed organization by The Sanctuary Institute. This model recognizes trauma can be pervasive to the human experience. It acknowledges the vulnerability of clients, organizations, and systems to the adverse effects of trauma and guides the approach that our almost 715 team members across our organization take to recognize, understand and respond to trauma in a manner that mitigates its' negative effects. This model also fosters a restorative organizational culture and framework for creating trauma informed communities, and promotes healthy team member engagement, safety, self-awareness, and self-care.

Cornerstones of Care has been providing services to the children and families of Kansas since 1999. Today, we have more than 250 team members in Kansas within seven offices, supporting citizens in 49 counties.















The map depicts, with overlap:

- Family Preservation for families in twenty-five (25) counties
- Foster Care Case Management for children and families in three (3) counties
- Therapy Services for children, families, and adults in forty-eight (48) counties
- Behavior Intervention Support for schools in seven (7) counties
- Transitional Living for teens from around the state in one (1) county
- Therapeutic Foster Family Home support for families in eleven (11) counties



Prevention and Protective Services: Family Preservation

Cornerstones of Care is the Family Preservation provider in the Northeast and Southeast Regions for the Department for Children and Families (DCF). Our Family Preservation programs have offices in Brown County, Crawford County, Montgomery County, and Shawnee County.

Foster Care/Adoption Case Management

Cornerstones of Care is the Foster Care provider in Area 5. Our geographic area covers three counties in Kansas: Atchison, Leavenworth, and Wyandotte. Our program has offices in Leavenworth County and Wyandotte County.



Area 5 Client Population

As of March 18, 2025, Cornerstones of Care is providing services to 443 foster care clients, which is down from 842 or 47% from our initial grant inception (October 1, 2019). The new foster care contract started on July 1, 2024, with 506 foster care clients, so the population is down 12%, since then. We are thankful to the teams, agencies, and people that have helped to make this happen. We realize it is because of the work of many different entities.

Caseload Carrying Staffing Vacancies and Caseload Sizes

As of March 24, 2025, Cornerstones of Care has four vacancies or a 91% occupancy rate. The average current caseload size for our Foster Care Case Management team is 10.05 youth per case carrying team member.

AWOL/Missing Youth Information

As of March 24, 2025, Cornerstones of Care has two of 443 youth or 0.004% AWOL/Missing from care.

One Night Placements

In 2025, Cornerstones of Care has had three instances of a one-night placement with three unique clients.

- 1. A youth was discharged from a PRTF on 1/20/25 and she was going to fly to Pennsylvania to be placed with a relative via Interstate Compact for Placement of Children (ICPC) on 1/21/25 and she needed a place to stay for one night.
- 2. An ICPC disruption occurred in Florida and the youth flew back to Kansas City on 1/1/25. The case team wanted to give him a day to process the situation to help prevent a disruption before going to a Pre Placement Visit, which then occurred and led to a stable placement.
- 3. A youth got into an argument with their placement provider and refused to go back to the home. While our Placement Finding team looked to locate a long-term placement, she spent one night in a foster home.

SOUL Family Permanency Option

Cornerstones of Care achieved its first SOUL Family Permanency on March 6, 2025!

The youth entered foster care on 5/20/20. Due to various circumstances during the case, placement with family was not an option. While in care, she had over 50 placements. She was placed in a long-term stable foster home and was intending to remain in that home until she aged out of care on her 18th birthday in October 2026. However, after learning she was pregnant in October 2024, the foster home was unable to maintain as her placement. At that point in time, she was able to reconnect with her uncle and her older sister who were residing six hours away in Missouri.

Background checks were completed, and the youth began visiting and rebuilding her relationship with them. Cornerstones of Care informed the youth and her family about the SOUL Permanency option in December 2024, and they were all immediately on board. The youth's case team sought to obtain permanency prior to her due date in April 2025 to prevent any complications with travel as well as to give her and her baby the best possible start. Our team was able to complete all SOUL paperwork by the end of February 2025. Simultaneous to all of this, Cornerstones of Care kept regular contact with the court and was able to schedule a hearing for March 6, 2025, where she reached permanency through SOUL after 1,751 days in foster care.

The youth and her family celebrated at our Leavenworth office with food and a gift basket with baby gifts.









Therapeutic Family Foster Home Capacity Building Grant March 1, 2024 – June 30, 2025

Specific to Therapeutic Family Foster Home (TFFH) Capacity Building, Cornerstones of Care was awarded \$689,889 to apply a therapeutic foster care model as a prevention tool in 11 counties in Northeast Kansas. The counties are Brown, Doniphan, Jackson, Jefferson, Marshall, Nemaha, Pottawatomie, Shawnee, and Wabaunsee.

If our model is effective, the work would: 1) reduce the number of children entering foster care, 2) reduce the number of children entering foster care due to reasons not related to abuse or neglect otherwise known as Family In Need of Assessment, 3) increase the capacity of TFFH for youth in foster care as beds are not being occupied by children we have prevented coming into care.

Our model focuses on supports to open Family Preservation cases. When a Family Preservation case is opened, our team works with the family to identify two to three respite/safety plan families. These are safe families, usually relatives or family friends, where children can go stay. The stays are usually short term but are helpful in allowing the biological parents to address what they need to all while knowing their children are in a safe place.

Typically, respite families opening their home to Family Preservation case children would receive no financial support. In an effort to further prevent the need for a child to enter foster care, Cornerstones of Care provides the following additional supports to these respite families identified as part of the TFFH work, in addition to the already assigned Case Manager:

- Access to training in a virtual resource library focused on successful behavioral intervention.
- A one-time \$100 incentive payment, per youth, for taking child(ren) into their home
- A \$50 daily reimbursement rate, per youth, to offset the cost of caring for child(ren) for things like food, gas, additional utility usage, etc.
- A \$200 incentive payment, per youth, for the children safely returning to their biological home and a successful case closure



- Functional Family Therapist Provider Support
 - Cornerstones of Care will provide therapeutic support to the respite home for any clinical support needs that arise.
- An In-Home Support Specialist
 - o Sometimes families just need practical day-to-day support. Therefore, aside from training, financial reimbursement, and therapeutic intervention, families get help with day-to-day activities and an extra set of eyes and ears between after school and bedtime hours. With these TFFH funds, Cornerstones of Care stood up two In Home Support Specialist positions. The Specialists are working with Family Preservation team members, but alongside the respite caregivers to help navigate the challenges of caring for youth who are a bonus to their home. Supports can be in the home with household support, babysitting, acting as another safe adult in the home, homework assistance, etc. Also, supports can be in the community via daily routine assistance like helping with transportation, helping with shopping, errands, etc. Each family's needs will be uniquely assessed and supported, and the In-Home Specialist Support work could look different from home to home.
