I am writing to voice my opposition to bill number SB 87.

Public funds should not be used for parochial or private schools. This violates separation of church and state which is guaranteed in the First Amendment to the Constitution (Freedom of Religion and Freedom from religion.) Bills keep coming up in the legislature trying to take funds from the public schools, and there isn't even accountability for those private schools. Our focus should be on fully funding public schools INCLUDING Special Education. Do not vote for any kind of voucher program no matter what language is used. Your focus should be providing full funding for Special Education, not taking funds away, and not redirecting funds to private and parochial schools.

I am a retired public school teacher (SMSD) and firm believer in public education which takes in ALL students (private schools don't) and is essential to democracy and an educated citizenry. Johnson County, where I live, seems to have the most private school alternatives, but still should not use public funds for private education. Our excellent public school districts, including Shawnee Mission (where my children attended, K-12) and other districts across the state should not lose important funding. I saw the problems we had with the Brownback tax cuts before things turned around. There were larger class sizes, not enough school counselors and buildings with curtailed cleaning! Don't go backwards!

One of the main reasons I chose to stay and work as a teacher in Kansas were the excellent public schools. Before choosing to move for a job in Kansas, many people will check that their children will get a good public education here. Don't you want to encourage new potential residents by showing that we value public education for all children?

In addition, the current tax credit of 75% already provides a huge benefit to those choosing to funnel their tax dollars to private schools. I am writing to voice my opposition to bill number SB 87.

Thank you in advance for reading my testimony. I am a parent of a child with an IEP enrolled in the Shawnee Mission School District. This bill would divert tax money to private schools that have no requirement to serve students with disabilities. In fact, the vast majority of private schools are not at all equipped to serve students with significant support needs, and they will refuse admission to those students. I am a parent of a student with significant support needs. Even if I wanted to take advantage of this program, I would NOT be able to, because there is no school in the state of Kansas that would accept my child. How do I know this? I know this because I am a former private school teacher, and I witnessed how heartbreaking it was to see families have one child accepted to the school, and the other sibling rejected on the basis of disability.

Even if she were allowed, most of those schools are religious schools, specifically Catholic, and I would be a fool to enroll my child, who is already extremely vulnerable to sexual abuse, in any institution that is frankly dangerous for children. A 2023 report released by the Kansas Bureau of Investigation identified 188 clergy in the state "suspected of committing various criminal acts," including aggravated criminal sodomy, rape, aggravated indecent liberties with a child and aggravated sexual battery. This is during a period going all the way up to 2022. These were crimes that were covered up by the dioceses – a pattern we have seen all over the United states. My child cannot reliably report sexual abuse. I would never, ever put her in this situation.

Our tax dollars should absolutely not be funneled into any religious institution, but especially those that have been proven to be criminally negligent in the protection of children.

We should not be reducing state revenues by providing tax credits that funnel money to private schools that can pick and choose which children they want to serve.

Senate Education Committee February 6, 2025 Attachment 61 Private schools can choose to admit only the best and brightest students, leaving other children behind.

Our tax dollars should not go to private schools that lack oversight, leaving the public uninformed as to whether or not our tax dollars are really being spent to improve the lives of children.

There are no controls in place to ensure eligible at-risk students who apply for a scholarship are granted one, as private schools are allowed to set their own admission standards. And there are no controls in place to ensure those who do receive scholarships receive a quality education. Kansans expect accountability for our tax dollars.

All of our students receive free breakfasts and free lunches. 93% of our student body is from a "minority background". The tax credit scholarship provides families the choice to send their students to a small and safe school.

Our Lady of Unity has a student body of 189 students in grades K-8. We pride ourselves on creating an environment where every student matters and every moment counts. Our faculty and staff strive to provide the best learning experience for all of our students. Our small environment allows us to differentiate and provide individualized learning opportunities for all of our students. We have seen students make significant gains in our building in both reading and math through our data driven resource programs. In addition to meeting the academic needs of our students we focus on providing our students with the tools to be excellent citizens of the world. Students participate in service projects, participate in buddy programs, and learn about virtues.

Recently, one of our tax credit scholarship graduates returned to visit our building. I asked him how Our Lady of Unity prepared him for high school and beyond. "John" (not his real name) told me he felt that he was more prepared than many people in his math class. He also told me he was looking forward to mentoring a student from Our Lady of Unity who is about to graduate. "John" knows that without some of the one-on-one support he received from Our Lady of Unity he wouldn't be ready to enter his welding program to prepare for a future career. It is very important that we continue to provide opportunities for scholarships to students like "John". I am writing to voice my opposition to bill number SB 87.

Public tax dollars belong to public schools that accept and educate ALL children. If parents choose to send their children to private schools or home school or co-op schooling, that's great-that decision is theirs to make, and thus should be on their own dime entirely or by fundraising through that specific system or congregation. Public schools serve the entire community. There is no denial of service. In a single classroom could be a neurodivergent student, a wealthy student, students on free and reduced lunch programs, a middle of the road student, a high achieving or accelerated student, a student on a behaviour plan, a student who needs extra services and ALL of these students are serviced by public school. There is no picking and choosing the best. Everyone gets to come to the table. MOST of those students would not be accepted into a private school, or parochial school not only because of cost, but because most religious institutions and private schools do not have the resources needed to acceptably educate all students. If the student fails- at academics, at "behaviour", and anything deemed inexcusable, they kick them out. Not to mention the severe lack of oversight of the distribution of funds.

This bill drains funds from Kansas public school systems, schools which are already experiencing strained budgets as a result of unfunded special education programs.

Special education, which is only provided in limited form in Kansas private schools, is now mandated by Federal statute and will be for the foreseeable future. These programs require careful management of tax funds and strict budgeting in order to ensure these students receive appropriate education and training in order to become contributing members of society.

Madam Chair, Members of the Committee;

I am a Kansas resident and proud parent of three public school graduates. I am writing today because I believe this committee should stay focused on ensuring that Kansas public schools – which must welcome and serve every Kansas child – remain the focus of this committee. I am opposed to this bill and any other that seeks to harm children and financially undermine public schools as this one does.

There Is Harm

Fiscal Harm

There are some who say that because this program doesn't take money *directly* away from the General Fund or because it is money that the state *never received* in the first place it is somehow not taking money away from the state so there is no fiscal harm. This is a particularly cynical and self-serving view which deliberately ignores the fact that tax credits are a significant reduction in a tax bill and therefore a significant reduction in state revenue that would otherwise be received and spent on public education and other services.

Harm to Children

Voucher programs encourage the dismantling of public education by bribing Kansans with tax relief to remove their children from public schools and place them in private schools. Our Kansas public schools are publicly accountable and have layers of oversight to ensure children are safe and that they receive a fact-based, dogma-free, quality education. Private schools in Kansas, on the other hand

- · are not subject to public oversight
- · can have bigoted and discriminatory selection processes
- can teach objectively false information
- · may promote religious dogma
- may be staffed by unqualified persons.

Allowing millions in tax dollars to evaporate by offering tax credits to families for private school choices without any mechanism to ensure the selected private educations meet minimum state standards for curricula, educational progress, and safety is a dereliction of this committee's obligation to protect Kansas children and ensure all Kansas children receive a quality education.

Where Does the Costly Program End?

It strikes me that this year's version of the bill is larger than previous years' both is the credit percentage and the number of children eligible to participate. How big will we let this program get? This year's version increases the cap, increases the tax credit percentage to 100% and includes more categories of applicants. It is clear that growing the program is the plan, not solving a specific education problem. The more kids that qualify, the easier it is to justify raising the cap. While \$20 million may seem an expendable amount today, what is to keep the legislature from raising the cap to \$50 million or \$500 million? What happens when the cost of this second, poorly regulated, education funding mechanism becomes a financial burden to the state? Will you cut the program or will you attack public education costs and strip even more

from our public schools? Why do you want to create two competing education systems that results in both a funding and quality crisis? Arizona is a perfect example of how this will end – ballooning education costs, poorer educational outcomes, angry citizens.

Public schools are one of Kansas' strengths. If this committee sees room for improvement in Kansas public schools, then please work to make those improvements so all Kansas children can benefit and thrive. Do not continue this effort to strip schools of children and resources. Families wanting an educational experience outside the public schools should always have that option to do so. However, I urge you to remember it is not the obligation of the state to fund or financially reward private choices made in lieu of public services and to vote NO on this bill.

Chairperson Erickson, members of the Committee:

Thank you for the opportunity to testify in opposition to SB 87.

Kansas NEA is a member-driven organization that represents all 40,000 educators in the state of Kansas. We have nearly 22,000 members. The positions we advocate for have been proposed, debated, and adopted by several hundred members that were selected by their peers to attend our annual Representative Assembly.

Our members have a strong stance on vouchers that is quite clear. The first part of that resolution reads:

Kansas NEA believes that voucher plans, tuition tax credits, or funding formulas that have the effect of financing private education with public funds, undermine support for public schools. Such programs could lead to racial, economic, and social isolation of students and weaken or destroy the public school system.

The Low-Income Student Scholarship Program is a voucher program that diverts public funds to private schools.

The KNEA resolution on vouchers continues to state:

KNEA acknowledges that it is the right of parents/guardians to choose to send their students to private schools...

... KNEA further believes that any private school or agency that receives public funding through voucher plans, tax credits, or other funding/financial arrangements must be subject to all accountability measures and regulations required of public schools.

SB 87 does not ensure that private schools that receive public funds are held to the same standards as public schools. As a matter of fact, SB 87 doesn't require any language regarding accountability, measurement, licensure, accreditation, assessment, or service requirements. The omission of such language is another reason that KNEA opposes this bill.

In closing, the most painful part for teachers when talking about such bills is the rhetoric seems to follow them. These proposals always appear to be predicated upon the assumption that public schools and, in turn, public school teachers are not thriving to meet the needs of Kansas children. This is not the case.

We ask the committee to oppose SB 87.
