Chair Erickson and Members of the Committee, thank you for the opportunity to provide opponent testimony for Senate Bill 275 on behalf of Mainstream Coalition.

Mainstream was founded over 30 years ago by faith leaders who warned about the intrusion of narrow, extremist religious views into our government and public institutions. In the following decades, Mainstream members have fought to protect our religious freedoms and maintain strong church-state separation because Kansans value their freedom to live as they see fit without the overreach of government or religion into their personal lives.

**Mainstream OPPOSES SB 275**. This bill is anti-abortion propaganda imposed upon our schools by religious extremists.

First, on the timeline of this hearing. SB 275 is being rushed through the legislative process at the last minute. Despite being introduced on February 18, the committee hearing was announced just yesterday, giving advocates less than 24 hours to prepare and submit their testimony. In our representative democracy, Kansans deserve the opportunity to share their concerns regarding bills that would directly impact their lives. SB 275 would have a significant impact on the way that Kansas youth are being taught about human development and sex education, something that parents and educators should have been given an appropriate amount of time to submit testimony on.

Bills similar in nature to SB 275 have been introduced in 20 state legislatures this session, with many of them including nearly identical language requiring "a presentation of a high-quality, computer-generated animation or high definition ultrasound of at least three minutes in duration that shows the development of the brain, heart and other vital organs in early human fetal development." SB 275 is model legislation being pushed by anti-abortion organizations from outside of Kansas.

Many of these bills, though not all, explicitly name the "Meet Baby Olivia" film. In 2023 and 2024, North Dakota and Tennessee passed bills very similar to SB 275 that do not specify which 3 minute video must be shown. But since this is the primary, if not only, film that meets the very specific requirements listed in SB 275, the final results are the same – schools are being mandated to show the "Baby Olivia" or very similar film.

So who is Olivia? Olivia is a computer generated fetus that is named, gendered, and presented with medically inaccurate human development in an attempt to stigmatize abortions. Throughout the film, timestamps show development that is anywhere from 2-10 weeks earlier than medical experts believe to be accurate, falsely identifying when a fetus has a heartbeat, vocal cords, and survivability outside of the womb. The Baby Olivia timeline is based on the moment of conception, rather than the first day of the last menstrual period, which is standard that medical professionals use. Video using computer generated animation rather than relying exclusively on real ultrasound footage allows for this inaccurate depiction of fetal development that is based in religious, not medically accurate, beliefs regarding conception.

Further, this film has been called out by the American College of Obstetricians and Gynecologists (ACOG) as anti-abortion misinformation.<sup>2</sup> Instead, it was created by Live Action, an extremist organization of anti-abortion advocates and doctors affiliated with the Charlotte Lozier Institute, whose research has been discredited and retracted from leading research journals. The Baby Olivia video, and others that use computer animation to fictionalize the human development process, are anti-abortion propaganda.

SB 275 prioritizes religious beliefs over scientific fact, and exposes children to dangerous misinformation at a critical time when sex education needs to be accurate, reliable, and trusted. SB 275 doesn't specify an age or grade level, nor does it define instruction on "human growth, human development or human sexuality." There is no attempt to identify the appropriate age or maturity level for when a child can be exposed to this propaganda, meaning that any class from K-12 that touches on "human development" could be subject to a "Baby Olivia" style video.

This bill is bad for our students and serves the agenda of those working to impose an extremist religious view onto all Kansans, regardless of their own faith (or non-faith) beliefs regarding conception and abortion.

For these reasons, Mainstream opposes SB 275, and we urge you to vote no.

Chair Erickson and Members of the Committee,

KASB offers this testimony in opposition to SB 275, as it is a substantial overreach into the constitutional responsibilities of the State Board of Education and local boards of education.

KASB's member-adopted permanent policies affirm the authority of local boards of education over curriculum decisions and calls upon the Legislature to reject proposals that mandate or control local curriculum decisions:

#### 2. Curriculum Authority

A district's curriculum should be established by the local board of education, not by state statute. KASB opposes efforts to directly or indirectly limit the board's ability to determine curriculum, library, and other instructional materials.

Setting state standards is squarely within the constitutional authority of the State Board of Education, and choosing instructional materials is squarely within the constitutional authority of local boards of education. In its 2025 Resolution on State Issues, KASB members reaffirmed their steadfast support of State Board and local control of such decisions:

We support general supervision of public schools under the State Board of Education, including setting standards for accreditation, learning standards, graduation, and licensure.

We support management of public schools under locally elected boards of education, including setting curriculum, staffing, financial management and policies, so that such schools can progress and meet State Board standards.

This bill overrules the constitutional authority of both the SBOE and local boards of education with respect to setting learning standards and choosing curricula in this area. It mandates districts to teach about these issues in a particular way. Having the Legislature dictate to local boards of education and the State Board of Education which curriculum a district may choose to meet learning standards is an unnecessary and likely unconstitutional overreach into the decision-making authority of local school boards, as well as the authority of the State Board of Education to adopt learning standards for public schools.

For these reasons, KASB respectfully requests the committee not to reject SB 275.

Chairperson Erickson and Members of the Committee,

Thank you for allowing us to present our opposition to SB 275. Trust Women Foundation is a Kansas-based health care provider dedicated to ensuring access to abortion care and comprehensive reproductive and sexual health services for our communities.

Kansas continues to face serious public health challenges when it comes to teen sexual health. According to the Kansas Department of Health and Environment (KDHE), our state's teen pregnancy rate is 17.2 per 1,000 females aged 15-19¹, and sexually transmitted infections (STIs) are on the rise, with over 13,000 new cases reported in 2022, many among young people². These numbers aren't just statistics, they represent real Kansas youth who need honest, accurate information to make healthy decisions.

Unfortunately, Senate Bill 275 does not address these urgent issues. Instead, it proposes mandating an undefined, unvetted video in public school classrooms—a video we know nothing about. The bill gives us no clear indication who is creating this video, where it's coming from, or whether it is rooted in objective medical fact. Will it be reviewed by medical experts or educators who will be required to teach it in their classrooms? Or is this just a devious attempt to insert politically motivated, anti-abortion propaganda into Kansas classrooms under the label of "education"? Right now, we simply don't know—and if we don't know, our students shouldn't be forced to watch it.

Public school health education should never be a tool for fear-mongering or political messaging. What our students need is comprehensive, evidence-based sexual education that includes age-appropriate lessons about consent, healthy relationships, contraception, and disease prevention—tools that empower them to protect themselves and lower the rates of teen pregnancy and STIs in Kansas. Research consistently shows that comprehensive, evidence-based sexual education leads to lower rates of teen pregnancy and STIs, delayed sexual activity, and higher contraceptive use<sup>3</sup> <sup>4</sup>. By contrast, abstinence-only or ideologically slanted sex education has been found ineffective and even harmful, leaving students without critical health information<sup>5</sup>.



We cannot afford to gamble with the health and education of Kansas youth by turning classrooms into political battlegrounds. If we are serious about reducing unintended pregnancies and STIs and supporting young people, we must reject SB 275 and invest in proven, fact-based sexual education programs that **actually** work.

I urge you to vote NO on SB 275 and instead focus on policies that protect the health, dignity, and futures of Kansas students.
