The agency requests \$1.4 million, all from the Utility Regulatory Fee Fund, and 9.0 FTE positions in FY 2025. The request is \$88,000, or 6.5 percent, above the approved amount. The agency is authorized each year, by language in the appropriations bill, to carry over unspent funds for consultant services to ensure sufficient funds during years with a higher number of rate cases. In FY 2025, the agency is carrying over \$88,000 in unspent consultant service expenditures from FY 2024. The agency's request for 9.0 FTE positions matches the approved number in FY 2025.

Agency

The agency requests \$1.4 million, all from the Utility Regulatory Fee Fund, and 9.0 FTE positions for FY 2026. The request is \$23,943, or 1.8 percent, above the approved amount in FY 2025. The increase is primarily attributable to estimated increases for group health insurance and fees paid to the Office of Information Technology Services for FY 2026. Increases are also attributable to computer hardware and support equipment, as well as estimated increases for KPERS employer contributions for FY 2026. The agency's request for 9.0 FTE positions matches the approved number in FY 2025.
