Agency

The agency requests a revised estimate of \$16.8 million, including \$12.1 million SGF, in expenditures and 140.7 FTE positions in FY 2025. This is an all funds decrease of \$1.1 million or 6.1 percent below the agency's FY 2025 approved amount. This is due to the agency receiving less than anticipated special revenue funds and consequently, the agency reduced their budgeted expenditures. The agency deleted 5.8 unfunded FTE in all other agency-wide adjustments.

Agency

The agency requests \$17.8 million, including \$12.4 million SGF, and 140.6 FTE positions for FY 2026. This is a net increase of \$62,152, or 0.4 percent, above the amount approved for FY 2025. The agency's request includes enhancement requests for capital improvements including **increasing the base amount of their rehab and repair** budget by 5.0 percent (\$55,648 SIBF), adding \$200,000 SIBF to continue the **repairs on the utility service tunnels** beneath a parking lot, adding \$90,000 SIBF to continue **abating hazardous material** found on campus, adding \$70,000 SIBF to install a **new campus gas service line**, and \$350,000 SIBF to replace a **roof on the Taylor Gym.**

Special Committee on Legislative Budget

The **LBC** concurs with the agency's revised estimate for FY 2026, with the following adjustment:

1. Delete \$765,648 SIBF for the five capital improvement enhancements for FY 2026.

House Committee on K-12 Education Budget

The **Budget Committee** concurs with the LBC's recommendation for FY 2026, with the following adjustments:

- 1. Add \$200,000 SIBF to continue the repairs on the utility service tunnels for FY 2026;
- 2. Add \$90,000 SIBF to continue abating hazardous material found on campus for FY 2026;
- 3. Add \$70,000 SIBF to install a new campus gas service line for FY 2026;
- 4. Add \$350,000 SIBF to replace a roof on the Taylor Gym for FY 2026.
