### Kansas Board of Regents-Capital Budget

Section 165 Kansas Campus Restoration Fund – No Limit
 *Provided*, That the state board of regents is hereby authorized to transfer moneys from
 the Kansas campus restoration fund to the deferred maintenance – campus restoration
 act account of any institution under the control and supervision of the state board of
 regents to be expended by the institution for projects approved by the state board of
 regents: *Provided further*, That the state board of regents shall certify to the director of
 accounts and reports each such transfer of moneys from the Kansas campus restoration
 fund: *And provided further*, That the state board of regents shall transmit a copy of each
 such certification to the director of the budget and to the director of legislative research.

## 3. Other requested amendments

### Sec. 99 Fort Hays State University

- Strike FHSU professional workforce development (246-00-1000-0340). \$750,000
  - o The appropriation in 2025 Sub for HB 2007 duplicates the appropriation made in 2024 SB 28.

### Sec. 110 Kansas Board of Regents: 27th Payroll Adjustment

- Strike Subsection (b): "On the effective date of this act, of the \$5,129,252 appropriated for the above agency for the fiscal year ending June 30, 2025, by section 116(a) of chapter 88 of the 2024 Session Laws of Kansas from the state general fund in the operating expenditures (including official hospitality) account (561-00-1000-0103), \$8,223 is hereby lapsed."
  - The \$8,223 has already been transferred from the Board of Regents to the Department of Administration for the 27<sup>th</sup> payroll adjustment as required in 2024 SB 28 55(n).

## Sec. 110 Board of Regents: Strike Current Year Lapses

• Strike subsections (c), (d), (e), (f), (g), (h), which lapse current year State General Fund and Economic Development Initiatives Fund appropriations or reappropriations totaling \$3,983,720. As these monies have either been already spent or will be committed to student scholarships for the Spring 2025 semester, it is requested that the monies not be lapsed on the effective date of the bill.

# Sec. 111 Kansas Board of Regents: 27th Payroll Adjustment

- Add the 27<sup>th</sup> payroll adjustment amount of \$8,223 back to the Operating expenditures account to provide the correct funding amount (561-00-1000-0103) \$5,247,947 \$5,256,170
  - The \$8,223 will be transferred to the Department of Administration during FY 2026 as required in 2025 Sub for HB 2007 Sec. 58(n).

# Sec. 111 Kansas Board of Regents: Strike FY 2026 Financial Aid Lapses

 Strike subsections (g), (h), (i), which all lapse FY 2026 appropriations made by the 2024 Legislature for student financial aid programs.

## Sec. 111 Kansas Board of Regents: Adult Learner Grant

- Finance the Adult Learner Grant Program for FY 2026 with the same transfer language as provided in FY 2024 and FY 2025.
- The funding from this source is already reflected in the agency's budget and awards have been made to students for next year, as of March 3, 2025.
  (\*) On July 1, 2025, or as soon thereafter as moneys are available, the director of accounts and reports shall transfer \$1,000,000 from the state general fund to the Kansas adult

learner grant program fund (561-00-2857-2857) of the state board of regents.
