1 AN ACT concerning drivers' training; relating to ~~motoreyele~~ **driving**  
2 instructors; providing that driving school instructors **and motorcycle**  
3 **instructors** may possess a **driver's license or motorcycle driver's**  
4 license from any state; amending K.S.A. 8-276 and repealing the  
5 existing section.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. K.S.A. 8-276 is hereby amended to read as follows: 8-276.

9 (a) In order for a person to qualify as an instructor for a driving school,  
10 such person shall meet the following requirements:

11 ~~(a)~~(1) Present to the department evidence of:

12 ~~(1)~~(A) Credit in driver education and safety from an accredited  
13 college or university equivalent to credits in those subjects required of  
14 instructors in the schools accredited by the state board;

15 ~~(2)~~(B) having a valid credential issued by the state board to teach  
16 driver education; or

17 ~~(3)~~(C) having completed at least 30 hours of classroom and 24 hours  
18 of behind the wheel training under the direct supervision of an individual  
19 who is presently licensed as an instructor by the state board under  
20 ~~paragraph (1) subparagraph (A) or (2) (B)~~ and who has been continuously  
21 licensed and who has actively instructed students for a period of at least  
22 three years;

23 ~~(b)~~(2) have knowledge of the Kansas operation lifesaver  
24 highway/railroad grade crossing safety program;

25 ~~(e)~~(3) be physically able to operate safely a motor vehicle and to train  
26 others in the operation of motor vehicles;

27 ~~(d)~~(4) provide a certificate of health from a medical doctor stating  
28 that such person is physically and mentally able to safely operate a motor  
29 vehicle;

30 ~~(e)~~(5) ~~except as otherwise provided in subsection (b),~~ hold a valid  
31 Kansas ~~drivers'~~ **driver's license or driver's license issued by any other**  
32 **state**; and

33 ~~(f)~~(6) pay to the department an application fee of \$5.

34 (b) *For a motorcycle instructor subject to the provisions of this*  
35 *section, such motorcycle instructor shall be required to:*

- 1       (1) *Have successfully completed all requirements of this section; and*  
2       (2) *possess a valid class M driver's license or equivalent license*  
3 *allowing such individual to operate a motorcycle for another state.*

4       Sec. 2. K.S.A. 8-276 is hereby repealed.

5       Sec. 3. This act shall take effect and be in force from and after its  
6 publication in the statute book.
