1 AN ACT concerning business entities; relating to the Kansas revised
2 limited liability company act; providing for document form, signature
3 and delivery options; specifying that a subscription for a limited
4 liability company interest is irrevocable under certain circumstances;
5 modifying requirements related to domestic limited liability company
6 division, certificates of division and certificates of amendment of
7 certificate of division and certificates of merger or consolidation of
8 series; **relating to series limited liability companies; authorizing a**
9 **limited liability company and any of its series to elect to consolidate**
10 **its operations as a single taxpayer and elect to be treated as a single**
11 **business for certain purposes; permitting operating agreements to**
12 **impose restrictions, duties and obligations on members; specifying**
13 **that wrongful transfer of property with intent to hinder, delay or**
14 **defraud creditors or to defraud shall be deemed void;** relating to the
15 business entity transactions act; modifying requirements related to
16 certificates of merger, certificates of interest exchange, certificates of
17 conversion and certificates of domestication; relating to the business
18 entity standard treatment act; including certificates of amendment to
19 certificate of designation and certificates of merger or consolidation of
20 series as documents related to limited liability companies to be filed
21 with the secretary of state; specifying circumstances under which
22 changes related to a resident agent shall be deemed a change of name of
23 the person or entity acting as a resident agent; amending K.S.A. 17-
24 7662, 17-7663, 17-7668, 17-7670, 17-7681, 17-7682, 17-7685a, 17-
25 7686, 17-7687, 17-7690, 17-7695, 17-7698, 17-76,143, 17-76,143a, 17-

31 *Be it enacted by the Legislature of the State of Kansas:*

New Section 1. (a) (1) Except as provided in subsection (b), without
33 limiting the manner in which any act or transaction may be documented or

1 the manner in which a document may be signed or delivered:

2 (A) Any act or transaction contemplated or governed by the Kansas
3 revised limited liability company act or the operating agreement may be
4 provided for in a document, and an electronic transmission is the
5 equivalent of a written document.

6 (B) Whenever the Kansas revised limited liability company act or the
7 operating agreement requires or permits a signature, the signature may be
8 a manual, facsimile, conformed or electronic signature. "Electronic
9 signature" means an electronic symbol or process that is attached to, or
10 logically associated with, a document and executed or adopted by a person
11 with an intent to execute, authenticate or adopt the document. A person
12 may execute a document with such person's signature.

13 (C) Unless otherwise provided in the operating agreement or agreed
14 between the sender and recipient, an electronic transmission is delivered to
15 a person for purposes of the Kansas revised limited liability company act
16 and the operating agreement when it enters an information processing
17 system that the person has designated for the purpose of receiving
18 electronic transmissions of the type delivered if the electronic transmission
19 is in a form capable of being processed by that system and such person is
20 able to retrieve the electronic transmission. Whether a person has so
21 designated an information processing system is determined by the
22 operating agreement or from the context and surrounding circumstances,
23 including the parties' conduct. An electronic transmission is delivered
24 under this section even if no person is aware of its receipt. Receipt of an
25 electronic acknowledgement from an information processing system
26 establishes that an electronic transmission was received but, by itself, does
27 not establish that the content sent corresponds to the content received.

28 (2) The Kansas revised limited liability company act shall not
29 prohibit one or more persons from conducting a transaction in accordance
30 with the uniform electronic transactions act, K.S.A. 16-601 et seq., and
31 amendments thereto, if the part or parts of the transaction that are
32 governed by the Kansas revised limited liability company act are
33 documented, signed and delivered in accordance with this subsection or
34 otherwise in accordance with the Kansas revised limited liability company
35 act. This subsection shall apply solely for purposes of determining whether
36 an act or transaction has been documented, and the document has been
37 signed and delivered, in accordance with the Kansas revised limited
38 liability company act and the operating agreement.

39 (b) (1) Subsection (a) shall not apply to:

40 (A) A document filed with or submitted to the secretary of state or a
41 court or other judicial or governmental body of this state;

42 (B) a certificate of limited liability company interest, except that a
43 signature on a certificate of limited liability company interest may be

1 manual, facsimile or electronic signature; and

2 (C) an act or transaction effected pursuant to article 79 of chapter 17
3 of the Kansas Statutes Annotated, and amendments thereto, or K.S.A. 17-
4 7667, 17-76,130, 17-76,131, 17-76,132 and 17-76,133, and amendments
5 thereto.

6 (2) The provisions of paragraph (1) shall not create any presumption
7 about the lawful means to document a matter addressed by this subsection
8 or the lawful means to sign or deliver a document addressed by this
9 subsection. A provision of the operating agreement shall not limit the
10 application of subsection (a) unless the provision expressly restricts one or
11 more of the means of documenting an act or transaction, or of signing or
12 delivering a document, permitted by subsection (a).

13 (c) In the event that any provision of the Kansas revised limited
14 liability company act is deemed to modify, limit or supersede the federal
15 electronic signatures in global and national commerce act, 15 U.S.C. §
16 7001 et. seq., the provisions of the Kansas revised limited liability
17 company act shall control to the fullest extent permitted by 15 U.S.C. §
18 7002(a)(2).

19 (d) This section shall be a part of and supplemental to article 76 of
20 chapter 17 of the Kansas Statutes Annotated, and amendments thereto.

21 New Sec. 2. (a) For all purposes of the laws of the state of Kansas, a
22 subscription for a limited liability company interest, whether submitted in
23 writing, by means of electronic transmission or as otherwise permitted by
24 applicable law, is irrevocable if the subscription states that such
25 subscription is irrevocable to the extent provided by the terms of the
26 subscription.

27 (b) This section shall be a part of and supplemental to article 76 of
28 chapter 17 of the Kansas Statutes Annotated, and amendments thereto.

36 7663. As used in the Kansas revised limited liability company act unless
37 the context otherwise requires:

38 (a) "Articles of organization" means the articles of organization
39 referred to in K.S.A. 17-7673, and amendments thereto, and the articles of
40 organization as amended.

41 (b) "Bankruptcy" means an event that causes a person to cease to be a
42 member as provided in K.S.A. 17-7689, and amendments thereto.

43 (c) "Contribution" means any cash, property, services rendered or a

1 promissory note or other obligation to contribute cash or property or to
2 perform services; ~~which~~ *that* a person contributes to a limited liability
3 company in such person's capacity as a member.

4 (d) *"Document" means:*

5 (1) *Any tangible medium on which information is inscribed.*
6 *"Document" includes handwritten, typed, printed or similar instruments*
7 *and copies of such instruments; and*

8 (2) *an electronic transmission.*

9 (e) *"Electronic transmission" means any form of communication not*
10 *directly involving the physical transmission of paper, including the use of,*
11 *or participation in, one or more electronic networks or databases,*
12 *including one or more distributed electronic networks or databases, that*
13 *creates a record that may be retained, retrieved and reviewed by a*
14 *recipient thereof and directly reproduced in paper form by such a recipient*
15 *through an automated process.*

16 (f) *"Foreign limited liability company" means a limited liability*
17 *company formed under the laws of any state or under the laws of any*
18 *foreign country or other foreign jurisdiction. When used in the Kansas*
19 *revised limited liability company act in reference to a foreign limited*
20 *liability company, the terms "operating agreement," "limited liability*
21 *company interest," "manager" or "member" shall mean an operating*
22 *agreement, limited liability company interest, manager or member,*
23 *respectively, under the laws of the state or foreign country or other foreign*
24 *jurisdiction under which the foreign limited liability company is formed.*

25 (e)(g) *"Knowledge" means a person's actual knowledge of a fact,*
26 *rather than the person's constructive knowledge of the fact.*

27 (f)(h) *"Limited liability company" and "domestic limited liability*
28 *company" ~~means~~ mean a limited liability company formed under the laws*
29 *of the state of Kansas and having one or more members.*

30 (g)(i) *"Limited liability company interest" means a member's share of*
31 *the profits and losses of a limited liability company and a member's right*
32 *to receive distributions of the limited liability company's assets.*

33 (h)(j) *"Liquidating trustee" means a person carrying out the winding*
34 *up of a limited liability company.*

35 (i)(k) *"Manager" means a person who is named as a manager of a*
36 *limited liability company in, or designated as a manager of a limited*
37 *liability company pursuant to, an operating agreement or similar*
38 *instrument under which the limited liability company is formed.*
39 *"Manager" includes a manager of the limited liability company generally*
40 *and a manager associated with a series of the limited liability company.*
41 *Unless the context otherwise requires, references in the Kansas revised*
42 *limited liability company act to a manager, including references in the*
43 *Kansas revised limited liability company act to a manager of a limited*

1 *liability company, shall be deemed to be references to a manager of the*
2 *limited liability company generally and to a manager associated with a*
3 *series with respect to such series.*

4 ~~(j)~~(l) "Member" means a person who is admitted to a limited liability
5 company as a member as provided in K.S.A. 17-7686, and amendments
6 thereto. "Member" includes a member of the limited liability company
7 generally and a member associated with a series of the limited liability
8 company. Unless the context otherwise requires, references in the Kansas
9 revised limited liability company act to a member, including references in
10 the Kansas revised limited liability company act to a member of a limited
11 liability company, shall be deemed to be references to a member of the
12 limited liability company generally and to a member associated with a
13 series with respect to such series.

14 ~~(k)~~(m) "Operating agreement" means any agreement, whether
15 referred to as an operating agreement, limited liability company agreement
16 or otherwise, written, oral, or implied, of the member or members as to the
17 affairs of a limited liability company and the conduct of its business. A
18 member or manager of a limited liability company or an assignee of a
19 limited liability company interest is bound by the operating agreement
20 whether or not the member or manager or assignee executes the operating
21 agreement. A limited liability company, *including any series thereof*, is not
22 required to execute its operating agreement. A limited liability company,
23 *including any series thereof*, is bound by its operating agreement whether
24 or not the limited liability company, *or any series thereof*, executes the
25 operating agreement. An operating agreement of a limited liability
26 company having only one member shall not be unenforceable by reason of
27 there being only one person who is a party to the operating agreement. An
28 operating agreement is not subject to any statute of frauds, including
29 K.S.A. 33-106, and amendments thereto. An operating agreement may
30 provide rights to any person, including a person who is not a party to the
31 operating agreement, to the extent set forth therein. A written operating
32 agreement or another written agreement or writing:

33 (1) May provide that a person shall be admitted as a member of a
34 limited liability company, or shall become an assignee of a limited liability
35 company interest or other rights or powers of a member to the extent
36 assigned:

37 (A) If such person, or a representative authorized by such person
38 orally, in writing or by other action such as payment for a limited liability
39 company interest, executes the operating agreement or any other writing
40 evidencing the intent of such person to become a member or assignee; or

41 (B) without such execution, if such person, or a representative
42 authorized by such person orally, in writing or by other action such as
43 payment for a limited liability company interest, complies with the

1 conditions for becoming a member or assignee as set forth in the operating
2 agreement or any other writing; ~~and~~

3 (2) shall not be unenforceable by reason of its not having been signed
4 by a person being admitted as a member or becoming an assignee as
5 provided in subsection (k)(1), or by reason of its having been signed by a
6 representative as provided in the Kansas revised limited liability company
7 act; *and*

8 (3) *may consist of one or more agreements, instruments or other*
9 *writings and include or incorporate one or more schedules, supplements*
10 *or other writings containing provisions as to the conduct of the business*
11 *and affairs of the limited liability company or any series thereof.*

12 ~~(h)~~(n) "Person" means a natural person, partnership, whether general
13 or limited, limited liability company, trust, including a common law trust,
14 business trust, statutory trust, voting trust or any other form of trust, estate,
15 association, including any group, organization, ~~co-tenancy~~ *cotenancy*, plan,
16 board, council or committee, corporation, government, including a
17 country, state, county or any other governmental subdivision, agency or
18 instrumentality, custodian, nominee or any other individual or entity, or
19 series thereof, in its own or any representative capacity, in each case,
20 whether domestic or foreign.

21 ~~(m)~~(o) "Personal representative" means, as to a natural person, the
22 executor, administrator, guardian, conservator or other legal representative
23 thereof and, as to a person other than a natural person, the legal
24 representative or successor thereof.

25 ~~(n)~~(p) "Series" means a designated series of members, managers,
26 limited liability company interests or assets that is established in
27 accordance with K.S.A. 17-76,143, and amendments thereto.

28 ~~(o)~~(q) "State" means the District of Columbia or the commonwealth
29 of Puerto Rico or any state, territory, possession or other jurisdiction of the
30 United States other than the state of Kansas.

31 Sec. 5. K.S.A. 17-7668 is hereby amended to read as follows: 17-
32 7668. (a) Unless otherwise specifically prohibited by law, a limited
33 liability company may carry on any lawful business, purpose or activity,
34 whether or not for profit with the exception of the business of granting
35 policies of insurance, or assuming insurance risks or banking as defined in
36 K.S.A. 9-702, and amendments thereto.

37 (b) A limited liability company shall possess and may exercise all the
38 powers and privileges granted by this act or by any other law or by its
39 operating agreement, together with any powers incidental thereto,
40 including such powers and privileges as are necessary or convenient to the
41 conduct, promotion or attainment of the business, purposes or activities of
42 the limited liability company.

43 (c) A limited liability company organized and existing under the

1 Kansas revised limited liability company act or otherwise qualified to do
2 business in Kansas may have and exercise all powers that may be
3 exercised by a Kansas professional association or professional corporation
4 under the professional corporation law of Kansas, including employment
5 of professionals to practice a profession, which shall be limited to the
6 practice of one profession, except as provided in K.S.A. 17-2710, and
7 amendments thereto.

8 (d) Only a qualified person may be a member of a limited liability
9 company organized to exercise powers of a professional association or
10 professional corporation. No membership may be transferred to another
11 person until there is presented to such limited liability company a
12 certificate by the licensing body, as defined in K.S.A. 74-146, and
13 amendments thereto, stating that the person to whom the transfer is made
14 or the membership issued is duly licensed to render the same type of
15 professional services as that for which the limited liability company was
16 organized.

17 (e) As used in the section, "qualified person" means:

18 (1) Any natural person licensed to practice the same type of
19 profession that any professional association or professional corporation is
20 authorized to practice;

21 (2) the trustee of a trust that is a qualified trust under section 401(a)
22 of the federal internal revenue code of 1986, as in effect, on July 1, 1999,
23 or of a contribution plan that is a qualified employee stock ownership plan
24 under section 409A(a) of the federal internal revenue code of 1986, as in
25 effect, on July 1, 1999;

26 (3) the trustee of a revocable living trust established by a natural
27 person who is licensed to practice the type of profession that any
28 professional association or professional corporation is authorized to
29 practice, if the terms of such trust provide that such natural person is the
30 principal beneficiary and sole trustee of such trust and such trust does not
31 continue to hold title to membership in the limited liability company
32 following such natural person's death for more than a reasonable period of
33 time necessary to dispose of such membership;

34 (4) a Kansas professional corporation or foreign professional
35 corporation in which at least one member or shareholder is authorized by a
36 licensing body, as defined in K.S.A. 74-146, and amendments thereto, to
37 render in this state a professional service permitted by the articles of
38 organization;

39 (5) a general partnership or limited liability company, if all partners
40 or members thereof are authorized to render the professional services
41 permitted by the articles of organization of the limited liability company
42 formed pursuant to this section and in which at least one partner or
43 member is authorized by a licensing authority of this state to render in this

1 state the professional services permitted by the articles of organization of
2 the limited liability company; or

3 (6) a healing arts school clinic authorized to perform professional
4 services in accordance with K.S.A. 65-2877a, and amendments thereto.

5 (f) Nothing in this act shall restrict or limit in any manner the
6 authority and duty of any licensing body, as defined in K.S.A. 74-146, and
7 amendments thereto, for the licensing of individual persons rendering a
8 professional service or the practice of the profession that is within the
9 jurisdiction of the licensing body, notwithstanding that the person is an
10 officer, manager, member or employee of a limited liability company
11 organized to exercise powers of a professional association or professional
12 corporation. Each licensing body may adopt rules and regulations
13 governing the practice of each profession as are necessary to enforce and
14 comply with this act and the law applicable to each profession.

15 (g) A licensing body, as defined in K.S.A. 74-146, and amendments
16 thereto, the attorney general or district or county attorney may bring an
17 action in the name of the state of Kansas in quo warranto or injunction
18 against a limited liability company engaging in the practice of a profession
19 without complying with the provisions of this act.

20 (h) Notwithstanding any provision of this act to the contrary, without
21 limiting the general powers enumerated in subsection (b), a limited
22 liability company shall, subject to such standards and restrictions, if any,
23 as are set forth in its operating agreement, have the power and authority to
24 make contracts of guaranty and suretyship and enter into interest rate,
25 basis, currency, hedge or other swap agreements or cap, floor, put, call,
26 option, exchange or collar agreements, derivative agreements, or other
27 agreements similar to any of the foregoing.

28 (i) Unless otherwise provided in an operating agreement, a limited
29 liability company has the power and authority to grant, hold or exercise a
30 power of attorney, including an irrevocable power of attorney.

31 (j) (I) (A) *Except as provided in subparagraph (B), any act or*
32 *transaction that may be taken by or in respect of a limited liability*
33 *company under the Kansas revised limited liability company act or an*
34 *operating agreement, but that is void or voidable when taken, may be*
35 *ratified, or the failure to comply with any requirements of the operating*
36 *agreement making such act or transaction void or voidable may be*
37 *waived, by the members, managers or other persons whose approval*
38 *would be required under the operating agreement (i) for such act or*
39 *transaction to be validly taken, or (ii) to amend the operating agreement*
40 *in a manner that would permit such act or transaction to be validly taken,*
41 *in each case at the time of such ratification or waiver.*

42 (B) *If the void or voidable act or transaction was the issuance or*
43 *assignment of any limited liability company interests, the limited liability*

1 *company interests purportedly issued or assigned shall be deemed not to*
2 *have been issued or assigned for purposes of determining whether the void*
3 *or voidable act or transaction was ratified or waived pursuant to this*
4 *subsection.*

5 (2) *Any act or transaction that is ratified, or with respect to which the*
6 *failure to comply with any requirements of the operating agreement is*
7 *waived, pursuant to this subsection shall be deemed validly taken at the*
8 *time of such act or transaction.*

9 (3) *If an amendment to the operating agreement to permit any such*
10 *act or transaction to be validly taken would require notice to any*
11 *members, managers or other persons under the operating agreement and*
12 *the ratification or waiver of such act or transaction is effectuated pursuant*
13 *to this subsection by the members, managers or other persons whose*
14 *approval would be required to amend the operating agreement, notice of*
15 *such ratification or waiver shall be given following such ratification or*
16 *waiver to the members, managers or other persons who would have been*
17 *entitled to notice of such an amendment and who have not otherwise*
18 *received notice of, or participated in, such ratification or waiver.*

19 (4) *The provisions of this subsection shall not be construed to limit*
20 *the accomplishment of a ratification or waiver of a void or voidable act by*
21 *other means permitted by law.*

22 (5) *Upon application of the limited liability company, any member,*
23 *manager or person claiming to be substantially and adversely affected by*
24 *a ratification or waiver pursuant to this subsection, excluding any harm*
25 *that would have resulted if such act or transaction had been valid when*
26 *taken, the district court may hear and determine the validity and*
27 *effectiveness of the ratification of, or waiver with respect to, any void or*
28 *voidable act or transaction effectuated pursuant to this subsection. In any*
29 *such application, the limited liability company shall be named as a party*
30 *and service of the application upon the resident agent of the limited*
31 *liability company shall be deemed to be service upon the limited liability*
32 *company, and no other party need be joined in order for the court to*
33 *adjudicate the validity and effectiveness of the ratification or waiver. The*
34 *court may make such order respecting further or other notice of such*
35 *application as it deems proper under these circumstances. Nothing in this*
36 *paragraph limits or affects the right to serve process in any other manner*
37 *now or hereafter provided by law, and this provision is an extension of and*
38 *not a limitation upon the right otherwise existing of service of legal*
39 *process upon nonresidents.*

40 Sec. 6. K.S.A. 17-7670 is hereby amended to read as follows: 17-
41 7670. (a) Subject to such standards and restrictions, if any, as are set forth
42 in its operating agreement, a limited liability company may, and shall have
43 the power to, indemnify and hold harmless any member or manager or

1 other person from and against any and all claims and demands whatsoever.

2 (b) (1) *Except as provided in the operating agreement, to the extent*
3 *that a present or former member, manager, or officer, ~~employee or agent~~ of*
4 *a limited liability company has been successful on the merits or otherwise*
5 *as a plaintiff in an action to determine that the plaintiff is a member of a*
6 *limited liability company or in defense of any threatened, pending or*
7 *completed action, suit or proceeding, whether civil, criminal,*
8 *administrative or investigative, by reason of the fact that such person is or*
9 *was a member, manager, officer, employee or agent of the limited liability*
10 *company, or is or was serving at the request of the limited liability*
11 *company as a member, manager, director, officer, employee or agent of*
12 *another limited liability company, corporation, partnership, joint venture,*
13 *trust or other enterprise, or in defense of any claim, issue or matter therein,*
14 *such member, manager, officer, employee or agent shall be indemnified by*
15 *the limited liability company against expenses actually and reasonably*
16 *incurred by such person in connection therewith, including attorney fees.*

17 (2) *For indemnification with respect to any act or omission occurring*
18 *after June 30, 2025, references to "officer" for purposes of this subsection*
19 *only means an officer of the limited liability company who:*

20 (A) *Is or was the president, chief executive officer, chief operating*
21 *officer, chief financial officer, chief legal officer, controller, treasurer or*
22 *chief accounting officer of the limited liability company; or*

23 (B) *is or was identified in the limited liability company's public*
24 *filings with the United States securities and exchange commission,*
25 *because such person is or was one of the most highly compensated*
26 *executive officers of the limited liability company.*

27 Sec. 7. K.S.A. 17-7681 is hereby amended to read as follows: 17-
28 7681. (a) Pursuant to an agreement of merger or consolidation, one or
29 more domestic limited liability companies may merge or consolidate with
30 or into one or more limited liability companies formed under the laws of
31 the state of Kansas or any other state or any foreign country or other
32 foreign jurisdiction, or any combination thereof, with such limited liability
33 company as the agreement shall provide being the surviving or resulting
34 limited liability company.

35 (1) (A) Unless otherwise provided in the operating agreement, an
36 agreement of merger or consolidation shall be consented to or approved by
37 each domestic limited liability company—~~which~~ *that* is to merge or
38 consolidate by members who own more than 50% of the then-current
39 percentage or other interest in the profits of the domestic limited liability
40 company owned by all of the members;

41 (B) unless otherwise provided in the operating agreement, a limited
42 liability company whose original articles of organization were filed with
43 the secretary of state and effective on or prior to June 30, 2019, shall not

1 be governed by subsection (a)(1)(A); but shall be governed by this
2 subparagraph. Unless otherwise provided in the operating agreement, an
3 agreement of merger or consolidation shall be consented to or approved by
4 each domestic limited liability company—~~which~~ *that* is to merge or
5 consolidate by the members, or if there is more than one class or group of
6 members, then by each class or group of members, in either case, by
7 members who own more than 50% of the then current percentage or other
8 interest in the profits of the domestic limited liability company owned by
9 all of the members or by the members in each class or group, as
10 appropriate.

11 (2) In connection with a merger or consolidation hereunder, rights or
12 securities of, or interests in, a domestic limited liability company—~~which~~
13 *that* is a constituent party to the merger or consolidation may be exchanged
14 for or converted into cash, property, rights or securities of, or interests in,
15 the surviving or resulting limited liability company or, in addition to or in
16 lieu thereof, may be exchanged for or converted into cash, property, rights

31 operating agreement may provide that any member or class or group of
32 members associated with a series shall have no voting rights **or ability to**
33 **otherwise participate in the management or governance of such series,**
34 **but any such member or class or group of members are owners of the**
35 **series.**

36 (4) An operating agreement may grant to all or certain identified
37 members or managers or a specified class or group of the members or
38 managers associated with a series the right to vote separately or with all or
39 any class or group of the members or managers associated with such
40 series, on any matter. Voting by members or managers associated with a
41 series may be on a per capita, number, financial interest, class, group or
42 any other basis.

43 (5) Unless otherwise provided in an operating agreement, the

1 management of a series shall be vested in the members associated with
2 such series in proportion to the then-current percentage or other interest of
3 members in the profits of such series owned by all of the members
4 associated with such series, the decision of members owning more than
5 50% of such percentage or other interest in the profits controlling, except
6 that if an operating agreement provides for the management of a series, in
7 whole or in part, by a manager **or managers**, the management of such
