1 A PROPOSITION to amend section 1 of article 5 of the constitution of  
2 the state of Kansas to require individuals to be citizens of the United  
3 States, at least 18 years of age and a resident of the voting area in  
4 which such person seeks to vote in order to vote in this state.  
5

6 *Be it resolved by the Legislature of the State of Kansas, two-thirds of the*  
7 *members elected (or appointed) and qualified to the House of*  
8 *Representatives and two-thirds of the members elected (or*  
9 *appointed) and qualified to the Senate concurring therein:*

10 Section 1. The following proposition to amend the constitution of  
11 the state of Kansas shall be submitted to the qualified electors of the state  
12 for their approval or rejection: Section 1 of article 5 of the constitution of  
13 the state of Kansas is hereby amended to read as follows:

14 "§ 1. **Qualifications of electors.** ~~Every~~(a) *No person shall*  
15 *be deemed a qualified elector unless such person:*

16 (1) *Is a citizen of the United States*~~who~~;

17 (2) *has attained the age of eighteen years; and*~~who~~

18 (3) *except as provided in subsection (b) or (c), resides in*  
19 *the voting area in which*~~he or she~~ *such person seeks to vote*  
20 ~~shall be deemed a qualified elector.~~

21 (b) *Laws of this state relating to voting for presidential*  
22 *electors and candidates for the office of president and vice-*  
23 *president of the United States shall comply with the laws of the*  
24 *United States relating thereto. A citizen of the United States,*  
25 *who is otherwise qualified to vote in Kansas for presidential*  
26 *electors and candidates for the offices of president and vice-*  
27 *president of the United States may vote for such officers either*  
28 *in person or by absentee ballot notwithstanding the fact that*  
29 *such person may have become a nonresident of this state if*~~his~~  
30 ~~or her~~ *such person's* removal from this state occurs during a  
31 period in accordance with federal law next preceding such

1 election.

2 (c) A person who is otherwise a qualified elector may vote  
3 in the voting area of ~~his or her~~ *such person's* former residence  
4 either in person or by absentee ballot notwithstanding the fact  
5 that such person may have become a nonresident of such voting  
6 area during a period prescribed by law next preceding the  
7 election at which ~~he or she~~ *such person* seeks to vote, if ~~his~~  
8 *such person's* new residence is in another voting area in the  
9 state of Kansas."

10 Sec. 2. The following statement shall be printed on the ballot with  
11 the amendment as a whole:

12 "*Explanatory statement.* This amendment would clarify that  
13 only a person who is a citizen of the United States, ~~at least~~  
14 ~~18 years of age and, unless a residency exception applies to~~  
15 ~~such person, a resident of the voting area in which such~~  
16 ~~person seeks to vote~~ is eligible to vote in this state.

17 "A vote for this proposition would clarify that only a person  
18 who is a citizen of the United States, ~~at least 18 years of age~~  
19 ~~and, unless a residency exception applies to such person, a~~  
20 ~~resident of the voting area in which such person seeks to~~  
21 ~~vote~~ is eligible to vote in this state.

22 "A vote against this proposition would make no change to the  
23 constitution of the state of Kansas, and the language  
24 concerning voter qualifications would remain the same."

25 Sec. 3. This resolution, if approved by two-thirds of the members  
26 elected (or appointed) and qualified to the House of Representatives and  
27 two-thirds of the members elected (or appointed) and qualified to the  
28 Senate, shall be entered on the journals, together with the yeas and nays.  
29 The secretary of state shall cause this resolution to be published as  
30 provided by law and shall cause the proposed amendment to be submitted  
31 to the electors of the state at the general election in November in the year  
32 2026, unless a special election is called at a sooner date by concurrent  
33 resolution of the legislature, in which case the proposed amendment shall  
34 be submitted to the electors of the state at the special election.
