

## Senate Concurrent Resolution No. 1608

1 A PROPOSITION to amend section 1 of article 5 of the constitution of  
2 the state of Kansas to require individuals to be citizens of the United  
3 States, at least 18 years of age and a resident of the voting area in  
4 which such person seeks to vote in order to vote in this state.

6 *Be it resolved by the Legislature of the State of Kansas, two-thirds of the*  
7 *members elected (or appointed) and qualified to the Senate and two-*  
8 *thirds of the members elected (or appointed) and qualified to the*  
9 *House of Representatives concurring therein:*

10 Section 1. The following proposition to amend the constitution of  
11 the state of Kansas shall be submitted to the qualified electors of the state  
12 for their approval or rejection: Section 1 of article 5 of the constitution of  
13 the state of Kansas is hereby amended to read as follows:

14 **"§ 1. Qualifications of electors.** ~~Every~~(a) *No person shall be*  
15 *deemed a qualified elector unless such person:*

16 (1) *Is a citizen of the United States*~~who~~;

17 (2) *has attained the age of eighteen years; and*~~who~~

18 (3) *except as provided in subsection (b) or (c), resides in the*  
19 *voting area in which he or she seeks to vote*~~shall be deemed a~~  
20 ~~qualified elector.~~

21 (b) *Laws of this state relating to voting for presidential*  
22 *electors and candidates for the office of president and vice-*  
23 *president of the United States shall comply with the laws of the*  
24 *United States relating thereto. A citizen of the United States, who is*  
25 *otherwise qualified to vote in Kansas for presidential electors and*  
26 *candidates for the offices of president and vice-president of the*  
27 *United States may vote for such officers either in person or by*  
28 *absentee ballot notwithstanding the fact that such person may have*  
29 *become a nonresident of this state if his or her removal from this*  
30 *state occurs during a period in accordance with federal law next*  
31 *preceding such election.*

32 (c) *A person who is otherwise a qualified elector may vote in*  
33 *the voting area of his or her former residence either in person or by*

1 absentee ballot notwithstanding the fact that such person may have  
2 become a nonresident of such voting area during a period  
3 prescribed by law next preceding the election at which he or she  
4 seeks to vote, if his *or her* new residence is in another voting area  
5 in the state of Kansas."

6 Sec. 2. The following statement shall be printed on the ballot with  
7 the amendment as a whole:

8 "*Explanatory statement.* This amendment would clarify that  
9 only a person who is a citizen of the United States, at least  
10 18 years of age and, unless a residency exception applies to  
11 such person, a resident of the voting area in which such  
12 person seeks to vote is eligible to vote in this state.

13 "A vote for this proposition would clarify that only a person  
14 who is a citizen of the United States, at least 18 years of age  
15 and, unless a residency exception applies to such person, a  
16 resident of the voting area in which such person seeks to  
17 vote is eligible to vote in this state.

18 "A vote against this proposition would make no change to the  
19 constitution of the state of Kansas, and the language  
20 concerning voter qualifications would remain the same."

21 Sec. 3. This resolution, if approved by two-thirds of the members  
22 elected (or appointed) and qualified to the Senate and two-thirds of the  
23 members elected (or appointed) and qualified to the House of  
24 Representatives, shall be entered on the journals, together with the yeas  
25 and nays. The secretary of state shall cause this resolution to be published  
26 as provided by law and shall cause the proposed amendment to be  
27 submitted to the electors of the state at the general election in November  
28 in the year 2026, unless a special election is called at a sooner date by  
29 concurrent resolution of the legislature, in which case the proposed  
30 amendment shall be submitted to the electors of the state at the special  
31 election.
