2025 Session Deadlines

The following dates are the deadlines for introduction and consideration of bills for the 2025 session. These deadlines were adopted as part of the Joint Rules of the Senate and House of Representatives for the 2025 - 2026 biennium.

Monday, January 27th

Last day for member or members to REQUEST bill drafts from Revisor's office.

Monday, February 3rd

Last day for <u>non-exempt Committees</u> to REQUEST bill drafts from the Revisor's office.

NOTE: This is the last day requests for introduction or sponsorship can be on nonexempt committee agendas.

Wednesday, February 5th

Last day for <u>Individuals</u> to INTRODUCE bills in originating chamber. NOTE: Bills must be submitted to chamber staff during daily session for Introduction.

Friday, February 7th

Last day for <u>non-exempt Committees</u> to INTRODUCE bills in originating chamber.

NOTE: Bills must be submitted to chamber staff during daily session for Introduction.

Thursday, February 20th (Turnaround Day)

Last day to CONSIDER non-exempt bills IN house of origin.

Friday, March 21st (Second Chamber Consideration)

Last day to CONSIDER non-exempt bill NOT in the chamber of origin.

Friday, March 28th (First Adjournment)

No bills considered after this date except bills vetoed by the Governor, Omnibus appropriations act and Omnibus reconciliations spending limit bill. NOTE: Subject to suspension motion pursuant to Joint Rule 4(k).

Veto session is anticipated to begin on April 10th.

Exempt committees: House and Senate Federal and State Affairs, Senate Ways and Means, Senate Assessment and Taxation, House committees on Calendar and Printing, Appropriations, Taxation or select committees of either house when so authorized. **Exempt bills** are those sponsored by, referred to or acted upon by an exempt committee.
