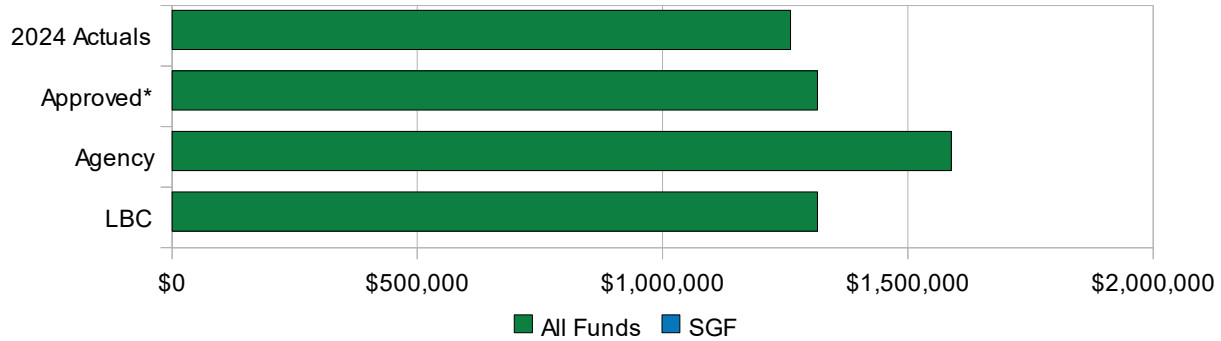
AGENCY OVERVIEW

The Board of Cosmetology (KBOC) is responsible for ensuring the health, safety, and welfare of the consuming public. This regulatory responsibility is attained through a proactive, efficient, and responsive structure. The Board accepts the responsibility to provide licensees access to information necessary to ensure the health, safety, and welfare of the consuming public. The Board licenses cosmetology schools, instructors, cosmetologists, electrologists, estheticians, manicurists, cosmetology technicians, body piercers, tattoo artists, and permanent cosmetic facilities. Instructors are required to complete continuing education hours to maintain their certification. The Board also contracts with an exam company to administer national standardized written and practical examinations to license students training in the fields of cosmetology and body art.

The Board of Cosmetology consists of a single administration program and utilizes three agency divisions to achieve its goals: administration, licensing, and enforcement.

1. SGF REAPPROPRIATION

The agency did not have any SGF funds reappropriated from FY 2024 into FY 2025.

2. IT MAINTENANCE AGREEMENT

The agency's FY 2025 request includes a supplemental request of \$45,000, all from the Cosmetology Fee Fund, for the continued operation, maintenance, set up, and programming of Big Picture licensing and archival software used by the agency.

- **Agency:** Add \$45,000, all from the Cosmetology Fee Fund, to use for the ongoing maintenance agreement with Big Picture archival software in FY 2025.
- **LBC:** Delete \$45,000, all from the Cosmetology Fee Fund, to use for the ongoing maintenance agreement with "Big Picture" archival software in FY 2025.

3. IT MAINTENANCE SERVICES (OT)

The agency's FY 2025 request includes a supplemental request of \$18,000, all from the Cosmetology Fee Fund, for IT maintenance services previously conducted on Big Picture software outside of the maintenance agreement for the current fiscal year.

- **Agency:** Add \$18,000, all from the Cosmetology Fee Fund, for IT maintenance services in FY 2025.
- **LBC:** Delete \$18,000, all from the Cosmetology Fee Fund, for IT maintenance services in FY 2025.

4. IT SOFTWARE LEASING (OT)

The agency's FY 2025 request includes a supplemental request of \$37,000, all from the Cosmetology Fee Fund, for leasing and use of software designed to connect the agency server to IBARS in order to assist with the certain requirements as they relate to 2023 SB 66. \$33,000 of \$37,000 is a one-time (OT) expense and only attributed to the contract cost. \$4,000 of \$37,000 is a recurring expense for the maintenance of the software.

- **Agency:** Add \$37,000, all from the Cosmetology Fee Fund, for IT leasing services in FY 2025.
- **LBC:** Delete \$37,000, all from the Cosmetology Fee Fund, for IT leasing services in FY 2025.

5. OFFICE IT EQUIPMENT (OT)

The agency's FY 2025 request includes a supplemental request of \$5,000, all from the Cosmetology Fee Fund, for increased rental costs following the agency's anticipated move to a new office location in September 2025.

- **Agency:** Add \$5,000, all from the Cosmetology Fee Fund, for office IT equipment in FY 2025.
- **LBC:** Delete \$5,000, all from the Cosmetology Fee Fund, for office IT equipment in FY 2025.

6. LEASE INCREASE

The agency's FY 2025 request includes a supplemental request for \$41,800, all from the Cosmetology Fee Fund, for additional rental costs following the anticipated 2025 office move to a new location, following the expiration of the current lease and purchase of the office space by a private entity. The new office will feature an increased cost per square foot of rental space. The agency's current location charges \$12.99 per square foot, while a new office will charge \$23.95 per square foot.

- **Agency:** Add \$41,800, all from the Cosmetology Fee Fund, for the increased cost of square footage in a new office space in FY 2025.

22. ALL OTHER ADJUSTMENTS

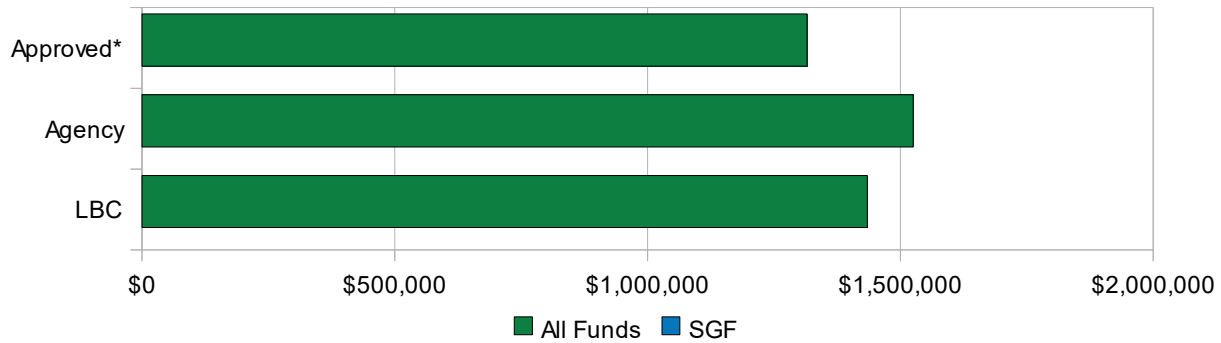
The agency's FY 2025 revised estimate includes a decrease of \$10,200 for all other adjustments. The request adds 1.0 FTE position.

This increase is offset by a decrease in spending on classified temporary salary (\$13,500).

- **Agency:** Add \$87,793, all from the Cosmetology Fee Fund, for salaries and wages for FY 2026.

5. INTERGOV

The agency's 2026 revised estimate includes an increase of \$14,421, all from the Cosmetology Fee Fund, for communication services. This increase reflects the usage of intergovernmental services.

- **Agency:** Add \$14,421, all from the Cosmetology Fee Fund, for intergovernmental communication systems in FY 2026.
- **LBC:** No change.

6. BUILDING SPACE RENTAL

The agency's 2026 revised estimate includes an increase of \$5,500, all from the Cosmetology Fee Fund, for building space rental. This increase reflects the increased

cost of the new office space when compared with the lease for the current office.

- **Agency:** Add \$5,500, all from the Cosmetology Fee Fund, for building space rental in FY 2026.
- **LBC:** No change.

7. OTHER PROFESSIONAL FEES

The agency's 2026 revised estimate includes an increase of \$15,247, all from the Cosmetology Fee Fund, for other professional fees. This amount reflects an increase of spending on contractual services consisting of payments to the Office of Information Technology Services and the Department of Administration.

8. ATTORNEYS

The agency's 2026 revised estimate includes an increase of \$8,650, all from the Cosmetology Fee Fund, for attorneys and lawyers. The agency's legal counsel is provided through the Office of the Attorney General.

- **Agency:** Add \$8,650, all from the Cosmetology Fee Fund, for attorneys and lawyers in FY 2026.
- **LBC:** No change.

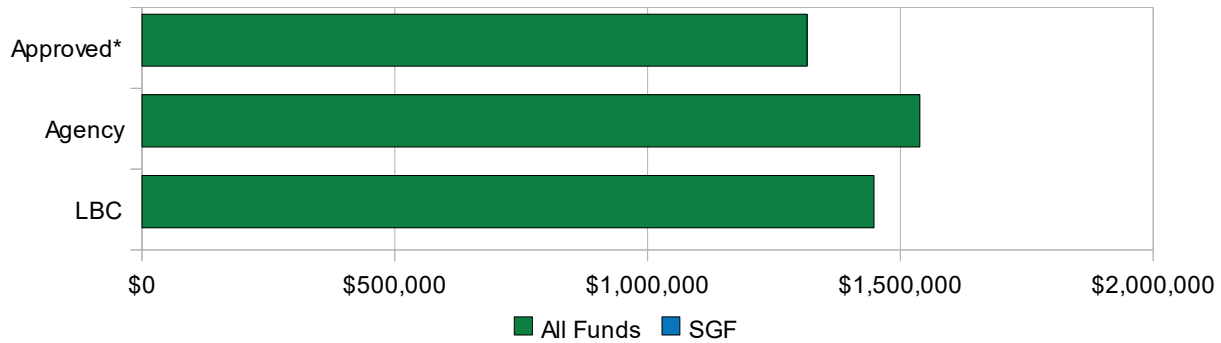
9. ALL OTHER ADJUSTMENTS

The agency's FY 2026 revised estimate includes a decrease of \$12,734 for all other adjustments. This decrease includes printing and advertising (\$7,700), meals and lodging (\$6,500), surety bonds and insurance premiums (\$2,000), and dues and subscriptions (\$2,000), offset by an increase in repair and service of vehicles (\$5,445). The request also includes an increase of 1.0 FTE position.

- **Agency:** Delete \$12,734, all from the Cosmetology Fee Fund, and 1.0 FTE position for all other adjustments for FY 2026.
- **LBC:** Delete 1.0 FTE position for FY 2026.

The agency's 2027 revised estimate includes an increase of \$13,721, all from the Cosmetology Fee Fund, for communication services. This increase reflects the usage of stationery, intergovernmental, and database communication related to 2023 SB 66.

- **Agency:** Add \$13,721, all from the Cosmetology Fee Fund, for intergovernmental communication systems for FY 2027.
- **LBC:** No change.

7. BUILDING SPACE RENTAL

The agency's 2027 revised estimate includes an increase of \$5,500, all from the Cosmetology Fee Fund, for building space rental. This increase reflects the increased lease cost of the new office space when compared with the lease for the current office.

- **Agency:** Add \$5,500, all from the Cosmetology Fee Fund, for building space rental for FY 2027.
- **LBC:** No change.

8. OTHER PROFESSIONAL FEES

The agency's 2027 revised estimate includes an increase of \$15,247, all from the Cosmetology Fee Fund, for other professional fees. This amount reflects an increase of spending on contractual services consisting of payments to the Office of Information Technology Services and the Department of Administration.

- **Agency:** Add \$15,247, all from the Cosmetology Fee Fund, for other professional fees for FY 2027.
- **LBC:** No change.

9. ATTORNEYS

The agency's 2027 revised estimate includes an increase of \$8,650, all from the Cosmetology Fee Fund, for attorneys. The agency's legal counsel is provided through the Office of the Attorney General.

- **Agency:** Add \$8,650, all from the Cosmetology Fee Fund, for attorneys for FY 2027.
- **LBC:** No change.

10. ALL OTHER ADJUSTMENTS

The agency's FY 2027 revised estimate includes a decrease of \$12,034 for all other adjustments. This decrease includes printing and advertising (\$7,700), meals and lodging (\$6,500), surety bonds and insurance premiums (\$2,000), and dues and subscriptions (\$2,000), offset by an increase in repair and service of vehicles (\$5,445).

- **Agency:** Delete \$12,034, all from the Cosmetology Fee Fund, for all other adjustments for FY 2027.
- **LBC:** Delete 1.0 FTE position for FY 2027.

SPECIAL REVENUE FUND OVERVIEW

The Board of Cosmetology is a fee-funded agency. The revenue received provides financing for all agency operations. KSA 75-3170a(a) provides that 90.0 percent of incoming revenues are retained by the agency and 10.0 percent are deposited into the State General Fund, up to a maximum of \$100,000 per fiscal year per fund. There have not been any major changes in expenditures for the Cosmetology Fee Fund for the last few years.
