#### AGENCY OVERVIEW

**FTE Positions** 

The Governmental Ethics Commission is charged with administering, interpreting, and enforcing the Campaign Finance Act and laws relating to conflicts of interest, financial disclosure, and the regulation of lobbying. These laws establish the public's right to information about the financial affairs of Kansas' public officials, lobbyists, and candidates for state and local office. The Commission also renders advisory opinions and can adopt rules and regulations.

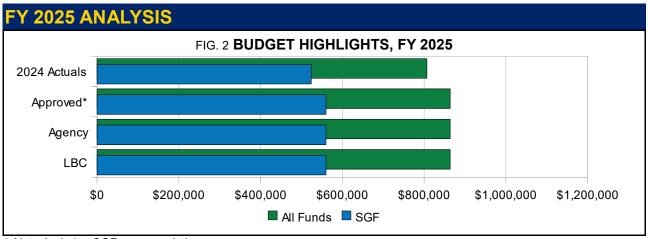

Each year, the Commission receives thousands of financial disclosure reports filed by candidates, political parties and party committees, public officials, and lobbyists. During non-election years, the Commission staff conduct comprehensive audits of previous filings; process new candidate Appointment of Treasurer forms and Political Action Committee Statement of Organization forms; ensure all persons subject to Commission regulation receive all pertinent campaign finance information for upcoming elections; process failure-to-file notices; and file complaints. During election years, the Commission devotes a majority of staff time to answering campaign-related questions, assisting candidates and candidate treasurers in completing their reports, and reviewing the receipts and expenditure reports filed. In addition to these responsibilities, the Commission enforces and assures lobbyists' compliance with state lobbying laws. The agency also provides the public with timely reports and statistical summaries of information filed by lobbyists, candidates for state office, political action committees, and party committees.

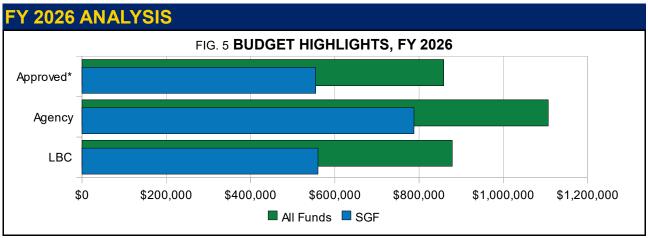

#### 1. ADDITIONAL PERSONNEL AND OFFICE RELOCATION

The agency is currently staffed by 9 employees, totaling 8.5 FTE positions:

- 1 Executive Director;
- 1 Attorney;
- 1 Office Manager;
- 2 Campaign Finance Coordinators;
- 2 State Auditors;
- 1 Investigator; and
- 1 Lobbyist Coordinator.

The agency's request includes an additional \$227,907 SGF and 2.0 FTE positions for additional personnel and office space for FY 2026. That amount includes \$186,047 to add one Compliance Attorney and one Auditor, \$40,360 for office space, \$10,000 for one-time moving costs, and a decrease of \$8,500 from eliminating the conflict counsel contract with the Office of the Attorney General.

**Compliance Attorney.** The base salary for the Compliance Attorney position would be \$80,000, along with associated fringe benefits. The agency states that separating compliance and enforcement attorneys is practiced in other agencies, such as the Kansas Corporation Commission and the Office of the Attorney General's open government team. This ensures that the person providing guidance is not also responsible for enforcement, helping to avoid potential conflicts.

**Auditor.** The base wage for the auditor position would be \$57,000, along with associated fringe benefits. The auditor will conduct field audits of the receipts and expenditure reports submitted by campaigns and committees. Additionally, the auditor will be tasked with auditing the records of candidates and political action committees to ensure compliance and accuracy.

**Building Space Rental.** The agency's request includes an increase of \$40,360 for building rent. Currently, the agency is located in the Mills Building in Topeka. According to the agency, the existing office does not provide adequate space for the additional staff they are requesting, and the current lease will expire in November 2025.

**Moving Expenses.** Additionally, the agency's request includes a one-time increase of \$10,000 for moving costs in FY 2026.

**Conflict Counsel Contract.** The agency requests a decrease of \$8,500 to eliminate the current conflict counsel contract with the Office of the Attorney General, as this contract will no longer be needed with the addition of a compliance attorney.

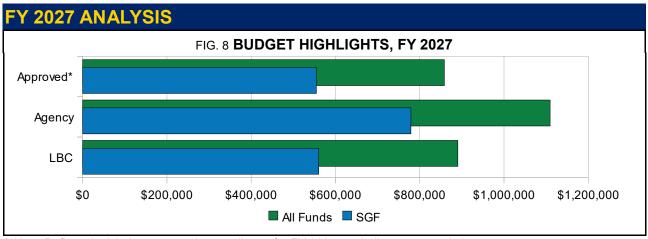
- Agency: Add \$227,907 SGF and 2.0 FTE positions to add one Compliance Attorney and one Auditor, for additional office space and one-time moving costs, and to eliminate the conflict counsel contract for FY 2026.
- LBC: Delete \$236,407 SGF and 2.0 FTE positions not to add one Compliance Attorney and one Auditor, additional office space, and one-time moving costs, and add \$8,500 SGF to keep the conflict counsel contract, for a total deletion of \$227,907 SGF for FY 2026.

#### 2. ALL OTHER ADJUSTMENTS

The agency's request includes an additional \$19,952, including \$5,407 SGF, in other adjustments from the amount approved by the 2024 Legislature. This increase is associated with increased employer contributions to health benefits (\$7,617) for FY 2026. For FY 2026, employer rates for medical benefits will increase to 7.5 percent, leading to increased agency spending for this expenditure. Additionally, there are increases of spending in contractual services, including a new building space rental (\$12,557), employee parking (\$7,782), the monumental building surcharge assessed by the Department of Administration for the agency's office space (\$4,236), and janitorial services due to a transition in building management (\$2,796).

These increases are partially offset by decreased spending on database fees due to a termination of a contract (\$6,024), database data storage (\$4,236), postage in a less-active election cycle (\$4,000), and mileage for the Commissioner (\$2,088).

### 1. ADDITIONAL PERSONNEL AND OFFICE RELOCATION

The agency requests \$218,887, all SGF, and 2.0 FTE positions for additional personnel and office space for FY 2027. This request includes an increase of \$187,027 to add one Compliance Attorney and one Auditor, \$40,360 for office space, and a decrease of \$8,500 from eliminating the conflict counsel contract with the Office of the Attorney General.

This request is substantively similar to the same enhancement request for FY 2026, but it does not include the \$10,000 for one-time moving expenses requested for FY 2026, and there is a slight difference in fringe benefits spending.

- Agency: Add \$218,887 SGF and 2.0 FTE positions for one Compliance Attorney and one Auditor, additional office space, and elimination of the conflict counsel contract for FY 2027.
- LBC: Delete \$227,387 SGF and 2.0 FTE positions not to add one Compliance Attorney and one Auditor and additional office space, and add \$8,500 SGF to keep

the conflict counsel contract, for a total deletion of \$218,887 SGF for FY 2027.

#### 2. ALL OTHER ADJUSTMENTS

The agency's request includes an additional \$31,941, including \$5,407 SGF, in other adjustments from the amount approved by the 2024 Legislature. This increase is associated with increased employer contributions to health benefits (\$14,877) for FY 2027. Beginning FY 2026, the employer rates for medical benefits will increase to 7.5 percent, leading to increased agency spending for this expenditure. Additionally, there are increases of spending in contractual services, including new building space rental (\$12,380), employee parking (\$7,782), the monumental building surcharge assessed by the Department of Administration for the agency's office space (\$6,001), janitorial services due to a transition in building management (\$2,796), and Office 365 and computer replacements (\$2,304).

These increases are partially offset by decreased spending on database fees due to termination of a contract (\$6,024), database data storage (\$4,836), and postage (\$2,000).

- Agency: Add \$31,941, including \$5,407 SGF, for all other adjustments for FY 2027.
- LBC: No changes.

# **SPECIAL REVENUE FUND OVERVIEW**

# **GOVERNMENTAL ETHICS COMMISSION FEE FUND**

The Governmental Ethics Commission Fee Fund is a statutory fee fund. It is funded by candidate filing fees, lobbyist registration fees, political action committees fees, and registration fees. KSA 75-3170a(a) provides that 90.0 percent of incoming revenues are retained by the agency and 10.0 percent are deposited into the SGF, up to a maximum of \$100,000 per fiscal year per fund.

The Governmental Ethics Commission Fee Fund collects revenue from fees paid by political action committees, lobbyists, and candidates. The amount of revenue collected varies each year depending on the election year cycle and the number of elections that are held.
