Chairman Landwehr called the meeting to order and recognized new committee members Representative Jack, Representative Mah, Representative Rhoades, Representative Winn and Representative Donohoe. The committee has expanded from 19 to 23 members.

The following staff members were also introduced: Norm Furse and Ken Wilke with the Revisor's Office, Kathie Sparks and Melissa Calderwood with the Legislative Research Office, and Debbie Bartuccio, Committee Assistant.

Chairman Landwehr asked if there were any bills to be introduced.

Representative Quigley made a motion to introduce HB 2447, which provides for a licensure category under the board of nursing of advanced practice registered nurse. The motion was seconded by Representative Flaherty. The motion carried.

Chairman Landwehr requested all committee members provide the e-mail address to be used for receiving electronic testimony for the electronic bill books.

Representative Schwab made a motion to introduce a bill concerning pharmacists giving flu shots and other immunizations. The bill is currently in a conceptual stage but needed to be introduced due to issues with Representative Schwab's schedule. The motion was seconded by Representative Crum. The motion carried.

After the motion carried, Chairman Landwehr informed the committee that, as a normal rule, we do not do conceptual bills, but under the circumstances it was acceptable.

Chairman Landwehr announced three scheduled roundtable discussions to be held on January 22, February 5 and February 12. The meetings will be in Room 711 and will begin at 9:30 a.m. The general discussions will be on health insurance, Medicaid, Medicare and private insurance in Kansas. Participants will include providers of these services. A subcommittee has been appointed with the following members: Representative Landwehr (Chair), Representative Crum, Representative Mast, Representative Shultz, Representative Neighbor, Representative Furtado, Representative Flaherty and Representative Jack.

The purpose of these meetings is to provide the committee with factual information concerning health care costs and to promote open, honest discussion about health issues, costs and problems.

Representative Landwehr requested all committee members to provide suggestions for the roundtable participants. There is no limit to the number attending, other than the size of the room.
