Sec. . Except as otherwise provided in this section, no state agency named in this or any other appropriation act of the 2012 regular session of the legislature shall expend moneys appropriated from the state general fund or from any special revenue fund or funds for fiscal years 2013 and 2014 as authorized by this or any other appropriation act of the 2012 regular session of the legislature, prior to January 1, 2014, to provide services through the home and community based waiver for individuals with developmental disabilities under any managed care system or any managed care oversight or any function that is determined to be a managed care oversight during fiscal year 2013 and the first six months of fiscal year 2014: Provided, that during fiscal year 2013 and the first six months of fiscal year 2014, any state agency named in this or any other appropriation act of the 2012 regular session of the legislature may expend monies appropriated from the state general fund or any special revenue fund or funds to develop and offer pilot programs for the demonstration, testing and evaluation of the delivery of services through the home and community based waiver for individuals with developmental disabilities under any managed care system or any managed care oversight or any function that is determined to be a managed care oversight; and Provided, that, on and after January 1, 2014, any state agency named in this or other appropriation act of the 2012 regular session of the legislature may expend moneys appropriated from the state general fund or from any special revenue fund or funds for the fiscal year ending June 30, 2014, as authorized by this or other appropriation act of the 2012 regular session of the legislature, to provide services through the home and community based waiver for individuals with developmental disabilities under any managed care system or any managed care oversight or any function that is determined to be a managed care oversight during the last six months of fiscal year 2014.
