USCIS has reduced TNCs and increased E-Verify accuracy by expanding the number of databases that E-Verify can query and instituting quality control procedures to screen for data entry errors. For example, as we testified in June 2008, USCIS implemented the Naturalization Phase I enhancement, which automatically checks USCIS naturalization databases before E-Verify issues an SSA TNC because of a citizenship status

mismatch. According to USCIS, this reduced the number of SSA TNCs for naturalized citizens by about 35 percent in fiscal year 2009.25 In addition to

²⁵ USCIS has also taken steps to help naturalized citizens better resolve TNCs. For example, in May 2008, USCIS developed a process to allow naturalized citizens to directly resolve their SSA TNCs with DHS. Almost 94 percent of employees who received an SSA TNC for a citizenship mismatch from October 2009 through August 31, 2010, have chosen to resolve their TNC by calling DHS. USCIS reported that 94 percent of employees who called USCIS after receiving an SSA TNC were determined to be work eligible.

what we reported in our June 2008 testimony, USCIS has undertaken three other initiatives to reduce the number of erroneous TNCs. Table 1 presents information on the nature and the results of these initiatives.

Initiative	Description	Results reported by USCIS*
Pre-TNC check	In September 2007, USCIS released an enhancement to E-Verify that automatically requires employers to double check their entry of employee information into E-Verify if the system determines that the employee is not work authorized.	Reduced TNCs by 36 percent from October 2007 to August 2010.
Passport data	In December 2008, USCIS and the State Department signed an MOU to reduce SSA mismatches because of citizenship status for employees who present their U.S. passports as evidence of employment eligibility. If employees present their passport as identification for the Form I-9, E-Verify will automatically check their passports against passport records to determine citizenship status. USCIS began using passport data to reduce citizenship mismatches in February 2009.	Prevented about 65,426 erroneous TNCs from occurring from February 2009 through August 2010.
Record matching initiative	In December 2009, USCIS added a quality control capability that enables E-Verify to recognize European date format and common clerical errors of transposed visa and passport numbers.	Prevented about 1,914 erroneous TNCs from occurring from December 2009 through August 2010.

*We reviewed USCIS's E-Verify transaction database from which USCIS generated these statistics and found the data sufficiently reliable for reporting purposes.

USCIS and SSA have taken additional actions to try to increase the accuracy of the E-Verify system. For example:

- In fiscal year 2009, working with USCIS, SSA added language to USCIS's A Guide to Naturalization, a booklet that is given to individuals at the naturalization ceremony, to emphasize the importance of visiting the local SSA office to report a change in citizenship status. Among other things, the booklet notes the importance of updating citizenship status for employment authorization purposes, as well as updating any name changes.²⁶
- DHS is in the planning stages of developing a data-sharing initiative, called DHS Autocards, to update SSA's Numident database with information from DHS databases on foreign-born individuals who change citizenship status. Through DHS Autocards, it is anticipated that USCIS will

The Case for Voter II

n Thursday, the Wisconsin legislature sent a bill requiring photographic identification for voting to Gov. Scott Walker's, lesk. This follows the enactment of m even stricter law in Kansas a few veeks ago.

Drafted by my office, Kansas's Seure and Fair Elections Act commed three elements: (1) a requirement that voters present photo Ds when they vote in person; (2) a requirement that absentee voters present a full driver's license number and have their signatures verified:


foul. They argued that voter fraud isn't significant enough to warrant such steps, that large numbers of Americans don't possess photo IDs, and that such laws will depress turnout among the poor and among minorities. They are wrong on all three counts.

reality in American elections. To offer a few examples, a 2010 state representative race in Kansas City, Mowas stolen when one candidate, J.J. Rizzo, allegedly received more than 50 votes illegally cast by citizens of Somalia. The Somalis, who didn't speak English, were coached to vote for Mr. Rizzo by an interpreter at the polling place. The margin of victory? One vote.

In Kansas, 221 incidents of voter fraud were reported between 1997 and 2010. The crimes included absentee-ballot fraud, impersonation of another voter, and a host of other violations. Because voter fraud is extremely difficult to detect and is usually not reported, the cases that we know about likely represent a small fraction of the total.

My office already has found 67 aliens illegally registered to vote in Kansas, but when the total number is calculated, it will likely be in the hundreds. In Colorado, the Secretary of State's office recently identified 11,805 aliens illegally registered to vote in the state, of whom 4,947 cast a ballot in the 2010 elections.

Evidence of voter fraud is present in all 50 states, and public confidence in the integrity of elections is at an all-time low. In the Cooperative Congressional Election Study of 2008, 62% of American voters thought that voter fraud was very



Fear that elections are being stolen erodes the legitimacy of our government. That's why the vast majority of Americans support laws like Kansas's Secure and Fair Elections Act, A 2010 Rasmussen poll showed that 82% of Americans support photo ID laws. Similarly, a 2011 Survey USA poll of Kansas voters showed that 83% support proof-ofcitizenship requirements for voter registration.

Critics of these laws nevertheless make outrageous arguments against them. New York University's Brennan Center, which stridently opposes all photo ID laws, claims that a whopping 11% of the American voting-age public—that means tens of millions of people—don't possess a photo ID. It bases this number on a survey it conducted in 2006.

However, we don't have to rely on implausible estimates when the

actual numbers are readily available. In Kansas, my office obtained the statistics, and they tell a very different story. According to the 2010 census, there are 2,126,179 Kansans of voting age. According to the Kansas Department of Motor Vehicles, 2,156,446 Kansans already have a driver's license or a non-driver ID. In other words, there are more photo IDs in circulation than there are eligible voters. The notion that there are hundreds of thousands of voters in Kansas (or any other state) without IDs is a myth.

Carrying a photo ID has become a part of American life. You can't cash a check, board a plane, or even buy full-strength Sudafed over the counter without one. That's why it's not unreasonable to require one in order to protect our most important privilege of citizenship. But just in case any person lacks a photo ID, Kan-

sas's law provides a free state ID to anyone who needs one. Other states have included similar provisions in their photo-ID laws.

If election security laws really were part of a Republican scheme to suppress Democratic votes, one would expect Democrats to fight such laws, tooth and nail. That didn't happen in Kansas, where two-thirds of the Democrats in the House and three-fourths of the Democrats in the Secure and Fair Elections Act. They did so because they realize that fair elections protect every voter and every party equally.

No candidate, Republican or Democrat, wants to emerge from ar election with voters suspecting that he didn't really win. Election security measures like the one in my state give confidence to voters and candidates alike that the system is fair.
