My name is Desima Dawdy and I am testifying in support of the Livestock and Ag Community HB 2712.

I was born and raised in Dodge City as was my father, who invested and participated in cattle ranching and sponsorship of the rodeo. My cousin, Doyle Heft, served Kansas as State Branding Inspector. My Mother's family has strong ties to both the XIT Ranch, and the ranching community in Greensburg.. My Grandmother, who was a County Treasury, invested in oil and ranching. My father-in-law was Head of Fisheries for the Fish and Game Commission. My family beats the heart of Kansas.

Growing up in Dodge, I would often complain about the feedlot aroma, and my Dad would always smile and say he loved the smell because that was the smell of money, and how true that statement was. My father's generation understood a hard days work, sweat equity, and the value of a dollar. My Dad, like many other fathers, wanted to use his hard earned money to give his daughters an education and a more comfortable life. Gratefully I joined the exodus out of Dodge, as did most of my peers, who primarily settled in Wichita, Topeka, and Kansas CIty, or out of state, after college.

During frequent visits back to Dodge, I remember discussions about the financial benefits of feedlots and processing centers being centrally located, and was excited to see Dodge building and growing, in stark contrast to other similar towns. I remember when the call went out for workers and the jobs remained vacant. The economy was good, and everyone wanted steak, but no one wanted the dirty work of killing the cow. I remember when the Vietnamese immigrants came to town then packed up and left because their frames were physically unable to do breaking work. I remember how the Latino community rode in and saved the industry with sweat and determination, seeking a better life for their families, just like my father had. I remember reading and hearing how my childhood neighbor and friend of the family, Pat George, brought Dodge in at the lowest unemployment rate in the state, while boasting one of the highest minority percentages, during a time when other communities were tanking.

Now as a business owner in both Topeka and Lawrence, I fully understand the need for a strong responsible workforce that is willing and ready to work. During a recent remodeling, I had difficulty finding workers who were willing to work nights and weekends so my business could continue to operate during the remodel. Local workers on "lay off" wanted paid cash, which I refused, Many skilled workers did not want to work inconvenient hours, during the Cheif's game, or when the weather was good, or bad. A local master carpenter did shoddy workmanship. I ended up having most of the work done from a subcontractor from Kansas City. All you have to do is read the Sunday Capital Journal Classified Ads and equate the big color ads mean that certain industries are competitively seeking HARD WORKING INDIVIDUALS. They are giving bonuses. They need workers. A young man I advocate for graduated from high school, college, and dentistry school in the U.S. and now we FAIL OUR STATE AND CITIZENS by refusing to extend him a visa to adjust his status to practice dentistry in western Kansas. I also advocate for a college valedictorian with a chemical engineering degree, who also graduated in the U.S. and now our government won't extend her a visa to work in Kansas, while having no problem pouring thousands of taxpayers dollars to try to create a workforce while one is right under our noses.

Legislators need to wake-up and look at the stark reality that a lot of the unemployed are unemployable. They have drug issues, lack education, skills, physical stamina, or have a poor work ethic, or a poorer attitude. As long as it is easier to collect a welfare check, than to bust your tail, we will always have job openings. And for the unemployed that would like to work, you also might want to consider how other states are offering unemployed workers the opportunity to take a "lessor paying job" especially with benefits, and making up the difference, because if you pay them more to stay home than to work, many can't afford to work. On the other hand, in specialized high demand fields such as my business, we can't find qualified applicants. If I can not find a U.S. citizen to work for me, then I should be able to recruit elsewhere without outlandish fees, or miles of red tape. The only thing that prevents many industries from growth is BIG C

of prosperity. Please don't lecture me about a "living wage", I pay quality standard minimum wage, and if you think it should be higher, I am not st

so quit blaming businesses owners for the failure of government. You also might want to factor in the expense it takes to own a business, especially after paying taxes and overhead and then see how much is really left on the plate at the end of the day.

I am even more appalled that out of one side of their mouths, politicians decry "BIG GOVERNMENT" but continue to hamstring businesses by refusing to help resolve work shortage issues facing certain industries. Prior to 1996 most status adjustments could be done within the U.S. by paying a \$1000 fine.
