HOUSE OF REPRESENTATIVES

MR. CHAIRMAN:

I move to amend Substitute for **HB 2340**, on page 4, following line 42 by inserting the following:

"Sec. 3. K.S.A. 2010 Supp. 74-8734 is hereby amended to read as follows: 74-8734. (a) The Kansas lottery may operate one lottery gaming facility in each gaming zone.

(b) Not more than 30 days after the effective date of this act the lottery commission shall adopt and publish in the Kansas register the procedure for receiving, considering and approving, proposed lottery gaming facility management contracts. Such procedure shall include provisions for review of competitive proposals within a gaming zone and the date by which proposed lottery gaming facility management contracts must be received by the lottery commission if they are to receive consideration.

(c) The lottery commission shall adopt standards to promote the integrity of the gaming and finances of lottery gaming facilities, which shall apply to all management contracts, shall meet or exceed industry standards for monitoring and controlling the gaming and finances of gaming facilities and shall give the executive director sufficient authority to monitor and control the gaming operation and to ensure its integrity and security.

(d) The Kansas lottery commission may approve management contracts with one or more prospective lottery gaming facility managers to manage, or construct and manage, on behalf of the state of Kansas and subject to the operational control of the Kansas lottery, a lottery gaming facility or lottery gaming enterprise at specified destination locations within the northeast, south central, southwest and southeast Kansas gaming zones where the commission determines the operation of such

1 facility would promote tourism and economic development. The commission shall approve or
2 disapprove a proposed management contract within 90 days after the deadline for receipt of proposals
3 established pursuant to subsection (b).

4 (e) In determining whether to approve a management contract with a prospective lottery
5 gaming facility manager to manage a lottery gaming facility or lottery gaming enterprise pursuant to
6 this section, the commission shall take into consideration the following factors: The size of the
7 proposed facility; the geographic area in which such facility is to be located; the proposed facility's
8 location as a tourist and entertainment destination; the estimated number of tourists that would be
9 attracted by the proposed facility; the number and type of lottery facility games to be operated at the
10 proposed facility; and agreements related to ancillary lottery gaming facility operations.

11 (f) Subject to the requirements of this section, the commission shall approve at least one
12 proposed lottery gaming facility management contract for a lottery gaming facility in each gaming
13 zone.

14 (g) The commission shall not approve a management contract unless:

15 (1) (A) The prospective lottery gaming facility manager is a resident Kansas American Indian
16 tribe and, at a minimum: (i) Has sufficient access to financial resources to support the activities
17 required of a lottery gaming facility manager under the Kansas expanded lottery act; and (ii) has three
18 consecutive years' experience in the management of gaming which would be class III gaming, as
19 defined in K.S.A. 46-2301, and amendments thereto, operated pursuant to state or federal law; or

20 (B) the prospective lottery gaming facility manager is not a resident Kansas American Indian
21 tribe and, at a minimum: (i) Has sufficient access to financial resources to support the activities
22 required of a lottery gaming facility manager under the Kansas expanded lottery act; (ii) is current in
23 filing all applicable tax returns and in payment of all taxes, interest and penalties owed to the state of
24 Kansas and any taxing subdivision where such prospective manager is located in the state of Kansas,

1 excluding items under formal appeal pursuant to applicable statutes; and (iii) has three consecutive
2 years' experience in the management of gaming which would be class III gaming, as defined in K.S.A.
3 46-2301, and amendments thereto, operated pursuant to state or federal law; and

4 (2) the commission determines that the proposed development consists of an investment in
5 infrastructure, including ancillary lottery gaming facility operations, of at least \$225,000,000 in the
6 northeast, ~~southeast~~ and south central Kansas gaming zones ~~and~~, of at least \$100,000,000 in the
7 southeast Kansas gaming zone and of at least \$50,000,000 in the southwest Kansas gaming zone. The
8 commission, in determining whether the minimum investment required by this subsection is met, shall
9 not include any amounts derived from or financed by state or local retailers' sales tax revenues.

10 (h) Any management contract approved by the commission under this section shall:

11 (1) Have a maximum initial term of 15 years from the date of opening of the lottery gaming
12 facility. At the end of the initial term, the contract may be renewed by mutual consent of the state and
13 the lottery gaming facility manager;

14 (2) specify the total amount to be paid to the lottery gaming facility manager pursuant to the
15 contract;

16 (3) establish a mechanism to facilitate payment of lottery gaming facility expenses, payment
17 of the lottery gaming facility manager's share of the lottery gaming facility revenues and distribution of
18 the state's share of the lottery gaming facility revenues;

19 (4) include a provision for the lottery gaming facility manager to pay the costs of oversight
20 and regulation of the lottery gaming facility manager and the operations of the lottery gaming facility
21 by the Kansas racing and gaming commission and the Kansas lottery;

22 (5) establish the types of lottery facility games to be installed in such facility;

23 (6) provide for the prospective lottery gaming facility manager, upon approval of the proposed
24 lottery gaming facility management contract, to pay to the state treasurer a nonrefundable privilege fee,

1 except as provided in K.S.A. 2010 Supp. 74-8738, and amendments thereto, and except in
2 circumstances when a lottery facility management contract is disapproved by either the lottery gaming
3 facility review board or the Kansas racing and gaming commission pursuant to K.S.A. 2010 Supp. 74-
4 8736, and amendments thereto of: (A) \$25,000,000 for the privilege of being selected as a lottery
5 gaming facility manager of a lottery gaming facility in the northeast, ~~southeast~~ or south central Kansas
6 gaming zone and; (B) \$11,000,000 for the privilege of being selected as a lottery gaming facility
7 manager of a lottery gaming facility in the southeast Kansas gaming zone; and (C) \$5,500,000 for the
8 privilege of being selected as a lottery gaming facility manager of a lottery gaming facility in the
9 southwest Kansas gaming zone. Such fee shall be deposited in the state treasury and credited to the
10 lottery gaming facility manager fund, which is hereby created in the state treasury;

11 (7) incorporate terms and conditions for the ancillary lottery gaming facility operations;

12 (8) designate as key employees, subject to approval of the executive director, any employees
13 or contractors providing services or functions which are related to lottery facility games authorized by a
14 management contract;

15 (9) include financing commitments for construction;

16 (10) include a resolution of endorsement from the city governing body, if the proposed facility
17 is within the corporate limits of a city, or from the county commission, if the proposed facility is
18 located in the unincorporated area of the county;

19 (11) include a requirement that any parimutuel licensee developing a lottery gaming facility
20 pursuant to this act comply with all orders and rules and regulations of the Kansas racing and gaming
21 commission with regard to the conduct of live racing, including the same minimum days of racing as
22 specified in K.S.A. 2010 Supp. 74-8746, and amendments thereto, for operation of electronic gaming
23 machines at racetrack gaming facilities;

24 (12) include a provision for the state to receive not less than 22% of lottery gaming facility

1 revenues, which shall be paid to the expanded lottery act revenues fund established by K.S.A. 2010
2 Supp. 74-8768, and amendments thereto;

3 (13) include a provision for ~~2%~~ 1% of lottery gaming facility revenues to be paid to the
4 problem gambling and addictions grant fund established by K.S.A. 2010 Supp. 79-4805, and
5 amendments thereto;

6 (14) include a provision for 1% of lottery gaming facility revenues to be paid to the Kansas
7 department of wildlife, parks and tourism for purposes of promoting tourism in Kansas;

8 ~~(14)~~ (15) if the prospective lottery gaming facility manager is an American Indian tribe,
9 include a provision that such tribe agrees to waive its sovereign immunity with respect to any actions
10 arising from or to enforce either the Kansas expanded lottery act or any provision of the lottery gaming
11 facility management contract; any action brought by an injured patron or by the state of Kansas; any
12 action for purposes of enforcing the workers compensation act or any other employment or labor law;
13 and any action to enforce laws, rules and regulations and codes pertaining to health, safety and
14 consumer protection; and for any other purpose deemed necessary by the executive director to protect
15 patrons or employees and promote fair competition between the tribe and others seeking a lottery
16 gaming facility management contract;

17 ~~(15)~~ (16) (A) if the lottery gaming facility is located in the northeast or southwest Kansas
18 gaming zone and is not located within a city, include a provision for payment of an amount equal to 3%
19 of the lottery gaming facility revenues to the county in which the lottery gaming facility is located; or
20 (B) if the lottery gaming facility is located in the northeast or southwest Kansas gaming zone and is
21 located within a city, include provision for payment of an amount equal to 1.5% of the lottery gaming
22 facility revenues to the city in which the lottery gaming facility is located and an amount equal to 1.5%
23 of such revenues to the county in which such facility is located;

24 ~~(16)~~ (17) (A) if the lottery gaming facility is located in the southeast or south central Kansas

1 gaming zone and is not located within a city, include a provision for payment of an amount equal to 2%
2 of the lottery gaming facility revenues to the county in which the lottery gaming facility is located and
3 an amount equal to 1% of such revenues to the other county in such zone; or (B) if the lottery gaming
4 facility is located in the southeast or south central Kansas gaming zone and is located within a city,
5 provide for payment of an amount equal to 1% of the lottery gaming facility revenues to the city in
6 which the lottery gaming facility is located, an amount equal to 1% of such revenues to the county in
7 which such facility is located and an amount equal to 1% of such revenues to the other county in such
8 zone;

9 ~~(17)~~(18) allow the lottery gaming facility manager to manage the lottery gaming facility in a
10 manner consistent with this act and applicable law, but shall place full, complete and ultimate
11 ownership and operational control of the gaming operation of the lottery gaming facility with the
12 Kansas lottery. The Kansas lottery shall not delegate and shall explicitly retain the power to overrule
13 any action of the lottery gaming facility manager affecting the gaming operation without prior notice.
14 The Kansas lottery shall retain full control over all decisions concerning lottery gaming facility games;

15 ~~(18)~~(19) include provisions for the Kansas racing and gaming commission to oversee all
16 lottery gaming facility operations, including, but not limited to: Oversight of internal controls;
17 oversight of security of facilities; performance of background investigations, determination of
18 qualifications and credentialing of employees, contractors and agents of the lottery gaming facility
19 manager and of ancillary lottery gaming facility operations, as determined by the Kansas racing and
20 gaming commission; auditing of lottery gaming facility revenues; enforcement of all state laws and
21 maintenance of the integrity of gaming operations; and

22 ~~(19)~~(20) include enforceable provisions: (A) Prohibiting the state, until July 1, 2032, from (i)
23 entering into management contracts for more than four lottery gaming facilities or similar gaming
24 facilities, one to be located in the northeast Kansas gaming zone, one to be located in the south central

1 Kansas gaming zone, one to be located in the southwest Kansas gaming zone and one to be located in
2 the southeast Kansas gaming zone, (ii) designating additional areas of the state where operation of
3 lottery gaming facilities or similar gaming facilities would be authorized or (iii) operating an aggregate
4 of more than 2,800 electronic gaming machines at all parimutuel licensee locations; and (B) requiring
5 the state to repay to the lottery gaming facility manager an amount equal to the privilege fee paid by
6 such lottery gaming facility manager, plus interest on such amount, compounded annually at the rate of
7 10%, if the state violates the prohibition provision described in (A).

8 (i) The power of eminent domain shall not be used to acquire any interest in real property for
9 use in a lottery gaming enterprise.

10 (j) Any proposed management contract for which the privilege fee has not been paid to the
11 state treasurer within 30 days after the date of approval of the management contract shall be null and
12 void.

13 (k) A person who is the manager of the racetrack gaming facility in a gaming zone shall not
14 be eligible to be the manager of the lottery gaming facility in the same zone.

15 (l) Management contracts authorized by this section may include provisions relating to:

16 (1) Accounting procedures to determine the lottery gaming facility revenues, unclaimed prizes
17 and credits;

18 (2) minimum requirements for a lottery gaming facility manager to provide qualified
19 oversight, security and supervision of the lottery facility games including the use of qualified personnel
20 with experience in applicable technology;

21 (3) eligibility requirements for employees, contractors or agents of a lottery gaming facility
22 manager who will have responsibility for or involvement with actual gaming activities or for the
23 handling of cash or tokens;

24 (4) background investigations to be performed by the Kansas racing and gaming commission;

1 (5) credentialing requirements for any employee, contractor or agent of the lottery gaming
2 facility manager or of any ancillary lottery gaming facility operation as provided by the Kansas
3 expanded lottery act or rules and regulations adopted pursuant thereto;

4 (6) provision for termination of the management contract by either party for cause; and

5 (7) any other provision deemed necessary by the parties, including such other terms and
6 restrictions as necessary to conduct any lottery facility game in a legal and fair manner.

7 (m) A management contract shall not constitute property, nor shall it be subject to attachment,
8 garnishment or execution, nor shall it be alienable or transferable, except upon approval by the
9 executive director, nor shall it be subject to being encumbered or hypothecated. The trustee of any
10 insolvent or bankrupt lottery gaming facility manager may continue to operate pursuant to the
11 management contract under order of the appropriate court for no longer than one year after the
12 bankruptcy or insolvency of such manager.

13 (n) (1) The Kansas lottery shall be the licensee and owner of all software programs used at a
14 lottery gaming facility for any lottery facility game.

15 (2) A lottery gaming facility manager, on behalf of the state, shall purchase or lease for the
16 Kansas lottery all lottery facility games. All lottery facility games shall be subject to the ultimate
17 control of the Kansas lottery in accordance with this act.

18 (o) A lottery gaming facility shall comply with any planning and zoning regulations of the city
19 or county in which it is to be located. The executive director shall not contract with any prospective
20 lottery gaming facility manager for the operation and management of such lottery gaming facility
21 unless such manager first receives any necessary approval under planning and zoning requirements of
22 the city or county in which it is to be located.

23 (p) Prior to expiration of the term of a lottery gaming facility management contract, the lottery
24 commission may negotiate a new lottery gaming facility management contract with the lottery gaming

1 facility manager if the new contract is substantially the same as the existing contract. Otherwise, the
2 lottery gaming facility review board shall be reconstituted and a new lottery gaming facility
3 management contract shall be negotiated and approved in the manner provided by this act.

4 Sec. 4. K.S.A. 2010 Supp. 74-8741 is hereby amended to read as follows: 74-8741. (a) The
5 executive director of the Kansas lottery shall negotiate a racetrack gaming facility management
6 contract to place electronic gaming machines at one parimutuel licensee location in each gaming zone
7 except the southwest Kansas gaming zone.

8 (b) To be eligible to enter into a racetrack gaming facility management contract the
9 prospective racetrack gaming facility manager shall, at a minimum:

10 (1) Have sufficient access to financial resources to support the activities required of a
11 racetrack gaming facility manager under the Kansas expanded lottery act; and

12 (2) be current in filing all applicable tax returns and in payment of all taxes, interest and
13 penalties owed to the state of Kansas and any taxing subdivision where such prospective manager is
14 located in the state of Kansas, excluding items under formal appeal pursuant to applicable statutes.

15 (c) A racetrack gaming facility management contract shall include:

16 (1) The term of the contract;

17 (2) provisions for the Kansas racing and gaming commission to oversee all racetrack gaming
18 facility operations, including, but not limited to: Oversight of internal controls; oversight of security of
19 facilities; performance of background investigations, determination of qualifications and any required
20 certification or licensing of officers, directors, board members, employees, contractors and agents of
21 the racetrack gaming facility manager; auditing of net electronic gaming machine income and
22 maintenance of the integrity of electronic gaming machine operations;

23 (3) provisions for the racetrack gaming facility manager to pay the costs of oversight and
24 regulation of the racetrack gaming facility manager under this act and such manager's racetrack gaming

1 facility operations by the Kansas racing and gaming commission and the Kansas lottery; ~~and~~

2 (4) enforceable provisions: (A) Prohibiting the state, until July 1, 2032, from (i) entering into
3 management contracts for more than ~~three~~ four lottery gaming facilities or similar gaming facilities,
4 one to be located in the northeast Kansas gaming zone, one to be located in the south central Kansas
5 gaming zone ~~and~~, one to be located in the southeast Kansas gaming zone and one to be located in the

15 (d) Racetrack gaming facility management contracts authorized by this section may include
16 provisions relating to:

17 (1) Accounting procedures to determine net electronic gaming machine income, unclaimed
18 prizes and credits;

19 (2) minimum requirements for a racetrack gaming facility manager to provide qualified
20 oversight, security and supervision of electronic gaming machines including the use of qualified
21 personnel with experience in applicable technology;

22 (3) eligibility requirements for employees, contractors or agents of a racetrack gaming facility
23 manager who will have responsibility for or involvement with electronic gaming machines or for the
24 handling of cash or tokens;

1 (4) background investigations to be performed by the Kansas racing and gaming commission;

2 (5) credentialing or certification requirements of any employee, contractor or agent as
3 provided by the Kansas expanded lottery act or rules and regulations adopted pursuant thereto;

4 (6) provision for termination of the management contract by either party for cause; and

5 (7) any other provision deemed necessary by the parties, including such other terms and
6 restrictions as necessary to conduct racetrack gaming facility operations in a legal and fair manner.

7 (e) A person who is the manager of a lottery gaming facility in a gaming zone shall not be
8 eligible to be the manager of the racetrack gaming facility in the same zone.

9 (f) A racetrack gaming facility management contract shall not constitute property, nor shall it
10 be subject to attachment, garnishment or execution, nor shall it be alienable or transferable, except
11 upon approval by the executive director, nor shall it be subject to being encumbered or hypothecated.

12 Sec. 5. K.S.A. 2010 Supp. 74-8744 is hereby amended to read as follows: 74-8744. (a) In
13 accordance with rules and regulations adopted by the commission, the executive director shall have
14 general responsibility for the implementation and administration of the provisions of this act relating to
15 racetrack gaming facility operations, including the responsibility to:

16 (1) Certify net electronic gaming machine income by inspecting records, conducting audits,
17 having agents of the Kansas lottery on site or by any other reasonable means; and

18 (2) assist the commission in the promulgation of rules and regulations concerning the
19 operation of racetrack gaming facilities, which rules and regulations shall include, without limitation,
20 the following:

21 (A) The number of electronic gaming machines allocated for placement at each racetrack
22 gaming facility, subject to the provisions of subsection (b);

23 (B) standards for advertising, marketing and promotional materials used by racetrack gaming
24 facility managers;

1 (C) the kind, type, number and location of electronic gaming machines at any racetrack
2 gaming facility; and

3 (D) rules and regulations and procedures for the accounting and reporting of the payments
4 required from racetrack gaming facility managers under K.S.A. 2010 Supp. 74-8766, and amendments
5 thereto, including the calculations required for such payments.

6 (b) Rules and regulations establishing the minimum and maximum number of electronic
7 gaming machines allocated for placement at each racetrack gaming facility shall be adopted and
8 published not later than 120 days after the effective date of this act. Such rules and regulations shall be
9 subject to the following:

10 (1) At least 600, but not more than 1,200, electronic gaming machines shall be allocated to
11 and placed at each racetrack gaming facility.

12 (2) The total number of electronic gaming machines allocated to and placed at all racetrack
13 gaming facilities in the state shall not exceed 2,800. ~~Until lottery gaming facility management contracts
14 for lottery gaming facilities in all gaming zones become binding, the total number of electronic gaming
15 machines placed at all racetrack gaming facilities shall not exceed 2,200. When lottery gaming facility
16 management contracts for lottery gaming facilities in all gaming zones have become binding, the
17 lottery commission shall take privilege fee bids from the lottery gaming facility manager and racetrack
18 gaming facility manager in each gaming zone for the remaining electronic gaming machines allocated
19 to but not yet placed at the racetrack gaming facility in such zone. The minimum bid shall be a
20 privilege fee of \$2,500 per electronic gaming machine. If the racetrack gaming facility manager
21 submits the highest bid, the lottery commission shall place the remaining electronic gaming machines
22 at the racetrack gaming facility. If the lottery gaming facility manager submits the highest bid, the
23 commission shall not place any additional electronic gaming machines at the racetrack gaming facility.~~

24 (3) ~~In addition to any privilege fee paid pursuant to paragraph (2);~~ Each racetrack gaming

1 facility manager shall pay a privilege fee of \$2,500 for each electronic gaming machine placed at the
2 racetrack gaming facility ~~for which a privilege fee is not paid pursuant to paragraph (2).~~

3 (4) The racetrack gaming facility manager shall pay the privilege fees provided by this
4 subsection to the executive director, who shall remit the entire amount to the state treasurer in
5 accordance with K.S.A. 75-4215, and amendments thereto. Upon receipt of the remittance, the state
6 treasurer shall deposit the entire amount in the state treasury and credit it to the expanded lottery act
7 revenues fund.

8 Sec. 6. K.S.A. 2010 Supp. 74-8747 is hereby amended to read as follows: 74-8747. (a) Net
9 electronic gaming machine income from a racetrack gaming facility located in the southeast Kansas
10 gaming zone shall be distributed as follows:

11 (1) To the racetrack gaming facility manager, an amount equal to ~~25%~~ not more than 58% of
12 net electronic gaming machine income;

12 of the racetrack gaming facility revenues net electronic gaming machine income to the county in which
13 the racetrack gaming facility is located and an amount equal to 1% of such revenues income to the
14 other county in such zone; or (B) if the racetrack gaming facility is located in the southeast or south
15 central Kansas gaming zone and is located within a city, provide for payment of an amount equal to 1%
16 of the racetrack gaming facility revenues net electronic gaming machine income to the city in which the
17 racetrack gaming facility is located, an amount equal to 1% of such revenues income to the county in
18 which such facility is located and an amount equal to 1% of such revenues income to the other county
19 in such zone;

20 (6) (5) 2% 1% of net electronic gaming machine income shall be credited to the problem
21 gambling and addictions grant fund established by K.S.A. 2010 Supp. 79-4805, and amendments
22 thereto;

23 (6) 1% of lottery gaming facility revenues to be paid to the Kansas department of wildlife,
24 parks and tourism for purposes of promoting tourism in Kansas;

1 (7) 1% of net electronic gaming machine income shall be credited to the Kansas horse fair
2 racing benefit fund established by K.S.A. 74-8838, and amendments thereto; and

3 (8) ~~40%~~ not less than 22% of net electronic gaming machine income shall be credited to the
4 expanded lottery act revenues fund; ~~and.~~

14 person convicted of any felony, a crime involving gambling or a crime of moral turpitude prior to
15 applying for a certificate hereunder or at any time thereafter shall be deemed unfit. If the executive

17 comprehensive, thorough and provide similar adequate safeguards, the executive director may certify
18 an applicant already certified in such state without the necessity of a full application and background
