1 AN ACT relating to motor vehicles; concerning the registration of fleet
2 motor vehicles; amending K.S.A. 2010 Supp. 8-1,152 and repealing
3 the existing section.

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. K.S.A. 2010 Supp. 8-1,152 is hereby amended to read as
7 follows: 8-1,152. (a) As used in this section, "fleet motor vehicle" means
8 any motor vehicle of a commercial fleet of 250 or more motor vehicles
9 ~~which is exempt from personal property tax or assessed under the~~
10 ~~provisions of K.S.A. 79-6a01 et seq., and amendments thereto~~ and which
11 is registered for a gross weight of at least 12,000 pounds but not more
12 than 26,000 pounds, except that if a vehicle is registered for a gross
13 weight of more than 26,000 pounds and is part of a commercial fleet, and
14 such vehicle is not driven out-of-state, such vehicle shall be deemed a
15 fleet motor vehicle for purposes of this section.

16 ~~(b) Upon the payment of the applicable registration fees under~~
17 ~~K.S.A. 8-143, and amendments thereto,~~ The division shall provide for the
18 registration of and the issuance of license plates for fleet motor vehicles
19 in accordance with the provisions of this section. *Fleet motor vehicles*
20 *registered under the provisions of this section shall annually pay the*
21 *applicable registration fees under K.S.A. 8-143, and amendments thereto.*
22 *Upon registration, the owner of the fleet motor vehicles who are not*
23 *exempt from personal property taxes, shall provide evidence of the taxes*
24 *assessed under K.S.A. 79-6a01 et seq., or 79-5101 et seq., and*
25 *amendments thereto.* License plates issued under this section shall be
26 permanent in nature and designed in such a manner as to remain with the
27 fleet motor vehicle for the duration of the life span of the fleet motor
28 vehicle or until the fleet motor vehicle is deleted from the owner's fleet.
29 Such license plates shall be distinctive and there shall be no year date
30 thereon. Fleet motor vehicles registered under the provisions of this
31 section shall be issued a permanent registration cab card for the duration
32 of the life span of the fleet motor vehicle or until the fleet motor vehicle
33 is deleted from the owner's fleet. License plates issued under this section
34 shall not be transferable to any other fleet motor vehicle, except that the
35 unused registration fee may be transferred to another fleet motor vehicle
36 which is registered at the same or greater weight. The data required for

1 registration under this section shall be submitted electronically.

2 (c) The secretary of revenue may adopt rules and regulations in
3 order to administer the provisions of this section.

4 Sec. 2. K.S.A. 2010 Supp. 8-1,152 is hereby repealed.

5 Sec. 3. This act shall take effect and be in force from and after its
6 publication in the Kansas register.
