1 AN ACT concerning abortion; regarding certain prohibitions on late-term  
2 and partial birth abortion; amending K.S.A. 65-445, 65-6701, 65-6703,  
3 65-6705 and 65-6721 and K.S.A. 2010 Supp. 65-6709 and 65-6710 and  
4 repealing the existing sections; also repealing K.S.A. 65-6713.  
5

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. K.S.A. 65-445 is hereby amended to read as follows: 65-  
8 445. (a) Every medical care facility shall keep written records of all  
9 pregnancies which are lawfully terminated within such medical care  
10 facility and shall annually submit a written report thereon to the secretary  
11 of health and environment in the manner and form prescribed by the  
12 secretary. Every person licensed to practice medicine and surgery shall  
13 keep a record of all pregnancies which are lawfully terminated by such  
14 person in a location other than a medical care facility and shall annually  
15 submit a written report thereon to the secretary of health and environment  
16 in the manner and form prescribed by the secretary.

17 (b) Each report required by this section shall include the number of  
18 pregnancies terminated during the period of time covered by the report, the  
19 type of medical facility in which the pregnancy was terminated,  
20 information required to be reported under *subsections (b) and (c) of K.S.A.*  
21 *65-6703, subsection (j) of K.S.A. 65-6705 and subsection (c) of K.S.A. 65-*  
22 *6721, and amendments thereto, if applicable to the pregnancy terminated,*  
23 *and such other information as may be required by the secretary of health*  
24 *and environment, but the report shall not include the names of the persons*  
25 *whose pregnancies were so terminated. Each report required by*  
26 *subsections (b) and (c) of K.S.A. 65-6703, subsection (j) of K.S.A. 65-6705*  
27 *and subsection (c) of K.S.A. 65-6721, and amendments thereto, shall*

1 *specify the medical diagnosis and condition constituting a substantial and*  
2 *irreversible impairment of a major bodily function or the medical*  
3 *diagnosis and condition which necessitated performance of an abortion to*  
4 *preserve the life of the pregnant woman. Each report required by K.S.A.*  
5 *65-6703, and amendments thereto, shall include a sworn statement by the*  
6 *physician performing the abortion and the referring physician that such*  
7 *physicians are not legally or financially affiliated.*

8 (c) Information obtained by the secretary of health and environment  
9 under this section shall be confidential and shall not be disclosed in a  
10 manner that would reveal the identity of any person licensed to practice  
11 medicine and surgery who submits a report to the secretary under this  
12 section or the identity of any medical care facility which submits a report  
13 to the secretary under this section, except that such information, including  
14 information identifying such persons and facilities may be disclosed to the  
15 state board of healing arts upon request of the board for disciplinary action  
16 conducted by the board and may be disclosed to the attorney general *or*  
17 *any district or county attorney in this state* upon a showing that a  
18 reasonable cause exists to believe that a violation of this act has occurred.  
19 Any information disclosed to the state board of healing arts, ~~or~~ the attorney  
20 general *or any district or county attorney* pursuant to this subsection shall  
21 be used solely for the purposes of a disciplinary action or criminal  
22 proceeding. Except as otherwise provided in this subsection, information  
23 obtained by the secretary under this section may be used only for statistical  
24 purposes and such information shall not be released in a manner which  
25 would identify any county or other area of this state in which the  
26 termination of the pregnancy occurred. A violation of this subsection (c) is  
27 a class A nonperson misdemeanor.

28 (d) In addition to such criminal penalty under subsection (c), any  
29 person licensed to practice medicine and surgery or medical care facility  
30 whose identity is revealed in violation of this section may bring a civil  
31 action against the responsible person or persons for any damages to the  
32 person licensed to practice medicine and surgery or medical care facility  
33 caused by such violation.

34 (e) For the purpose of maintaining confidentiality as provided by  
35 subsections (c) and (d), reports of terminations of pregnancies required by  
36 this section shall identify the person or facility submitting such reports  
37 only by confidential code number assigned by the secretary of health and  
38 environment to such person or facility and the department of health and  
39 environment shall maintain such reports only by such number.

40 (f) *The annual public report on abortions performed in Kansas issued*  
41 *by the secretary of health and environment shall contain the information*  
42 *required to be reported by this section to the extent such information is not*  
43 *deemed confidential pursuant to this section. The secretary of health and*

1 *environment shall adopt rules and regulations to implement this section.*  
2 *Such rules and regulations shall prescribe, in detail, the information*  
3 *required to be kept by the physicians and hospitals and the information*  
4 *required in the reports which must be submitted to the secretary.*

5 (g) *The department of social and rehabilitation services shall prepare*  
6 *and publish an annual report on the number of reports of child sexual*  
7 *abuse received by the department from abortion providers. Such report*  
8 *shall be categorized by the age of the victim and the month the report was*  
9 *submitted to the department. The name of the victim and any other*  
10 *identifying information shall be kept confidential by the department and*  
11 *shall not be released as part of the public report.*

12 Sec. 2. K.S.A. 65-6701 is hereby amended to read as follows: 65-  
13 6701. As used in this act:

14 (a) "Abortion" means the use of any means to intentionally terminate  
15 a pregnancy except for the purpose of causing a live birth. Abortion does  
16 not include: (1) The use of any drug or device that inhibits or prevents  
17 ovulation, fertilization or the implantation of an embryo; or (2) disposition  
18 of the product of *in vitro* fertilization prior to implantation.

19 (b) "Counselor" means a person who is: (1) Licensed to practice  
20 medicine and surgery; (2) licensed to practice psychology; (3) licensed to  
21 practice professional or practical nursing; (4) registered to practice  
22 professional counseling; (5) licensed as a social worker; (6) the holder of a  
23 master's or doctor's degree from an accredited graduate school of social  
24 work; (7) registered to practice marriage and family therapy; (8) a licensed  
25 physician assistant; or (9) a currently ordained member of the clergy or  
26 religious authority of any religious denomination or society. Counselor  
27 does not include the physician who performs or induces the abortion or a  
28 physician or other person who assists in performing or inducing the  
29 abortion.

30 (c) "Department" means the department of health and environment.

31 (d) "Gestational age" means the time that has elapsed since the first  
32 day of the woman's last menstrual period.

33 (e) "Medical emergency" means that condition which, on the basis of  
34 the physician's good faith clinical judgment, so complicates the medical  
35 condition of a pregnant woman as to necessitate the immediate abortion of  
36 her pregnancy to avert her death or for which a delay will create serious  
37 risk of substantial and irreversible impairment of a major bodily function.

38 (f) "Minor" means a person less than 18 years of age.

39 (g) "Physician" means a person licensed to practice medicine and  
40 surgery in this state.

41 (h) "Pregnant" or "pregnancy" means that female reproductive  
42 condition of having a fetus ~~a fetus~~ *an unborn child* in the mother's body.

43 (i) "Qualified person" means an agent of the physician who is a

1 psychologist, licensed social worker, registered professional counselor,  
2 registered nurse or physician.

3 (j) "Unemancipated minor" means any minor who has never been: (1)  
4 Married; or (2) freed, by court order or otherwise, from the care, custody  
5 and control of the minor's parents.

6 (k) "~~Viable~~" means ~~that stage of gestation when, in the best medical~~  
7 ~~judgment of the attending physician, the fetus is capable of sustained~~  
8 ~~survival outside the uterus without the application of extraordinary~~  
9 ~~medical means: that stage of fetal development when it is the physician's~~  
10 ~~judgment according to accepted obstetrical or neonatal standards of care~~  
11 ~~and practice applied by physicians in the same or similar circumstances~~  
12 ~~that there is a reasonable probability that the life of the child can be~~  
13 ~~continued indefinitely outside the mother's womb with natural or artificial~~  
14 ~~life-supportive measures.~~

15 Sec. 3. K.S.A. 65-6703 is hereby amended to read as follows: 65-  
16 6703. (a) No person shall perform or induce an abortion when the ~~fetus~~  
17 ~~unborn child~~ is viable unless such person is a physician and has a  
18 documented referral from another physician not legally or financially  
19 affiliated with the physician performing or inducing the abortion and both  
20 physicians ~~determine~~ *provide a written determination, based upon a*  
21 *medical judgment arrived at using and exercising that degree of care, skill*  
22 *and proficiency commonly exercised by the ordinary skillful, careful and*  
23 *prudent physician in the same or similar circumstances and that would be*  
24 *made by a reasonably prudent physician, knowledgeable in the field, and*  
25 *knowledgeable about the case and the treatment possibilities with respect*  
26 *to the conditions involved, that: (1) The abortion is necessary to preserve*  
27 *the life of the pregnant woman; or (2) a continuation of the pregnancy will*  
28 *cause a substantial and irreversible impairment of a major bodily function*  
29 *of the pregnant woman.*

30 (b) *Except in the case of a medical emergency, a copy of the written*  
31 *documented referral and of the abortion-performing physician's written*  
32 *determination shall be provided to the pregnant woman no less than 30*  
33 *minutes prior to the initiation of the abortion. The written determination*  
34 *shall be time-stamped at the time it is delivered to the pregnant woman.*  
35 *The medical basis for the determination shall also be reported by the*  
36 *physician as part of the written report made by the physician to the*  
37 *secretary of health and environment under K.S.A. 65-445, and*  
38 *amendments thereto. Such determination shall specify:*

39 (1) *If the unborn child was determined to be nonviable and the*  
40 *medical basis of such determination;*

41 (2) *if the abortion is necessary to preserve the life of the pregnant*  
42 *woman and the medical basis of such determination, including the specific*  
43 *medical condition the physician believes would cause the death of the*

1 *pregnant woman; or*

2 (3) *if a continuation of the pregnancy will cause a substantial and*  
 3 *irreversible impairment of a major bodily function of the pregnant woman*  
 4 *and the medical basis of such determination, including the specific*  
 5 *medical condition the physician believes would constitute a substantial*  
 6 *and irreversible impairment of a major bodily function of the pregnant*  
 7 *woman.*

8 ~~(b)~~ (c) (1) Except in the case of a medical emergency, prior to  
 9 performing an abortion upon a woman, the physician shall determine the  
 10 gestational age of the ~~fetus~~ *unborn child* according to accepted obstetrical  
 11 and neonatal practice and standards applied by physicians in the same or  
 12 similar circumstances. If the physician determines the gestational age is  
 13 less than 22 weeks, the physician shall document as part of the medical  
 14 records of the woman the basis for the determination. *The medical basis*  
 15 *for the determination of the gestational age of the unborn child shall also*  
 16 *be reported by the physician as part of the written report made by the*  
 17 *physician to the secretary of health and environment under K.S.A. 65-445,*  
 18 *and amendments thereto.*

19 (2) If the physician determines the gestational age of the ~~fetus~~ *unborn*  
 20 *child* is 22 or more weeks, prior to performing an abortion upon the  
 21 woman the physician shall determine if the ~~fetus~~ *unborn child* is viable by  
 22 using and exercising that degree of care, skill and proficiency commonly  
 23 exercised by the ordinary skillful, careful and prudent physician in the  
 24 same or similar circumstances. In making this determination of viability,  
 25 the physician shall perform or cause to be performed such medical  
 26 examinations and tests as are necessary to make a finding of the  
 27 gestational age of the ~~fetus~~ *unborn child* and shall enter such findings and  
 28 determinations of viability in the medical record of the woman.

29 (3) If the physician determines the gestational age of a ~~fetus~~ *an*  
 30 *unborn child* is 22 or more weeks, and determines that the ~~fetus~~ *unborn*  
 31 *child* is not viable and performs an abortion on the woman, the physician  
 32 shall report such determinations, *the medical basis* and the reasons for  
 33 such determinations in writing to the medical care facility in which the  
 34 abortion is performed for inclusion in the report of the medical care  
 35 facility to the secretary of health and environment under K.S.A. 65-445,  
 36 and amendments thereto, or if the abortion is not performed in a medical  
 37 care facility, the physician shall report such determinations, *the medical*  
 38 *basis* and the reasons for such determinations in writing to the secretary of  
 39 health and environment as part of the written report made by the physician  
 40 to the secretary of health and environment under K.S.A. 65-445, and  
 41 amendments thereto.

42 (4) If the physician who is to perform the abortion determines the  
 43 gestational age of a ~~fetus~~ *an unborn child* is 22 or more weeks, and

1 determines that the ~~fetus~~ *unborn child* is viable, both physicians under  
2 subsection (a) determine in accordance with the provisions of subsection  
3 (a) that an abortion is necessary to preserve the life of the pregnant woman  
4 or that a continuation of the pregnancy will cause a substantial and  
5 irreversible impairment of a major bodily function of the pregnant woman  
6 and the physician performs an abortion on the woman, the physician who  
7 performs the abortion shall report such determinations, *the medical basis*  
8 *and the reasons for such determinations and the basis*, *including the*  
9 *specific medical diagnosis* for the determination that an abortion is  
10 necessary to preserve the life of the pregnant woman or that a continuation  
11 of the pregnancy will cause a substantial and irreversible impairment of a  
12 major bodily function of the pregnant woman *and the name of the*  
13 *referring physician required by subsection (a)* in writing to the medical  
14 care facility in which the abortion is performed for inclusion in the report  
15 of the medical care facility to the secretary of health and environment  
16 under K.S.A. 65-445, and amendments thereto, or if the abortion is not  
17 performed in a medical care facility, the physician who performs the  
18 abortion shall report such determinations, *the medical basis and*  
19 *the reasons for such determinations and the basis*, *including the specific*  
20 *medical diagnosis* for the determination that an abortion is necessary to  
21 preserve the life of the pregnant woman or that a continuation of a  
22 pregnancy will cause a substantial and irreversible impairment of a major  
23 bodily function of the pregnant woman *and the name of the referring*  
24 *physician required by subsection (a)* in writing to the secretary of health  
25 and environment as part of the written report made by the physician to the  
26 secretary of health and environment under K.S.A. 65-445, and  
27 amendments thereto.

28 (5) The physician shall retain the medical records required to be kept  
29 under paragraphs (1) and (2) of this subsection ~~(b)~~ (c) for not less than ~~five~~  
30 10 years and shall retain a copy of the written reports required under  
31 paragraphs (3) and (4) of this subsection ~~(b)~~ (c) for not less than ~~five~~ 10  
32 years.

33 (d) *The secretary of health and environment shall adopt rules and*  
34 *regulations to administer this section. Such rules and regulations shall*  
35 *include:*

36 (1) *A detailed list of the information that must be kept by a physician*  
37 *under paragraphs (1) and (2) of subsection (c);*

38 (2) *the contents of the written reports required under paragraphs (3)*  
39 *and (4) of subsection (c); and*

40 (3) *detailed specifications regarding information that must be*  
41 *provided by a physician in order to comply with the obligation to disclose*  
42 *the medical basis and specific medical diagnosis relied upon in*  
43 *determining that an abortion is necessary to preserve the life of the*

1 *pregnant woman or that a continuation of the pregnancy will cause a*  
2 *substantial and irreversible impairment of a major bodily function of the*  
3 *pregnant woman.*

4 (e) (e) A woman upon whom an abortion is performed shall not be  
5 prosecuted under this section for a conspiracy to violate this section  
6 pursuant to K.S.A. 21-3302, and amendments thereto.

7 (d) (f) Nothing in this section shall be construed to create a right to an  
8 abortion. Notwithstanding any provision of this section, a person shall not  
9 perform an abortion that is prohibited by law.

10 (g) (1) *A woman upon whom an abortion is performed in violation*  
11 *of this section, the father, if married to the woman at the time of the*  
12 *abortion, and the parents or custodial guardian of the woman, if the*  
13 *woman has not attained the age of 18 years at the time of the abortion,*  
14 *may in a civil action obtain appropriate relief, unless, in a case where the*  
15 *plaintiff is not the woman upon whom the abortion was performed, the*  
16 *pregnancy resulted from the plaintiff's criminal conduct.*

17 (2) *Such relief shall include:*

18 (A) *Money damages for all injuries, psychological and physical,*  
19 *occasioned by the violation of this section;*

20 (B) *statutory damages equal to three times the cost of the abortion;*  
21 *and*

22 (C) *reasonable attorney fees.*

23 (h) *The prosecution of violations of this section may be brought by*  
24 *the attorney general or by the district attorney or county attorney for the*  
25 *county where any violation of this section is alleged to have occurred.*

26 **(i) Nothing in this section shall be construed to restrict the**  
27 **authority of the board of healing arts to engage in a disciplinary**  
28 **action.**

29 ~~(e) As used in this section, "viable" means that stage of fetal~~  
30 ~~development when it is the physician's judgment according to accepted~~  
31 ~~obstetrical or neonatal standards of care and practice applied by physicians~~  
32 ~~in the same or similar circumstances that there is a reasonable probability~~  
33 ~~that the life of the child can be continued indefinitely outside the mother's~~  
34 ~~womb with natural or artificial life-supportive measures.~~

35 (f) (i) (j) If any provision of this section is held to be invalid or  
36 unconstitutional, it shall be conclusively presumed that the legislature  
37 would have enacted the remainder of this section without such invalid or  
38 unconstitutional provision.

39 (g) (j) (k) Upon a first conviction of a violation of this section, a  
40 person shall be guilty of a class A nonperson misdemeanor. Upon a second  
41 or subsequent conviction of a violation of this section, a person shall be  
42 guilty of a severity level 10, nonperson felony.

43 Sec. 4. K.S.A. 65-6705 is hereby amended to read as follows: 65-

1 6705. (a) ~~Before a person performs an abortion upon an unemancipated~~  
2 ~~minor, the person or the person's agent must give actual notice of the intent~~  
3 ~~to perform such abortion to one of the minor's parents or the minor's legal~~  
4 ~~guardian or must have written documentation that such notice has been~~  
5 ~~given unless, after receiving counseling as provided by subsection (a) of~~  
6 ~~K.S.A. 65-6704, the minor objects to such notice being given. If the minor~~  
7 ~~so objects, the minor may petition, on her own behalf or by an adult of her~~  
8 ~~choice, the district court of any county of this state for a waiver of the~~  
9 ~~notice requirement of this subsection. If the minor so desires, the counselor~~  
10 ~~who counseled the minor as required by K.S.A. 65-6704 shall notify the~~  
11 ~~court and the court shall ensure that the minor or the adult petitioning on~~  
12 ~~the minor's behalf is given assistance in preparing and filing the~~  
13 ~~application. Except in the case of a medical emergency or as otherwise~~  
14 ~~provided in this section, no person shall perform an abortion upon an~~  
15 ~~unemancipated minor, unless the person first obtains the notarized written~~  
16 ~~consent of the minor and both parents or the legal guardian of the minor.~~

17 (1) *If the minor's parents are divorced or otherwise unmarried and*  
18 *living separate and apart, then the written consent of the parent with*  
19 *primary custody, care and control of such minor shall be sufficient.*

20 (2) *If the minor's parents are married and one parent is not available*  
21 *to the person performing the abortion in a reasonable time and manner,*  
22 *then the written consent of the parent who is available shall be sufficient.*

23 (3) *If the minor's pregnancy was caused by sexual intercourse with*  
24 *the minor's natural father, adoptive father, stepfather or legal guardian,*  
25 *then the written consent of the minor's mother shall be sufficient. Notice*  
26 *of such circumstances shall be reported to the proper authorities as*  
27 *provided in K.S.A. 2010 Supp. 38-2223, and amendments thereto.*

28 (b) *After receiving counseling as provided by subsection (a) of K.S.A.*  
29 *65-6704, and amendments thereto, the minor may object to the written*  
30 *consent requirement set forth in subsection (a). If the minor so objects,*  
31 *the minor may petition, on her own behalf or by an adult of her choice,*  
32 *the district court of any county of this state for a waiver of the written*  
33 *consent requirement. If the minor so desires, the counselor who counseled*  
34 *the minor as required by K.S.A. 65-6704, and amendments thereto, shall*  
35 *notify the court and the court shall ensure that the minor or the adult*  
36 *petitioning on the minor's behalf is given assistance in preparing and*  
37 *filing the petition. The minor may participate in proceedings in the court*  
38 *on the minor's own behalf or through the adult petitioning on the minor's*  
39 *behalf. The court shall provide a court-appointed counsel to represent the*  
40 *minor at no cost to the minor.*

41 (c) Court proceedings under this section shall be anonymous and the  
42 court shall ensure that the minor's identity is kept confidential. The court  
43 shall order that a confidential record of the evidence in the proceeding be



1 maintained. All persons shall be excluded from hearings under this section  
2 except the minor, her attorney and such other persons whose presence is  
3 specifically requested by the applicant or her attorney.

4 (d) ~~Notice Consent~~ shall be waived if the court finds by a  
5 ~~preponderance of the~~ *clear and convincing* evidence that either: (1) The  
6 minor is mature and well-informed enough to make the abortion decision  
7 on her own; or (2) ~~notification of a person~~ *the consent of the individuals*  
8 specified in subsection (a) would not be in the best interest of the minor.

9 (e) A court that conducts proceedings under this section shall issue  
10 written and specific factual findings and legal conclusions supporting its  
11 decision as follows:

12 (1) Granting the minor's application for waiver of ~~notice consent~~  
13 pursuant to this section, if the court finds that the minor is mature and  
14 well-enough informed to make the abortion decision without ~~notice to a~~  
15 ~~person~~ *the consent of the individuals* specified in subsection (a);

16 (2) granting the minor's application for waiver *of consent* if the court  
17 finds that the minor is immature but that ~~notification of a person~~ *consent*  
18 *of the individuals* specified in subsection (a) would not be in the minor's  
19 best interest; or

20 (3) denying the application if the court finds that the minor is  
21 immature and that waiver of ~~notification of a person~~ *the consent of the*  
22 *individuals* specified in subsection (a) would not be in the minor's best  
23 interest.

24 (f) The court shall give proceedings under this section such  
25 precedence over other pending matters as necessary to ensure that the  
26 court may reach a decision promptly. The court shall issue a written order  
27 which shall be issued immediately to the minor, or her attorney or other  
28 individual designated by the minor to receive the order. If the court fails to  
29 rule within 48 hours, excluding Saturdays and Sundays, of the time of the  
30 filing of the minor's application, the application shall be deemed granted.

31 (g) An expedited anonymous appeal shall be available to any minor.  
32 The record on appeal shall be completed and the appeal shall be perfected  
33 within five days from the filing of the notice to appeal.

34 (h) The supreme court shall promulgate any rules it finds are  
35 necessary to ensure that proceedings under this act are handled in an  
36 expeditious and anonymous manner.

37 (i) No fees shall be required of any minor who avails herself of the  
38 procedures provided by this section.

39 (j) (1) No ~~notice consent~~ shall be required under this section if:

40 (A) ~~The pregnant minor declares that the father of the fetus is one of~~  
41 ~~the persons to whom notice may be given under this section;~~

42 (B) in the best medical judgment of the attending physician based on  
43 the facts of the case, an emergency exists that threatens the health, safety

1 or well-being of the minor as to require an abortion; or

2 ~~(C) the person or persons who are entitled to notice have signed a~~  
3 ~~written, notarized waiver of notice which is placed in the minor's medical~~  
4 ~~record.~~

5 ~~(2) A physician who does not comply with the provisions of this~~  
6 ~~section by reason of the exception of subsection (j)(1)(A) must inform the~~  
7 ~~minor that the physician is required by law to report the sexual abuse to~~  
8 ~~the department of social and rehabilitation services. A physician who does~~  
9 ~~not comply with the requirements of this section by reason of the~~  
10 ~~exception of subsection (j)(1)(B) A physician acting pursuant to this~~  
11 ~~subsection shall state in the medical record of the abortion the medical~~  
12 ~~indications on which the physician's judgment was based. The medical~~  
13 ~~basis for the determination shall also be reported by the physician as part~~  
14 ~~of the written report made by the physician to the secretary of health and~~  
15 ~~environment under K.S.A. 65-445, and amendments thereto.~~

16 (k) Any person who intentionally performs an abortion with  
17 knowledge that, or with reckless disregard as to whether, the person upon  
18 whom the abortion is to be performed is an unemancipated minor, and who  
19 intentionally and knowingly fails to conform to any requirement of this  
20 section, is guilty of a class A person misdemeanor.

21 (l) Except as necessary for the conduct of a proceeding pursuant to  
22 this section, it is a class B person misdemeanor for any individual or entity  
23 to willfully or knowingly: (1) Disclose the identity of a minor petitioning  
24 the court pursuant to this section or to disclose any court record relating to  
25 such proceeding; or (2) permit or encourage disclosure of such minor's  
26 identity or such record.

27 (m) *Prior to conducting proceedings under this section, the court*  
28 *may require the minor to participate in an evaluation ~~and counseling~~*  
29 *session with a ~~mental health professional~~ **psychiatrist, licensed***  
30 ***psychologist or licensed clinical social worker.** Such evaluation ~~and~~*  
31 *~~counseling~~ session shall be for the purpose of developing trustworthy and*  
32 *reliable expert opinion concerning the minor's sufficiency of knowledge,*  
33 *insight, judgment and maturity with regard to her abortion decision in*  
34 *order to aid the court in its decision and to make the state's resources*  
35 *available to the court for this purpose. Persons conducting such sessions*

7 *any other relevant factors, the minor's age, experience working outside the*  
8 *home, living away from home, traveling on her own, handling personal*

11 *what steps the minor has taken to explore her options and the extent to*

18 *this section shall upon final determination by the court be compiled by the*  
19 *court. One copy of the judicial record shall be given to the minor or an*

21 *second copy of the judicial record shall be sent by the court to the*  
22 *abortion provider who performed or will perform the abortion for*

25 *(p) The chief judge of each judicial district shall send annual reports*  
26 *to the department of health and environment disclosing in a nonidentifying*

28 *(1) The number of minors seeking a bypass of the parental consent*  
29 *requirements through court proceedings under this section;*

30 *(2) the number of petitions granted;*

31 *(3) the reasons for granting such petitions;*

32 *(4) any subsequent actions taken to protect the minor from domestic*  
33 *or predator abuse;*

34 *(5) each minor's state of residence, age and disability status; and*

35 *(6) the gestational age of the unborn child if the petition is granted.*

36 *(o) (1) A custodial parent or legal guardian of the minor may*  
37 *pursue civil remedies against individuals, including the physician and*  
38 *abortion clinic staff, who violate the rights of parents, legal guardian or*  
39 *the minor as set forth in this section.*

40 *(2) Such relief shall include:*

41 *(A) Money damages for all injuries, psychological and physical,*  
42 *occasioned by the violation of this section;*

43 *(B) the cost of any subsequent medical treatment such minor might*

1 *require because of the abortion performed without parental consent or*  
2 *knowledge, or without a court order, in violation of this section;*

3 (C) *statutory damages equal to three times the cost of the abortion;*  
4 *and*

5 (D) *reasonable attorney fees.*

6 (q) *In the course of a judicial hearing to waive parental consent, if*  
7 *the court has reason to suspect that a minor has been injured as a result of*  
8 *physical, mental or emotional abuse or neglect or sexual abuse, the court*  
9 *shall report the matter promptly as provided in subsection (c) of K.S.A.*  
10 *2010 Supp. 38-2223, and amendments thereto. In the course of reporting*  
11 *suspected child abuse or neglect to the appropriate state authorities,*  
12 *nothing in this section shall abridge or otherwise modify the anonymity or*  
13 *confidentiality provisions of the judicial waiver proceeding as specified in*  
14 *this section.*

15 (r) *Nothing in this section shall be construed to create a right to an*  
16 *abortion. Notwithstanding any provision of this section, a person shall not*  
17 *perform an abortion that is prohibited by law.*

16 availability of such assistance is contained in the printed materials given to

38 of her unborn child, at no additional expense to her;

39 (2) offers the woman the opportunity to listen to the heartbeat of her
