1 AN ACT concerning reapportionment; relating to state senate districts;

10 *Be it enacted by the Legislature of the State of Kansas:*

11 Section 1. In accordance with section 2 of article 2 of the constitution
12 of the state of Kansas, the state of Kansas is divided into 40 single member
13 state senatorial districts. Such districts are reapportioned in accordance
14 with section 1 of article 10 of the constitution of the state of Kansas.

15 Sec. 2. (a) As used in sections 1 through 44, and amendments
16 thereto, "voting district," "tract," "block group" or "block" means,
17 respectively, a voting district (VTD), tract, block group or block identified
18 on the official United States 2010 decennial census maps.

19 (b) Voting districts, tracts, block groups and blocks are referred to in
20 sections 1 through 44, and amendments thereto, by the alphanumeric code
21 by which they are identified on the official United States 2010 decennial
22 census maps and data lists.

23 (c) The boundaries of counties, voting districts, tracts, block groups
24 and blocks referred to in sections 1 through 44, and amendments thereto,
25 are those boundaries as they exist and are identified on the official United
26 States 2010 decennial census maps.

27 Sec. 3. (a) If a county, voting district, tract, block group or block is
28 not included within a senatorial district established by this act, such
29 county, voting district, tract, block group or block shall be attached to the
30 senatorial district to which it is contiguous and, if contiguous to more than
31 one senatorial district, it shall be attached to the contiguous senatorial
32 district which has the least total population.

33 (b) If a county, voting district, tract, block group or block is included
34 in two or more senatorial districts established by this act, such county,
35 voting district, tract, block group or block shall be attached to and become

1 a part of the senatorial district which has the least total population.

2 Sec. 4. The provisions of this act shall not affect the term of any
3 senator elected to represent a district at the general election of 2008 or the
4 term of any successor elected to succeed such senator for an unexpired
5 term, and all such senators shall continue to serve the districts from which
6 elected until the senators elected from the districts established by this act
7 commence their terms of office in January of 2013.
