1 AN ACT concerning juvenile offenders; relating to out-of-state juvenile
2 offender registration.

4 *Be it enacted by the Legislature of the State of Kansas:*

5 Section 1. (a) As used in this section:

6 (1) "Residential placement facility" means any public or private
7 residence, facility or institution that provides residence or 24-hour-a-day
8 care to any out-of-state juvenile offender; and

9 (2) the terms "out-of-state," "reside," "residence" and "transient" have
10 the same meaning as provided in K.S.A. 22-4902, and amendments
11 thereto.

12 (b) Except for an offender placed in Kansas pursuant to the interstate
13 compact for juveniles as provided in K.S.A. 2011 Supp. 38-1008, and
14 amendments thereto, if an out-of-state juvenile offender is placed within
15 the state of Kansas the supervisor of a residential placement facility shall:

16 (1) Provide the completed residential placement registration form to
17 the commissioner and the city or county law enforcement agency in which
18 such facility is located within three business days of an out-of-state
19 juvenile offender's commencement of residence at such facility;

20 (2) inform the commissioner and the city or county law enforcement
21 agency in which such facility is located of the out-of-state juvenile
22 offender's release or discharge from such facility within three business
23 days of such release or discharge;

24 (3) immediately notify the commissioner and the city or county law
25 enforcement agency in which such facility is located of any unexpected or
26 unauthorized absence of the out-of-state juvenile offender; and

27 (4) upon request, provide information to any law enforcement agency
28 for the purpose of determining the out-of-state juvenile offender's
29 whereabouts.

30 (c) The residential placement registration form shall be made
31 available on the official website of the juvenile justice authority. The
32 supervisor of the residential placement facility shall provide all
33 information concerning an out-of-state juvenile known to such supervisor,
34 including, but not limited to:

35 (1) Name and all alias names;

36 (2) date and city, state and country of birth, and any alias dates or

- 1 places of birth;
- 2 (3) title and statute number of each offense or offenses committed,
- 3 date of each conviction or adjudication and court case numbers for each
- 4 conviction or adjudication;
- 5 (4) city, county, state or country of conviction or adjudication;
- 6 (5) current residential address, any anticipated future residence and
- 7 any temporary lodging information including, but not limited to, address,
- 8 telephone number and dates of travel for any place in which the offender is
- 9 staying for seven or more days; and, if transient, the locations where the
- 10 offender has stayed and frequented since last reporting for registration;
- 11 (6) all telephone numbers at which the offender may be contacted
- 12 including, but not limited to, all mobile telephone numbers;
- 13 (7) social security number, and all alias social security numbers;
- 14 (8) identifying characteristics such as race, ethnicity, skin tone, sex,
- 15 age, height, weight, hair and eye color, scars, tattoos and blood type;
- 16 (9) occupation and name, address or addresses and telephone number
- 17 of employer or employers, and name of any anticipated employer and
- 18 place of employment;
- 19 (10) all current driver's licenses or identification cards, including a
- 20 photocopy of all such driver's licenses or identification cards and their
- 21 numbers, states of issuance and expiration dates;
- 22 (11) all vehicle information, including the license plate number,
- 23 registration number and any other identifier and description of any vehicle
- 24 owned or operated by the offender, or any vehicle the offender regularly
- 25 drives, either for personal use or in the course of employment, and
- 26 information concerning the location or locations such vehicle or vehicles
- 27 are habitually parked or otherwise kept;
- 28 (12) license plate number, registration number or other identifier and
- 29 description of any aircraft or watercraft owned or operated by the offender,
- 30 and information concerning the location or locations such aircraft or
- 31 watercraft are habitually parked, docked or otherwise kept;
- 32 (13) all professional licenses, designations and certifications;
- 33 (14) documentation of any treatment received for a mental
- 34 abnormality or personality disorder of the offender; for purposes of
- 35 documenting the treatment received, registering law enforcement agencies,
- 36 correctional facility officials, treatment facility officials and courts may
- 37 rely on information that is readily available to them from existing records
- 38 and the offender;
- 39 (15) a photograph or photographs;
- 40 (16) fingerprints and palm prints;
- 41 (17) all schools and satellite schools attended or expected to be
- 42 attended and the locations of attendance and telephone number;
- 43 (18) any and all: e-mail addresses; online identities used by the

- 1 offender on the internet; information relating to membership in any and all
2 personal web pages or online social networks; and internet screen names;
3 (19) all travel and immigration documents; and
4 (20) name and telephone number of the offender's probation, parole
5 or community corrections officer.
6 (d) Violation of this section shall be an unclassified misdemeanor.
7 (e) The commissioner may promulgate rules and regulations to carry
8 out the provisions of this section.
9 (f) This section shall be a part of and supplemental to the revised
10 Kansas juvenile justice code.
11 (g) Nothing in this section shall be construed to limit or amend the
12 provisions, or the application, of the interstate compact for juveniles as
13 provided in K.S.A. 2011 Supp. 38-1008, and amendments thereto.
14 Sec. 2. This act shall take effect and be in force from and after its
15 publication in the statute book.
