1 AN ACT concerning criminal procedure; relating to sex offenders;
2 amending K.S.A. 22-4903 and K.S.A. 2010 Supp. 8-243, 8-255, 22-
3 4902, 22-4904 and 22-4913 and sections 7, 285 and 299 of chapter
4 136 of the 2010 Session Laws of Kansas and repealing the existing
5 sections.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. K.S.A. 2010 Supp. 8-243 is hereby amended to read as
9 follows: 8-243. (a) Upon payment of the required fee, the division shall
10 issue to every applicant qualifying under the provisions of this act the
11 driver's license as applied for by the applicant. Such license shall bear the
12 class or classes of motor vehicles which the licensee is entitled to drive, a
13 distinguishing number assigned to the licensee, the full legal name, date
14 of birth, gender, address of principal residence and a brief description of
15 the licensee, a colored digital photograph of the licensee, a facsimile of
16 the signature of the licensee and the statement provided for in subsection
17 (b). No driver's license shall be valid until it has been signed by the
18 licensee. All drivers' licenses issued to persons under the age of 21 years
19 shall be readily distinguishable from licenses issued to persons age 21
20 years or older. In addition, all drivers' licenses issued to persons under the
21 age of 18 years shall also be readily distinguishable from licenses issued
22 to persons age 18 years or older. The secretary of revenue shall
23 implement a vertical format to make drivers' licenses issued to persons
24 under the age of 21 more readily distinguishable. Except as otherwise
25 provided, no driver's license issued by the division shall be valid until a
26 colored digital photograph of such licensee has been taken and verified
27 before being placed on the driver's license. The secretary of revenue shall
28 prescribe a fee of not more than \$8 and upon the payment of such fee, the
29 division shall cause a colored digital photograph of such applicant to be
30 placed on the driver's license. Upon payment of such fee prescribed by
31 the secretary of revenue, plus payment of the fee required by K.S.A. 8-
32 246, and amendments thereto, for issuance of a new license, the division
33 shall issue to such licensee a new license containing a colored digital
34 photograph of such licensee. A driver's license which does not contain the
35 principal address as required may be issued to persons who are program
36 participants pursuant to K.S.A. 2010 Supp. 75-455, and amendments

1 thereto, upon payment of the fee required by K.S.A. 8-246, and
2 amendments thereto. All Kansas drivers' licenses and identification cards
3 shall have physical security features designed to prevent tampering,
4 counterfeiting or duplication of the document for fraudulent purposes.
5 The secretary of revenue shall incorporate common machine-readable
6 technology into all Kansas drivers' licenses and identification cards.

7 (b) All Kansas drivers' licenses issued to any person 16 years of age
8 or older shall contain a form which provides a statement for making a gift
9 of all or any part of the body of the licensee in accordance with the
10 revised uniform anatomical gift act, K.S.A. 2010 Supp. 65-3220 through
11 65-3244, and amendments thereto, except as otherwise provided by this
12 subsection. The statement to be effective shall be signed by the licensee
13 in the presence of two witnesses who shall sign the statement in the
14 presence of the donor. The gift becomes effective upon the death of the
15 donor. Delivery of the license during the donor's lifetime is not necessary
16 to make a valid gift. Any valid gift statement executed prior to July 1,
17 1994, shall remain effective until invalidated. The word "Donor" shall be
18 placed on the front of a licensee's driver's license, indicating that the
19 statement for making an anatomical gift under this subsection has been
20 executed by such licensee.

21 (c) Any person who is deaf or hard of hearing may request that the
22 division issue to such person a driver's license which is readily
23 distinguishable from drivers' licenses issued to other drivers and upon
24 such request the division shall issue such license. Drivers' licenses issued
25 to persons who are deaf or hard of hearing and under the age of 21 years
26 shall be readily distinguishable from drivers' licenses issued to persons
27 who are deaf or hard of hearing and 21 years of age or older. Upon
28 satisfaction of subsection (a), the division shall issue a receipt of
29 application permitting the operation of a vehicle consistent with the
30 requested class, if there are no other restrictions or limitations, pending
31 the division's verification of the information and production of a driver's
32 license.

33 (d) (1) A driver's license issued to a person required to be
34 registered under K.S.A. 22-4901 et seq., and amendments thereto, shall
35 be assigned a distinguishing number by the division which will readily
36 indicate to law enforcement officers that such person is a registered
37 offender. The division shall develop a numbering system to implement
38 the provisions of this subsection.

39 (2) *A driver's license issued to a person defined as an aggravated*
40 *sex offender under subsection (b) of K.S.A. 22-4902, and amendments*
41 *thereto, shall also include an "aggravated sex offender" label.*

42 Sec. 2. K.S.A. 2010 Supp. 8-255 is hereby amended to read as
43 follows: 8-255. (a) The division is authorized to restrict, suspend or

1 revoke a person's driving privileges upon a showing by its records or
2 other sufficient evidence the person:

3 (1) Has been convicted with such frequency of serious offenses
4 against traffic regulations governing the movement of vehicles as to
5 indicate a disrespect for traffic laws and a disregard for the safety of other
6 persons on the highways;

7 (2) has been convicted of three or more moving traffic violations
8 committed on separate occasions within a 12-month period;

9 (3) is incompetent to drive a motor vehicle;

10 (4) has been convicted of a moving traffic violation, committed at a
11 time when the person's driving privileges were restricted, suspended or
12 revoked; or

13 (5) is a member of the armed forces of the United States stationed at
14 a military installation located in the state of Kansas, and the authorities of
15 the military establishment certify that such person's on-base driving
16 privileges have been suspended, by action of the proper military
17 authorities, for violating the rules and regulations of the military
18 installation governing the movement of vehicular traffic or for any other
19 reason relating to the person's inability to exercise ordinary and
20 reasonable control in the operation of a motor vehicle.

21 (b) The division shall suspend a person's driving privileges when
22 required by K.S.A. 8-262, 8-1014, ~~21-3765~~ *subsection (a)(5) of section 87*
23 *of chapter 136 of the 2010 Session Laws of Kansas, 22-4903 or 41-727,*
24 *and amendments thereto, and shall disqualify a person's privilege to drive*
25 *commercial motor vehicles when required by K.S.A. 8-2,142, and*
26 *amendments thereto. The division shall restrict a person's driving*
27 *privileges when required by K.S.A. 2010 Supp. 39-7,155, and*
28 *amendments thereto.*

29 (c) When the action by the division restricting, suspending, revoking
30 or disqualifying a person's driving privileges is based upon a report of a
31 conviction or convictions from a convicting court, the person may not
32 request a hearing but, within 30 days after notice of restriction,
33 suspension, revocation or disqualification is mailed, may submit a written
34 request for administrative review and provide evidence to the division to
35 show the person whose driving privileges have been restricted,
36 suspended, revoked or disqualified by the division was not convicted of
37 the offense upon which the restriction, suspension, revocation or
38 disqualification is based. Within 30 days of its receipt of the request for
39 administrative review, the division shall notify the person whether the
40 restriction, suspension, revocation or disqualification has been affirmed
41 or set aside. The request for administrative review shall not stay any
42 action taken by the division.

43 (d) Upon restricting, suspending, revoking or disqualifying the

1 driving privileges of any person as authorized by this act, the division
2 shall immediately notify the person in writing. Except as provided by
3 K.S.A. 8-1002 and 8-2,145, and amendments thereto, and subsections (c)
4 and (g), if the person makes a written request for hearing within 30 days
5 after such notice of restriction, suspension or revocation is mailed, the
6 division shall afford the person an opportunity for a hearing as early as
7 practical not sooner than five days nor more than 30 days after such
8 request is mailed. If the division has not revoked or suspended the
9 person's driving privileges or vehicle registration prior to the hearing, the
10 hearing may be held within not to exceed 45 days. Except as provided by
11 K.S.A. 8-1002 and 8-2,145, and amendments thereto, the hearing shall be
12 held in the person's county of residence or a county adjacent thereto,
13 unless the division and the person agree that the hearing may be held in
14 some other county. Upon the hearing, the director or the director's duly
15 authorized agent may administer oaths and may issue subpoenas for the
16 attendance of witnesses and the production of relevant books and papers
17 and may require an examination or reexamination of the person. When
18 the action proposed or taken by the division is authorized but not
19 required, the division, upon the hearing, shall either rescind or affirm its
20 order of restriction, suspension or revocation or, good cause appearing
21 therefor, extend the restriction or suspension of the person's driving
22 privileges, modify the terms of the restriction or suspension or revoke the
23 person's driving privileges. When the action proposed or taken by the
24 division is required, the division, upon the hearing, shall either affirm its
25 order of restriction, suspension, revocation or disqualification, or, good
26 cause appearing therefor, dismiss the administrative action. If the person
27 fails to request a hearing within the time prescribed or if, after a hearing,
28 the order of restriction, suspension, revocation or disqualification is
29 upheld, the person shall surrender to the division, upon proper demand,
30 any driver's license in the person's possession.

31 (e) In case of failure on the part of any person to comply with any
32 subpoena issued *on behalf* of the division or the refusal of any witness to
33 testify to any matters regarding which the witness may be lawfully
34 interrogated, the district court of any county, on application of the
35 division, may compel obedience by proceedings for contempt, as in the
36 case of disobedience of the requirements of a subpoena issued from the
37 court or a refusal to testify in the court. Each witness who appears before
38 the director or the director's duly authorized agent by order or subpoena,
39 other than an officer or employee of the state or of a political subdivision
40 of the state, shall receive for the witness' attendance the fees and mileage
41 provided for witnesses in civil cases in courts of record, which shall be
42 audited and paid upon the presentation of proper vouchers sworn to by
43 the witness.

1 (f) The division, in the interest of traffic and safety, may establish or
2 contract with a private individual, corporation, partnership or association
3 for the services of driver improvement clinics throughout the state and,
4 upon reviewing the driving record of a person whose driving privileges
5 are subject to suspension under subsection (a)(2), may permit the person
6 to retain such person's driving privileges by attending a driver
7 improvement clinic. Any person other than a person issued a commercial
8 driver's license under K.S.A. 8-2,125 et seq., and amendments thereto,
9 desiring to attend a driver improvement clinic shall make application to
10 the division and such application shall be accompanied by the required
11 fee. The secretary of revenue shall adopt rules and regulations prescribing
12 a driver's improvement clinic fee which shall not exceed \$500 and such
13 rules and regulations deemed necessary for carrying out the provisions of
14 this section, including the development of standards and criteria to be
15 utilized by such driver improvement clinics. Amounts received under this
16 subsection shall be remitted to the state treasurer in accordance with the
17 provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of
18 each such remittance, the state treasurer shall deposit the same in the state
19 treasury as prescribed by subsection (f) of K.S.A. 8-267, and amendments
20 thereto.

21 (g) When the action by the division restricting a person's driving
22 privileges is based upon certification by the secretary of social and
23 rehabilitation services pursuant to K.S.A. 2010 Supp. 39-7,155, and
24 amendments thereto, the person may not request a hearing but, within 30
25 days after notice of restriction is mailed, may submit a written request for
26 administrative review and provide evidence to the division to show the
27 person whose driving privileges have been restricted by the division is
28 not the person certified by the secretary of social and rehabilitation
29 services, did not receive timely notice of the proposed restriction from the
30 secretary of social and rehabilitation services or has been decertified by
31 the secretary of social and rehabilitation services. Within 30 days of its
32 receipt of the request for administrative review, the division shall notify
33 the person whether the restriction has been affirmed or set aside. The
34 request for administrative review shall not stay any action taken by the
35 division.

36 New Sec. 3. (a) On October 31 of each year, any person required
37 to register as a sex offender pursuant to the Kansas offender registration
38 act shall:

- 39 (1) Avoid all Halloween-related contact with children;
- 40 (2) remain inside the person's residence between the hours of 5:00
41 p.m. and 11:00 p.m.;
- 42 (3) post a sign at the person's residence stating "No candy at this
43 residence"; and

1 (4) turn off all outdoor residential lighting after 5:00 p.m.

2 (b) This section shall be part of and supplemental to the Kansas
3 offender registration act.

4 Sec. 4. K.S.A. 2010 Supp. 22-4902 is hereby amended to read as
5 follows: 22-4902. As used in the Kansas offender registration act, unless
6 the context otherwise requires:

7 (a) "Offender" means: (1) A sex offender as defined in subsection
8 (b);

9 (2) a violent offender as defined in subsection (d);

10 (3) a sexually violent predator as defined in subsection (f);

11 (4) any person who, on and after May 29, 1997, is convicted of any
12 of the following crimes when the victim is less than 18 years of age:

13 (A) Kidnapping as defined in K.S.A. 21-3420, *prior to its repeal, or*
14 *subsection (a) of section 43 of chapter 136 of the 2010 Session Laws of*
15 *Kansas*, and amendments thereto, except by a parent;

16 (B) aggravated kidnapping as defined in K.S.A. 21-3421, *prior to its*
17 *repeal, or subsection (b) of section 43 of chapter 136 of the 2010 Session*
18 *Laws of Kansas*, and amendments thereto; or

19 (C) criminal restraint as defined in K.S.A. 21-3424, *prior to its*
20 *repeal, or section 46 of chapter 136 of the 2010 Session Laws of Kansas*,
21 and amendments thereto, except by a parent;

22 (5) any person convicted of any of the following criminal sexual
23 conduct if one of the parties involved is less than 18 years of age:

24 (A) Adultery as defined by K.S.A. 21-3507, *prior to its repeal, or*
25 *section 75 of chapter 136 of the 2010 Session Laws of Kansas*, and
26 amendments thereto;

27 (B) criminal sodomy as defined by subsection (a)(1) of K.S.A. 21-
28 3505, *prior to its repeal, or subsection (a) of section 68 of chapter 136 of*
29 *the 2010 Session Laws of Kansas*, and amendments thereto;

30 (C) promoting prostitution as defined by K.S.A. 21-3513, *prior to*
31 *its repeal, or section 230 of chapter 136 of the 2010 Session Laws of*
32 *Kansas*, and amendments thereto;

33 (D) patronizing a prostitute as defined by K.S.A. 21-3515, *prior to*
34 *its repeal, or section 231 of chapter 136 of the 2010 Session Laws of*
35 *Kansas*, and amendments thereto; or

36 (E) lewd and lascivious behavior as defined by K.S.A. 21-3508,
37 *prior to its repeal, or section 77 of chapter 136 of the 2010 Session Laws*
38 *of Kansas*, and amendments thereto;

39 (6) any person who has been required to register under any federal,
40 military or other state's law or is otherwise required to be registered;

41 (7) any person who, on or after July 1, 2006, is convicted of any
42 person felony and the court makes a finding on the record that a deadly
43 weapon was used in the commission of such person felony;

1 (8) any person who has been convicted of an offense in effect at any
2 time prior to May 29, 1997, that is comparable to any crime defined in
3 subsection (4), (5), (7) or (11), or any federal, military or other state
4 conviction for an offense that under the laws of this state would be an
5 offense defined in subsection (4), (5), (7) or (11);

6 (9) any person who has been convicted of an attempt, conspiracy or
7 criminal solicitation, as defined in K.S.A. 21-3301, 21-3302 or 21-3303,
8 *prior to their repeal, or sections 33, 34 or 35 of chapter 136 of the*
9 *2010 Session Laws of Kansas*, and amendments thereto, of an offense
10 defined in subsection (4), (5), (7) or (10);

11 (10) any person who has been convicted of aggravated human
12 trafficking as defined in K.S.A. 21-3447, *prior to its repeal, or subsection*
13 *(b) of section 61 of chapter 136 of the 2010 Session Laws of Kansas*, and
14 amendments thereto; or

15 (11) any person who has been convicted of: (A) Unlawful
16 manufacture or attempting such of any controlled substance or controlled
17 substance analog as defined by K.S.A. 65-4159, prior to its repeal, or
18 K.S.A. 2010 Supp. 21-36a03, and amendments thereto, unless the court
19 makes a finding on the record that the manufacturing or attempting to
20 manufacture such controlled substance was for such person's personal
21 use;

22 (B) possession of ephedrine, pseudoephedrine, red phosphorus,
23 lithium metal, sodium metal, iodine, anhydrous ammonia, pressurized
24 ammonia or phenylpropanolamine, or their salts, isomers or salts of
25 isomers with intent to use the product to manufacture a controlled
26 substance as defined by subsection (a) of K.S.A. 65-7006, prior to its
27 repeal, or subsection (a) of K.S.A. 2010 Supp. 21-36a09, and
28 amendments thereto, unless the court makes a finding on the record that
29 the possession of such product was intended to be used to manufacture a
30 controlled substance for such person's personal use; or

31 (C) K.S.A. 65-4161, prior to its repeal, or subsection (a)(1) of
32 K.S.A. 2010 Supp. 21-36a05, and amendments thereto. The provisions of
33 this paragraph shall not apply to violations of subsections (a)(2) through
34 (a)(6) or (b) of K.S.A. 2010 Supp. 21-36a05, and amendments thereto,
35 which occurred on and after July 1, 2009, through ~~the effective date of~~
36 ~~this act.~~ *April 15, 2010.*

37 Convictions which result from or are connected with the same act, or
38 result from crimes committed at the same time, shall be counted for the
39 purpose of this section as one conviction. Any conviction set aside
40 pursuant to law is not a conviction for purposes of this section. A
41 conviction from another state shall constitute a conviction for purposes of
42 this section.

43 (b) (1) "Sex offender" includes any person who.;

1 (A) On or after April 14, 1994, and prior to July 1, 2011, is
2 convicted of any sexually violent crime set forth in subsection (c) or is
3 adjudicated as a juvenile offender for an act which if committed by an
4 adult would constitute the commission of a sexually violent crime set
5 forth in subsection (c);-

6 (B) on or after July 1, 2011, is convicted of any sexually violent
7 crime set forth in subsection (c), or is adjudicated as a juvenile offender
8 for an act which if committed by an adult would constitute the
9 commission of a sexually violent crime set forth in subsection (c), if none
10 of the parties involved is less than 16 years of age.

11 (2) "Aggravated sex offender" includes any person who, on or after
12 July 1, 2011, is convicted of any sexually violent crime set forth in
13 subsection (c), or is adjudicated as a juvenile offender for an act which if
14 committed by an adult would constitute the commission of a sexually
15 violent crime set forth in subsection (c), if one of the parties involved is
16 less than 16 years of age.

17 (c) "Sexually violent crime" means:

18 (1) Rape as defined in K.S.A. 21-3502, prior to its repeal, or section
19 67 of chapter 136 of the 2010 Session Laws of Kansas, and amendments
20 thereto;

21 (2) indecent liberties with a child as defined in K.S.A. 21-3503,
22 prior to its repeal, or subsection (a) of section 70 of chapter 136 of the
23 2010 Session Laws of Kansas, and amendments thereto;

24 (3) aggravated indecent liberties with a child as defined in K.S.A.
25 21-3504, prior to its repeal, or subsection (b) of section 70 of chapter
26 136 of the 2010 Session Laws of Kansas, and amendments thereto;

27 (4) criminal sodomy as defined in subsection (a)(2) and (a)(3) of
28 K.S.A. 21-3505, prior to its repeal, or subsection (a) of section 68 of
29 chapter 136 of the 2010 Session Laws of Kansas, and amendments
30 thereto;

31 (5) aggravated criminal sodomy as defined in K.S.A. 21-3506, prior
32 to its repeal, or subsection (b) of section 68 of chapter 136 of the 2010
33 Session Laws of Kansas, and amendments thereto;

34 (6) indecent solicitation of a child as defined by K.S.A. 21-3510,
35 prior to its repeal, or subsection (a) of section 72 of chapter 136 of the
36 2010 Session Laws of Kansas, and amendments thereto;

37 (7) aggravated indecent solicitation of a child as defined by K.S.A.
38 21-3511, prior to its repeal, or subsection (b) of section 72 of chapter 136
39 of the 2010 Session Laws of Kansas, and amendments thereto;

40 (8) sexual exploitation of a child as defined by K.S.A. 21-3516,
41 prior to its repeal, or section 74 of chapter 136 of the 2010 Session Laws
42 of Kansas, and amendments thereto;

43 (9) sexual battery as defined by K.S.A. 21-3517, prior to its repeal,

1 *or subsection (a) of section 69 of chapter 136 of the 2010 Session Laws*
2 *of Kansas, and amendments thereto;*

3 (10) *aggravated sexual battery as defined by K.S.A. 21-3518, prior*
4 *to its repeal, or subsection (b) of section 69 of chapter 136 of the 2010*
5 *Session Laws of Kansas, and amendments thereto;*

6 (11) *aggravated incest as defined by K.S.A. 21-3603, prior to its*
7 *repeal, or subsection (b) of section 81 of chapter 136 of the 2010 Session*
8 *Laws of Kansas, and amendments thereto;*

9 (12) *electronic solicitation as defined by K.S.A. 21-3523, prior to its*
10 *repeal, or section 73 of chapter 136 of the 2010 Session Laws of Kansas,*
11 *and amendments thereto, committed on or after April 17, 2008;*

12 (13) *unlawful sexual relations as defined by K.S.A. 21-3520, prior*
13 *to its repeal, or section 76 of chapter 136 of the 2010 Session Laws of*
14 *Kansas, and amendments thereto, committed on or after July 1, 2010;*

15 (14) *any conviction for an offense in effect at any time prior to April*
16 *29, 1993, that is comparable to a sexually violent crime as defined in*
17 *subparagraphs (1) through (11), or any federal, military or other state*
18 *conviction for an offense that under the laws of this state would be a*
19 *sexually violent crime as defined in this section;*

20 (15) *an attempt, conspiracy or criminal solicitation, as defined in*
21 *K.S.A. 21-3301, 21-3302 or 21-3303, prior to their repeal, or sections*
22 *33, 34 or 35 of chapter 136 of the 2010 Session Laws of Kansas, and*
23 *amendments thereto, of a sexually violent crime, as defined in this*
24 *section; or*

25 (16) *any act which at the time of sentencing for the offense has been*
26 *determined beyond a reasonable doubt to have been sexually motivated.*
27 *As used in this subparagraph, "sexually motivated" means that one of the*
28 *purposes for which the defendant committed the crime was for the*
29 *purpose of the defendant's sexual gratification.*

30 (d) *"Violent offender" includes any person who, on or after May 29,*
31 *1997, is convicted of any of the following crimes:*

32 (1) *Capital murder as defined by K.S.A. 21-3439, prior to its repeal,*
33 *or section 36 of chapter 136 of the 2010 Session Laws of Kansas, and*
34 *amendments thereto;*

35 (2) *murder in the first degree as defined by K.S.A. 21-3401, prior to*
36 *its repeal, or section 37 of chapter 136 of the 2010 Session Laws of*
37 *Kansas, and amendments thereto;*

38 (3) *murder in the second degree as defined by K.S.A. 21-3402, prior*
39 *to its repeal, or section 38 of chapter 136 of the 2010 Session Laws of*
40 *Kansas, and amendments thereto;*

41 (4) *voluntary manslaughter as defined by K.S.A. 21-3403, prior to*
42 *its repeal, or section 39 of chapter 136 of the 2010 Session Laws of*
43 *Kansas, and amendments thereto;*

1 (5) involuntary manslaughter as defined by K.S.A. 21-3404, *prior to*
2 *its repeal, or section 40 of chapter 136 of the 2010 Session Laws of*
3 *Kansas*, and amendments thereto;

4 (6) any conviction for an offense in effect at any time prior to May
5 29, 1997, that is comparable to any crime defined in this subsection, or
6 any federal, military or other state conviction for an offense that under the
7 laws of this state would be an offense defined in this subsection; or

8 (7) an attempt, conspiracy or criminal solicitation, as defined in
9 K.S.A. 21-3301, 21-3302 or 21-3303, *prior to their repeal, or sections*
10 *33, 34 or 35 of chapter 136 of the 2010 Session Laws of Kansas*, and
11 amendments thereto, of an offense defined in this subsection.

12 (e) "Law enforcement agency having jurisdiction" means the sheriff
13 of the county in which the offender expects to reside upon the offender's
14 discharge, parole or release.

15 (f) "Sexually violent predator" means any person who, on or after
16 July 1, 2001, is found to be a sexually violent predator pursuant to K.S.A.
17 59-29a01 et seq., and amendments thereto.

18 (g) "Nonresident student or worker" includes any offender who
19 crosses into the state or county for more than 14 days, or for an aggregate
20 period exceeding 30 days in a calendar year, for the purposes of
21 employment, with or without compensation, or to attend school as a
22 student.

23 (h) "Aggravated offenses" means engaging in sexual acts involving
24 penetration with victims of any age through the use of force or the threat
25 of serious violence, or engaging in sexual acts involving penetration with

34 *chapter 136 of the 2010 Session Laws of Kansas*, and amendments
35 thereto, when such property is a motor vehicle, shall be presumptive
36 imprisonment. Such sentence shall not be considered a departure and
37 shall not be subject to appeal.

38 (o) The sentence for a felony violation of theft of property as defined
39 in section 87 *of chapter 136 of the 2010 Session Laws of Kansas*, and
40 amendments thereto, or burglary as defined in subsection (a) of section 93
41 *of chapter 136 of the 2010 Session Laws of Kansas*, and amendments
42 thereto, when such person being sentenced has no prior convictions for a
43 violation of K.S.A. 21-3701 or 21-3715, prior to their repeal, or theft of

1 property as defined in section 87 of chapter 136 of the 2010 Session Laws
2 of Kansas, and amendments thereto, or burglary as defined in subsection
3 (a) of section 93 of chapter 136 of the 2010 Session Laws of Kansas, and
4 amendments thereto; or the sentence for a felony violation of theft of
5 property as defined in section 87 of chapter 136 of the 2010 Session Laws
6 of Kansas, and amendments thereto, when such person being sentenced
7 has one or two prior felony convictions for a violation of K.S.A. 21-3701,
8 21-3715 or 21-3716, prior to their repeal, or theft of property as defined
9 in section 87 of chapter 136 of the 2010 Session Laws of Kansas, and
10 amendments thereto, or burglary as defined in section 93 of chapter 136
11 of the 2010 Session Laws of Kansas, and amendments thereto; or the
12 sentence for a felony violation of burglary as defined in subsection (a) of
13 section 93 of chapter 136 of the 2010 Session Laws of Kansas, and
14 amendments thereto, when such person being sentenced has one prior
15 felony conviction for a violation of K.S.A. 21-3701, 21-3715 or 21-3716,
16 prior to their repeal, or theft of property as defined in section 87 of
17 chapter 136 of the 2010 Session Laws of Kansas, and amendments
18 thereto, or burglary as defined in section 93 of chapter 136 of the 2010
19 Session Laws of Kansas, and amendments thereto, shall be the sentence
20 as provided by this section, except that the court may order an optional
21 nonprison sentence for a defendant to participate in a drug treatment
22 program, including, but not limited to, an approved after-care plan, if the
23 court makes the following findings on the record:

24 (1) Substance abuse was an underlying factor in the commission of
25 the crime;

26 (2) substance abuse treatment in the community is likely to be more
27 effective than a prison term in reducing the risk of offender recidivism;
28 and

29 (3) participation in an intensive substance abuse treatment program
30 will serve community safety interests.

31 A defendant sentenced to an optional nonprison sentence under this
32 subsection shall be supervised by community correctional services. The
33 provisions of subsection (f)(1) of section 305 of chapter 136 of the 2010
34 Session Laws of Kansas, and amendments thereto, shall apply to a
35 defendant sentenced under this subsection. The sentence under this
36 subsection shall not be considered a departure and shall not be subject to
37 appeal.

38 (p) The sentence for a felony violation of theft of property as defined
39 in section 87 of chapter 136 of the 2010 Session Laws of Kansas, and
40 amendments thereto, when such person being sentenced has any
41 combination of three or more prior felony convictions for violations of
42 K.S.A. 21-3701, 21-3715 or 21-3716, prior to their repeal, or theft of
43 property as defined in section 87 of chapter 136 of the 2010 Session Laws

1 *of Kansas, and amendments thereto, or burglary as defined in section 93*
2 *of chapter 136 of the 2010 Session Laws of Kansas, and amendments*
3 *thereto; or the sentence for a violation of burglary as defined in*
4 *subsection (a) of section 93 of chapter 136 of the 2010 Session Laws of*
5 *Kansas, and amendments thereto, when such person being sentenced has*
6 *any combination of two or more prior convictions for violations of*
7 *K.S.A. 21-3701, 21-3715 and 21-3716, prior to their repeal, or theft of*
8 *property as defined in section 87 of chapter 136 of the 2010 Session Laws*
9 *of Kansas, and amendments thereto, or burglary as defined in section 93*
10 *of chapter 136 of the 2010 Session Laws of Kansas, and amendments*
11 *thereto, shall be presumed imprisonment and the defendant shall be*
12 *sentenced to prison as provided by this section, except that the court may*
13 *recommend that an offender be placed in the custody of the secretary of*
14 *corrections, in a facility designated by the secretary to participate in an*
15 *intensive substance abuse treatment program, upon making the following*
16 *findings on the record:*

17 (1) Substance abuse was an underlying factor in the commission of
18 the crime;

19 (2) substance abuse treatment with a possibility of an early release
20 from imprisonment is likely to be more effective than a prison term in
21 reducing the risk of offender recidivism; and

22 (3) participation in an intensive substance abuse treatment program
23 with the possibility of an early release from imprisonment will serve
24 community safety interests by promoting offender reformation.

25 The intensive substance abuse treatment program shall be determined
26 by the secretary of corrections, but shall be for a period of at least four
27 months. Upon the successful completion of such intensive treatment
28 program, the offender shall be returned to the court and the court may
29 modify the sentence by directing that a less severe penalty be imposed in
30 lieu of that originally adjudged within statutory limits. If the offender's
31 term of imprisonment expires, the offender shall be placed under the
32 applicable period of postrelease supervision. The sentence under this
33 subsection shall not be considered a departure and shall not be subject to
34 appeal.

35 (q) As used in this section, an "optional nonprison sentence" is a
36 sentence which the court may impose, in lieu of the presumptive
37 sentence, upon making the following findings on the record:

38 (1) An appropriate treatment program exists which is likely to be
39 more effective than the presumptive prison term in reducing the risk of
40 offender recidivism; and

41 (2) the recommended treatment program is available and the
42 offender can be admitted to such program within a reasonable period of
43 time; or

1 (3) the nonprison sanction will serve community safety interests by
2 promoting offender reformation.

3 Any decision made by the court regarding the imposition of an
4 optional nonprison sentence shall not be considered a departure and shall
5 not be subject to appeal.

6 (r) The sentence for a violation of subsection (c)(2) of section 48 of
7 *chapter 136 of the 2010 Session Laws of Kansas*, and amendments
8 thereto, shall be presumptive imprisonment and shall be served
9 consecutively to any other term or terms of imprisonment imposed. Such
10 sentence shall not be considered a departure and shall not be subject to
11 appeal.

12 (s) *The sentence for a violation of K.S.A. 22-4903, and amendments*
13 *thereto, shall be presumptive imprisonment. Such sentence shall not be*
14 *considered a departure and shall not be subject to appeal.*

15 Sec. 11. *Section 299 of chapter 136 of the 2010 Session Laws of*
16 *Kansas is hereby amended to read as follows: Sec. 299. (a) When a*
17 *departure sentence is appropriate, the sentencing judge may depart from*
18 *the sentencing guidelines as provided in this section.*

19 (1) The sentencing judge shall not impose a downward dispositional
20 departure sentence for any crime of extreme sexual violence, as defined
21 in section 296 of *chapter 136 of the 2010 Session Laws of Kansas*, and
22 amendments thereto. The sentencing judge shall not impose a downward
23 durational departure sentence for any crime of extreme sexual violence,
24 as defined in section 296 of *chapter 136 of the 2010 Session Laws of*
25 *Kansas*, and amendments thereto, to less than 50% of the center of the
26 range of the sentence for such crime.

27 (2) *The sentencing judge shall not impose a downward dispositional*
28 *departure sentence for a violation of K.S.A. 22-4903, and amendments*
29 *thereto.*

30 (b) When a sentencing judge departs in setting the duration of a
31 presumptive term of imprisonment:

32 (1) The judge shall consider and apply the sentencing guidelines,
33 which is to impose a sentence that is proportionate to the severity of the
34 crime of conviction and the offender's criminal history; and

35 (2) the presumptive term of imprisonment set in such departure shall
36 not total more than double the maximum duration of the presumptive
37 imprisonment term.

38 (c) When a sentencing judge imposes a prison term as a
39 dispositional departure:

40 (1) The judge shall consider and apply the primary purpose of the
41 sentencing guidelines, which is to impose a sentence that is proportionate
42 to the severity of the crime of conviction; and

43 (2) the term of imprisonment shall not exceed the maximum

1 duration of the presumptive imprisonment term listed within the
2 sentencing grid. Any sentence inconsistent with the provisions of this
3 section shall constitute an additional departure and shall require
4 substantial and compelling reasons independent of the reasons given for
5 the dispositional departure.

6 (d) If the sentencing judge imposes a nonprison sentence as a
7 dispositional departure from the guidelines, the recommended duration
8 shall be as provided in subsection (c) of section 248 *of chapter 136 of the*
9 *2010 Session Laws of Kansas*, and amendments thereto.
