1 AN ACT concerning motor vehicles; relating to distinctive license plates;
2 providing for the ducks unlimited license plate.

4 *Be it enacted by the Legislature of the State of Kansas:*

5 Section 1. (a) On and after January 1, 2013, any owner or lessee of
6 one or more passenger vehicles or trucks registered for a gross weight of
7 20,000 pounds or less, who is a resident of Kansas, upon compliance with
8 the provisions of this section, may be issued one ducks unlimited license
9 plate for each such passenger vehicle or truck. Such license plates shall be
10 issued for the same time as other license plates upon proper registration
11 and payment of the regular license fee as provided in K.S.A. 8-143, and
12 amendments thereto, and the presentation of the annual logo use
13 authorization statement provided for in subsection (b).

14 (b) The board of directors of ducks unlimited may authorize the use of
15 their logo to be affixed on license plates as provided by this section. Any
16 royalty payment received pursuant to this section shall be paid to ducks
17 unlimited and shall be used to support ducks unlimited. Any motor vehicle
18 owner or lessee annually may apply to ducks unlimited for the use of such
19 logo. Upon annual application and payment to ducks unlimited in an
20 amount of not less than \$25 nor more than \$100 as a logo use royalty
21 payment for each license plate to be issued, ducks unlimited shall issue to
22 the motor vehicle owner or lessee, without further charge, a logo use
23 authorization statement, which shall be presented by the motor vehicle
24 owner or lessee at the time of registration.

25 (c) Any applicant for a license plate authorized by this section may
26 make application for such plates not less than 60 days prior to such
27 person's renewal of registration date, on a form prescribed and furnished
28 by the director of vehicles, and any applicant for such license plate shall
29 provide the annual logo use authorization statement provided for in
30 subsection (b). Application for registration of a passenger vehicle or truck
31 and issuance of the license plate under this section shall be made by the
32 owner or lessee in a manner prescribed by the director of vehicles upon
33 forms furnished by the director.

34 (d) No registration or license plate issued under this section shall be
35 transferable to any other person.

36 (e) Renewals of registration under this section shall be made annually,

1 upon payment of the fee prescribed in subsection (a), in the manner
2 prescribed in subsection (b) of K.S.A. 8-132, and amendments thereto. No
3 renewal of registration shall be made to any applicant until such applicant
4 provides the annual logo use authorization statement provided for in
5 subsection (b). If such logo use authorization statement is not presented at
6 the time of registration, the applicant shall be required to comply with
7 K.S.A. 8-143, and amendments thereto, and return the license plate to the
8 county treasurer of such person's residence.

9 (f) Ducks unlimited shall:

10 (1) Pay the initial cost of silk-screening for license plates authorized by
11 this section; and

12 (2) provide to all county treasurers a toll-free telephone number where
13 applicants can call ducks unlimited for information concerning the
14 application process or the status of their license plate application.

15 (g) Ducks unlimited, with the approval of the director of vehicles and
16 subject to the availability of materials and equipment, shall design a plate
17 to be issued under the provisions of this section.

18 Sec. 2. This act shall take effect and be in force from and after its
19 publication in the statute book.
