SUBJECT: Virtual Schools

The current virtual school law (KSA 72-3711 et seq.) was amended and approved by the 2008 Kansas Legislature. The law defines virtual school as any school or educational program that (1) is offered for credit; (2) uses distance-learning technologies which predominately use internet-based methods to deliver instruction; (3) involves instruction that occurs asynchronously with the teacher and pupil in separate locations; (4) requires the pupil to make academic progress toward the next grade level and matriculation from kindergarten through high school graduation; (5) requires the pupil to demonstrate competence in subject matter for each class or subject in which the pupil is enrolled as part of the virtual school; and (6) requires age-appropriate pupils to complete state assessment tests.

Statutes provide that school districts must provide adequate training to teachers who teach in virtual schools and programs.

The determination of enrollment in the virtual school or program is based upon the number of hours the pupil was in attendance on a single school day on or before September 19 and on a single school day on or after September 20, but on or before October 4 of each school year.

### FINANCING

Determine the number of hours the pupil was in attendance either on a single day on or before September 19 and a single school day on or after September 20, but on or before October 4. Add the hours together and divide by 12 to determine the full-time equivalent enrollment for the pupil. No pupil shall be counted more than six hours in one school day. The timeframe for determining the number of hours is the highest number of hours of attendance. Multiply the FTE enrollment times the base state aid per pupil times 105 percent.

### ADDITIONAL PROVISIONS

If the school district has an approved at-risk pupil assistance plan, any students who are non-proficient and a program is made available to assist the student, the base state aid per pupil is increased 25 percent.

Under Kansas law, all revenue generated for virtual students must be spent for such programs.

Funding of virtual schools and programs excludes all out-of-state students.

If a pupil is enrolled in at least one advanced placement course provided by a virtual school or program, the school district providing the virtual school or program shall be paid an amount equal to eight percent of the base state aid per pupil for that pupil as additional virtual school state aid. This additional state aid shall be paid in each semester in which the pupil is enrolled in an advanced placement course. This provision does not apply to school districts unless they have 200 square miles or an enrollment of at least 260 pupils.

#### VIRTUAL SCHOOLS AND PROGRAMS

Kansas currently has 13 virtual schools and 75 virtual programs. Approximately half of these virtual schools and programs will accept out-of-district students. School districts can choose whether to operate a virtual school or program. A virtual school has a separate building number and its own administrative staff. A virtual program operates as a program of an existing building and typically shares administrative staff. There is no difference in statutory or Board of Education requirements between virtual school and programs.

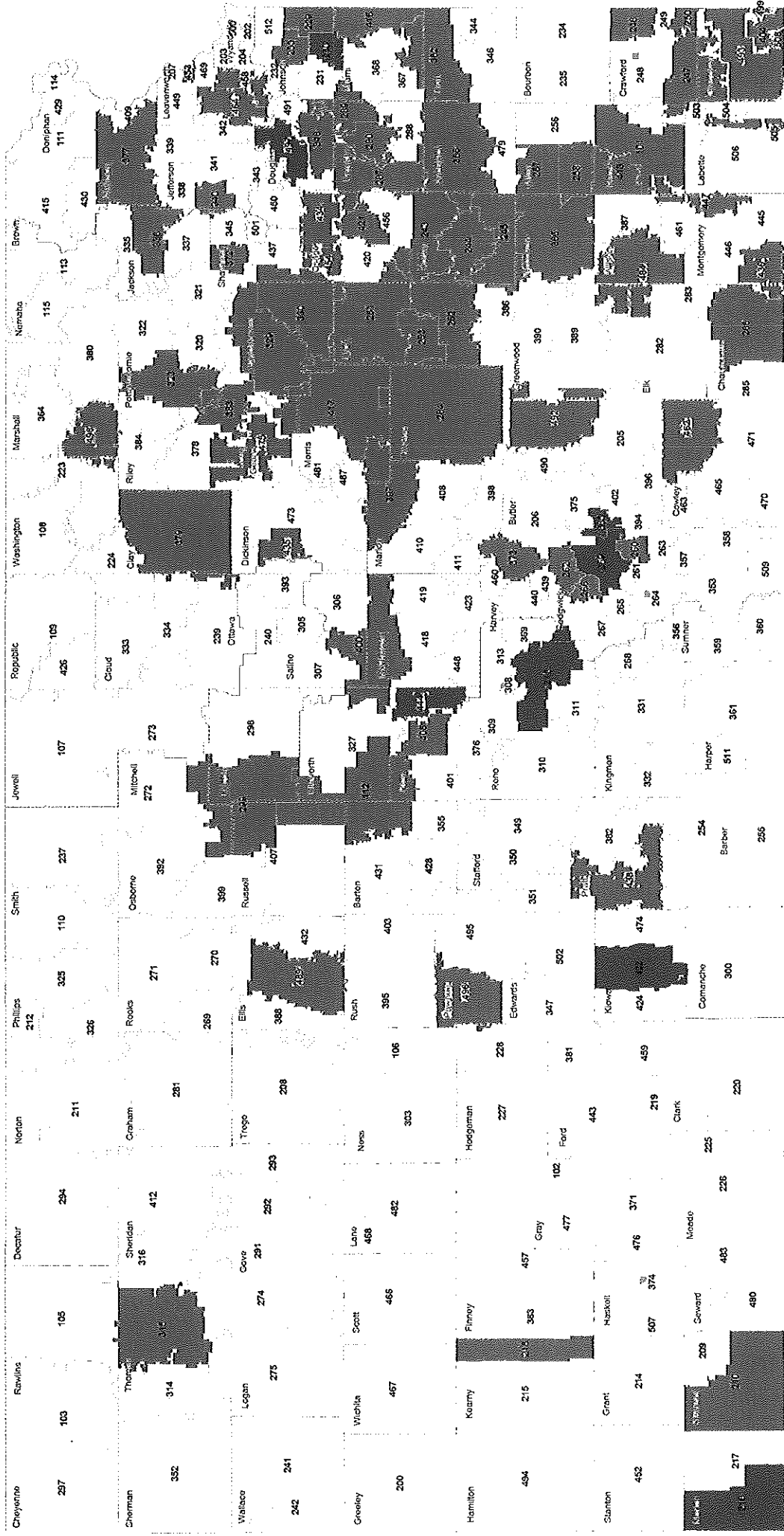
