I. OVERVIEW

A. Turnout

Turnout was lower than the Secretary of State's prediction of 1,200,000 (68%).

332 Total candidates for state & national office (excluding judges; there were 175 judicial candidates)

254 candidates in 2010 (no KS Senate)

337 candidates in 2008, including KS Senate

270 candidates in 2006 (no KS Senate)

309 candidates in 2004, including KS Senate

231 candidates in 2002 (no KS Senate)

Makeup of State Legislature

Senate party breakdown: 32 Republicans, 8 Democrats
In 2008 it was: 31 Republicans, 9 Democrats
In 2004 it was: 30 Republicans, 10 Democrats

House party breakdown: 92 Republicans, 33 Democrats
In 2010 it was: 92 Republicans, 33 Democrats
In 2008 it was: 76 Republicans, 49 Democrats
In 2006 it was: 78 Republicans, 47 Democrats
In 2004 it was: 83 Republicans, 42 Democrats

Write-Ins

Sixteen pairs of write-in candidates for President/Vice President filed affidavits of write-in candidacy. Seven received no votes; the others received vote totals ranging from 1 to 711.

V. RECOUNTS

There were no recounts for national or state offices.

Recounts were conducted for various local offices, mostly county commission and sheriff.

VI. MINOR PARTIES

Maintaining official recognition as a party requires nomination of a candidate for statewide office and at least one such candidate receiving 1% of the vote.

The Americans Elect Party notified the Secretary of State of its intention to cease operations and the party did not nominate any candidates. The party will lose its official recognition.
