Barn overview and justification:

Kansas State University requests director's level approval for a new swine nursery barn at the KSU Swine Teaching and Research Center located north of main campus on Marlett Ave. The nursery barn will allow for more flexibility in young pig housing. Nursery pigs are weaned from their mothers at 3 weeks of age and fed until they reach 10 weeks of age (initially 14 lb. and fed until about 60 lb. of body weight).

Due to improved productivity of sows at the KSU swine farm, sows currently produce approximately 12 pigs per litter compared to 8 pigs per litter when the facility was originally built. It is important to note that this new barn will not replace the current nursery barn, but allow for more space for the increase number of pigs produced. The swine farm currently has a temporary room where the extra pigs are kept that do not "fit" into the original nursery housing area. Finally, due to the current nursery barn design, building a new barn is more feasible then expanding onto the current nursery.

The new nursery barn will contain housing for up to 320 nursery pigs. The barn will be approximately 120' × 35' in size. The barn will be climate controlled by having a natural gas heater maintain requirement temperature for the young pigs. The building will have wall fans that will continuously exhaust to the outside environment excess heat and humidity as needed. Thus, required utilities to the barn will be electricity, water and natural gas. All of these utilities are readily available for hook-up in immediate area of the new barn.

Barn Financials:

The estimated project cost is \$300,000. Fifty percent of the project will be paid from the Department of Animal Sciences Industry sponsored research overhead fund balances and the remainder from allied industry donations given to the KSU Livestock and Meats Industry Council for the swine nutrition program.


The Natural History Reserve Caretaker House

Description

The Natural History Reserve (NHR) is 79 acres of unreclaimed abandoned mine land that is located several miles southwest of the main campus. It was originally covered by tallgrass prairie then converted to agriculture prior to the coal mining era. Mining ceased before the regulation requiring restoration so it was left as a series of parallel spoil banks and over 60 long and narrow strip mine lakes of various sizes. Four of the pits are large, three bordering the property and one within it. The spoils are heavily wooded with a dense shrub layer. Natural succession since the late 1930's has resulted in a brushy woodland type of complex in which cottonwood, Siberian elm, sycamore, sumac, poison ivy, Japanese honeysuckle, and rough-leaved dogwood are common. Many of the smaller pits hold water only intermittently. The large pits hold water permanently, but are subject to water level fluctuations of three to four feet depending on rainfall. The large main strip pit has a floating dock and several fish aquaculture cages used for teaching and research. Several small boats are also kept at this site for work by students and faculty.

The land was known to be mined in the 1930's, and probably mined prior to this decade as well. It was originally deeded to the Kansas Forestry, Fish and Game Commission (now Kansas Department of Wildlife and Parks) in 1936. In 1950 the agency passed it to PSU. Over the years it has been used as a university farm with orchards, an agricultural vocational training area, and a military training area. In the 1960's the Biology Department began managing the property as a site for field research. Since the mid 1980's it has housed raptors as part of the Biology Department's Nature Reach Program.

Four buildings stand on the property, including a newly constructed laboratory and raptor care facility, an old barn (1940s?), an old Quonset hut (1940's?), and a caretaker's house. In addition, newly constructed raptor enclosures sit directly to the North of the new laboratory. The house was built sometime between 1900 and 1920.



Usage

The NHR has a history of use for research, education, and service. An initial aquatic study was published in 1953. Many theses, most recent ones involving fish culture have been conducted on the site or using the site. It is also extensively used in undergraduate and graduate education. Upper division and graduate field biology classes use the reserve for class-related field work. The main pit is used to teach students water quality sampling procedures as well as aquaculture techniques. Terrestrial biology-related classes use the reserve for vegetative studies, mammal tracks and sign collecting, insect collecting, and bird identification.

Most recently, with the construction of the new NHR Laboratory and Raptor Care Facility, the main use of the area has been in association with the PSU Nature Reach Program. Currently nine birds of prey are housed in enclosures in an area directly to the north of the facility.

Justification for an On-Site Caretaker

Because of the attractiveness for wildlife and fishing, several unwelcomed individuals have tried successfully and unsuccessfully to enter the reserve. It is highly likely that hunters and fishermen would illegally trespass on the property and harass or shoot the raptors housed on the property if no caretaker were present. If we were to lose the raptors we would essentially lose the Nature Reach program as they are the most popular animals, and the heart of the program. Moreover, during winter months with large amounts of snow or ice, it is critical for someone to be on site to provide water, food, and protection from the elements. At least two birds must be brought inside when the temperature drops below 25 degrees Fahrenheit.

In addition, the garden, prairie, and picnic area would not be easy to maintain if no caretaker were present on site. Mowing and general maintenance around the laboratory, cages, and house is completed by the caretaker. Again, this is a difficult task to complete without a caretaker as a permanent resident. These areas are critical to successful summer camps and tours.

The Caretaker House

It is estimated that the house is approximately 100 years old. It is has been remodeled twice, most recently in the mid 1980's. It is a two bedroom, one bathroom home with a laundry room, three season porch (unusable due to condition), and carport. Traditionally, the Nature Reach Director has been required to live in the caretaker home. In exchange for caring for and protecting the property, the caretaker lives rent free. Over the years several problems have developed with the aging home. Mark Barnes, Carpentry Supervisor, recently completed an inspection of the home after which he noted the following conditions:

- ✓ The home's exterior shingle siding is an asbestos composition type tile (shingle); there are approximately one hundred damaged tiles on the structure.
- ✓ The roof is composed of organic three-tab shingles that were installed in the early to mid 1980's on the majority of the home, the south porch area is a low slope roof that is covered with rolled type roofing and is in need of replacement every few years due to the low slope situation. The gutter is rusted and in need of repair or replacement.

- ✓ The windows are wood, single pane, double-hung windows that allow air infiltration. In winters past, we have covered the window with plastic sheeting to minimize air infiltration.
- ✓ The dining room floor has an area of approximately 12' x 12' and has suspected termite damage. We had repaired this area in the mid to late 1980's and had to replace the flooring, dig the soil from around the floor joist and replace the floor joists in this southeast corner of the house as well as replace damaged wall framing on the south side of the dining area.
- ✓ The laundry room floor of approximately 5′ x 8′ is in need of leveling and repair. The ceiling shows evidence of moisture damage and is in need of repair.
- ✓ The bathroom floor is showing evidence of settlement and/or moisture damage; the water closet should be removed and the flooring repaired and checked for damage to the floor in the bathtub area. The floor area affected is approximately 7′ x 8′.
- ✓ There is water leaking from the area of the flue in the living room evidenced by ceiling tile.
- ✓ We have removed the ceiling insulation and drywall from the south porch. The rolled roofing is once again in need of replacement and we suspect the leaking may be from the roof valley areas that also drain onto the low slope porch roof. The door and windows on the porch leak air and the door has moisture infiltration when wind driven rains occur from the south.
- ✓ The carport on the house has been braced and repaired over the years. Last year we added a post brace to help prevent the sagging under a snow load. The carport has a very low slope roof.

The current caretaker home has become obsolete because of the very poor condition. As noted above the existing structure has several issues in need of attention and repair or replacement that includes but are not limited to settlement, water intrusion/mold, mechanical system, windows, roofing, electrical system, and plumbing system.

A New Caretaker Home

Pittsburg State University requests authorization to demolish the existing caretaker home and install a new modular home in the same location using the existing utility services. Additionally, the septic system will be upgraded. The cost of abatement and demolition of the existing house, septic system upgrade, installation of a concrete foundation, and the new modular home and installation will be entirely funded by private gifts through the PSU Foundation. The total project cost is estimated at \$80,000.

Request authorization to amend the list of the Rehabilitation and Repair projects authorized for the University of Kansas Lawrence Campus and KUMC for FY 13 to include:

Lawrence Campus

Laboratory Remodel, Malott Hall: \$400,000.00

Request approval to remodel the laboratory in rooms 5012, 5014, 5014a, and 5016 in Malott Hall for the Department of Chemistry. This project is funded with KU Center for Research funds.

Remove Shelving, Wescoe Hall: \$19,000.00

Request approval to remove remaining shelving in room 4070 in Wescoe Hall for the Academic Resource Center. This project is funded with Restricted Fees funds.

Create Catering Pantry and Additional Storage, Dole Institute of Politics: \$11,000.00
Request approval to create a catering pantry and additional storage in an existing storage area in the Dole Institute of Politics. This project is funded with Tuition funds.

Reconstruction of Circle Drive, Landscape Zone F2: \$172,000.00

Request approval to reconstruct the circle drive to the west of Murphy Hall to comply with the Americans with Disabilities Act (ADA). This project is funded with Parking Facilities Surplus funds.

Request approval to re-roof the Sutherland Institute. The scope of the project includes the installation of a new thermoplastic polyolefin roof over preparation of the existing roof, sheet metal perimeter trim, and downspouts. This project is funded with Tuition funds.

Biochemistry Expansion, Wahl West: \$55,000.00

Request approval to construct a new office along the north window in rooms 4013-4015 in Wahl West for to expand Biochemistry to re-roof the Sutherland Institute. This will also provide an opening back to the laboratory in room 4013. The project is funded with General Fund Appropriation for Operating Expenditure funds.

Laboratory Renovation, Orr Major: \$45,000.00

*15th & Naismith Intersection Reconstruction: The condition of the intersection has deteriorated causing increased maintenance to transit vehicles and the University is at risk for potential damage to vehicles and bikes. The condition of the pavement would become impassable after another winter season. The project would replace a waterline, waterproof the section of the tunnel under the road and reconstruct the intersection with concrete pavement.

**Murphy Hall Swarthout Recital Hall: The architectural program was previously sent to the Board for FY 2012 Capital Improvements and approved. The \$250,000 is a portion of the \$1.4 million in funding for the project. The balance in funding will be private gift. We plan to use the EBF for paying costs related to deferred maintenance such as furnish mechanical equipment, building automated controls, and light fixtures.

*** Jayhawk Blvd Reconstruction - Tunnel Improvements: In phase 1 of the reconstruction there are two sections of tunnel that will need repair. The tunnel running south of the main entry of Snow Hall will be uncovered, spot structural repair to the exterior of the tunnel and complete waterproofing of the exterior of the tunnel. The sidewalk going west from the entry of Show Hall is the tunnel top. This is the only location on campus where this occurs. A portion of the tunnel top near Snow Hall experienced a release of two inches of concrete into the tunnel. There are other signs of deterioration that will eventually result in failure. This portion of the project would remove the tunnel top (sidewalk portion), recast a new tunnel top, waterproof this section of the tunnel and pour a new sidewalk above the tunnel top. This work would include abatement of asbestos and reinstallation of steam anchors and lighting in the tunnel.
