SUBJECT:

SB 246, Reconciling amendments to certain statutes

Senate Bill 246 reconciles amendments to statutes, which have been amended more than once during the current legislative session or during a prior legislative session. The purpose of the reconciliation bill is to combine non-contradictory amendments from enacted legislation to produce one version of the statute.

Amendatory Sections for Statutes Amended More than Once

When two or more bills amend the same statute with different amendments, such amendments must be reconciled to resolve having two versions of the same statute. SB 246 addresses such issues in sections 1 through 36.
