STATE	ACTION	PURPOSE
Alabama	<u>SB 190</u>	Prohibit State Board from adopting Common Core
Alabama	<u>SB 403</u>	Companion bill to SB190 to prohibit adoption of CCS
Alabama	<u>HB 565</u>	Declaring State Board decides standards—not Federal
Georgia	<u>SB 167</u>	Declaring adoption of CCS to be void ab initio + defunds
Georgia	<u>GOP Res.</u>	GOP Resolution passed to stop CCS in Georgia schools
Indiana	<u>SB 0193</u>	VOIDS any action to adopt the Common Core Standards
Indiana	<u>HB 1427</u>	Stops implementation of CCS until hearing held + costs known
Kansas	<u>HB 2289</u>	No state or local tax dollars shall be used to implement CCS
Louisiana	<u>SCR 68</u>	Requests State Board stop implementing CCS in schools
Michigan	<u>HB 4328</u>	Budget Proviso to defund implementation of Common Core
Michigan	<u>HB 4276</u>	Prohibits implementation of Common Core
Missouri	<u>SB 210</u>	State Board shall not implement Common Core
New Hampshire	<u>HB 164</u>	Legislature must approve adoption of Common Core
North Carolina	<u>Proviso</u>	Budget Proviso to stop any CCS national assessments
Oklahoma	<u>HB 1907</u>	Creating Common Core Task Force to study CCS implications
Pennsylvania	<u>Gov. Ex. Order</u>	Governor order delay in implementing Common Core
RNC	<u>Resolution</u>	Republican National Committee Resolution to stop CCS
South Carolina	<u>S. 604</u>	CCS may not be imposed on South Carolina schools
South Carolina	<u>HB 718</u>	Study short and long-range impact of CCS costs & regulations
South Carolina	<u>H. 3943</u>	State Board shall not implement Common Core
South Dakota	<u>HB 1204</u>	Requires State Board to receive Legislative approval to adopt
Texas	<u>HB 2923</u>	State Sovereignty over curriculum
Texas	<u>HB 462</u>	Prohibits school districts from using Common Core Standards
Utah	<u>S.C.R. 13</u>	Asks State Board to reconsider adoption of Common Core
Utah	<u>GOP Res.</u>	GOP Resolution passed 65% to 35% to stop CCS in Utah
Washington	<u>HB 1891</u>	Delay implementation of Common Core
Wisconsin	<u>Joint Hrg.</u>	House & Senate Ed. Cmte. hearing on Pros & Cons of CCS
Virginia		Refused to adopt the Common Core Standards
Nebraska		Refused to adopt the Common Core Standards
Texas		Refused to adopt the Common Core Standards
Alaska		Refused to adopt the Common Core Standards
Minnesota		Only adopted the CCS English Standards
