

## HOUSE BILL No. 2144

1 AN ACT concerning children and minors; relating to the repeal of  
2 outdated provisions concerning juveniles; amending K.S.A. 2012 Supp.  
3 45-229 and repealing the existing section; also repealing K.S.A. 2012  
4 Supp. 38-1604, 38-1608 and 38-1664.  
5

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. K.S.A. 2012 Supp. 45-229 is hereby amended to read as  
8 follows: 45-229. (a) It is the intent of the legislature that exceptions to  
9 disclosure under the open records act shall be created or maintained only  
10 if:

11 (1) The public record is of a sensitive or personal nature concerning  
12 individuals;

13 (2) the public record is necessary for the effective and efficient  
14 administration of a governmental program; or

15 (3) the public record affects confidential information.

16 The maintenance or creation of an exception to disclosure must be  
17 compelled as measured by these criteria. Further, the legislature finds that  
18 the public has a right to have access to public records unless the criteria in  
19 this section for restricting such access to a public record are met and the  
20 criteria are considered during legislative review in connection with the  
21 particular exception to disclosure to be significant enough to override the  
22 strong public policy of open government. To strengthen the policy of open  
23 government, the legislature shall consider the criteria in this section before  
24 enacting an exception to disclosure.

25 (b) Subject to the provisions of subsection (h), all exceptions to  
26 disclosure in existence on July 1, 2000, shall expire on July 1, 2005, and  
27 any new exception to disclosure or substantial amendment of an existing  
28 exception shall expire on July 1 of the fifth year after enactment of the  
29 new exception or substantial amendment, unless the legislature acts to  
30 continue the exception. A law that enacts a new exception or substantially  
31 amends an existing exception shall state that the exception expires at the  
32 end of five years and that the exception shall be reviewed by the  
33 legislature before the scheduled date.

34 (c) For purposes of this section, an exception is substantially  
35 amended if the amendment expands the scope of the exception to include  
36 more records or information. An exception is not substantially amended if

1 the amendment narrows the scope of the exception.

2 (d) This section is not intended to repeal an exception that has been  
3 amended following legislative review before the scheduled repeal of the  
4 exception if the exception is not substantially amended as a result of the  
5 review.

6 (e) In the year before the expiration of an exception, the revisor of  
7 statutes shall certify to the president of the senate and the speaker of the  
8 house of representatives, by July 15, the language and statutory citation of  
9 each exception which will expire in the following year which meets the  
10 criteria of an exception as defined in this section. Any exception that is not  
11 identified and certified to the president of the senate and the speaker of the  
12 house of representatives is not subject to legislative review and shall not  
13 expire. If the revisor of statutes fails to certify an exception that the revisor  
14 subsequently determines should have been certified, the revisor shall  
15 include the exception in the following year's certification after that  
16 determination.

17 (f) "Exception" means any provision of law which creates an  
18 exception to disclosure or limits disclosure under the open records act  
19 pursuant to K.S.A. 45-221, and amendments thereto, or pursuant to any  
20 other provision of law.

21 (g) A provision of law which creates or amends an exception to  
22 disclosure under the open records law shall not be subject to review and  
23 expiration under this act if such provision:

24 (1) Is required by federal law;

25 (2) applies solely to the legislature or to the state court system.

26 (h) (1) The legislature shall review the exception before its scheduled  
27 expiration and consider as part of the review process the following:

28 (A) What specific records are affected by the exception;

29 (B) whom does the exception uniquely affect, as opposed to the  
30 general public;

31 (C) what is the identifiable public purpose or goal of the exception;

32 *and*

33 (D) whether the information contained in the records may be obtained  
34 readily by alternative means and how it may be obtained;

35 (2) an exception may be created or maintained only if it serves an  
36 identifiable public purpose and may be no broader than is necessary to  
37 meet the public purpose it serves. An identifiable public purpose is served  
38 if the legislature finds that the purpose is sufficiently compelling to  
39 override the strong public policy of open government and cannot be  
40 accomplished without the exception and if the exception:

41 (A) Allows the effective and efficient administration of a  
42 governmental program, which administration would be significantly  
43 impaired without the exception;

1 (B) protects information of a sensitive personal nature concerning  
2 individuals, the release of which information would be defamatory to such  
3 individuals or cause unwarranted damage to the good name or reputation  
4 of such individuals or would jeopardize the safety of such individuals.  
5 Only information that would identify the individuals may be excepted  
6 under this paragraph; or

7 (C) protects information of a confidential nature concerning entities,  
8 including, but not limited to, a formula, pattern, device, combination of  
9 devices, or compilation of information which is used to protect or further a  
10 business advantage over those who do not know or use it, the disclosure of  
11 which information would injure the affected entity in the marketplace.

12 (3) Records made before the date of the expiration of an exception  
13 shall be subject to disclosure as otherwise provided by law. In deciding  
14 whether the records shall be made public, the legislature shall consider  
15 whether the damage or loss to persons or entities uniquely affected by the  
16 exception of the type specified in paragraph (2)(B) or (2)(C) of this  
17 subsection (h) would occur if the records were made public.
