1 AN ACT making and concerning appropriations for the fiscal years ending  
2 June 30, 2014 and June 30, 2015, for the Kansas department for aging  
3 and disability services; relating to home and community based services  
4 I/DD waiver.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. (a) For the fiscal years ending June 30, 2014, and June 30,  
8 2015, appropriations are hereby made, restrictions and limitations are  
9 hereby imposed, and transfers, capital improvement projects, fees,  
10 receipts, disbursements and acts incidental to the foregoing are hereby  
11 directed or authorized as provided in this act.

12 (b) This act shall not be subject to the provisions of subsection (a) of  
13 K.S.A. 75-6702, and amendments thereto.

14 (c) The appropriations made by this act shall not be subject to the  
15 provisions of K.S.A. 46-155, and amendments thereto.

17 **KANSAS DEPARTMENT FOR AGING AND DISABILITY SERVICES**

18 (a) There is appropriated for the above agency from the state general  
19 fund for the fiscal years specified the following:

26 Any unencumbered balance in excess of \$100 as of June 30, 2014, in  
27 each of the following accounts is hereby reappropriated for fiscal year  
28 2015:

29 Community based services – waiting list – I/DD; community based  
30 services – system capacity building – I/DD. Any unencumbered balance in  
31 excess of \$100 as of June 30, 2015, in each of the following accounts is  
32 hereby reappropriated for fiscal year 2016:

33 Community based services – waiting list – I/DD; community based  
34 services – system capacity building – I/DD.

35 (b) During the fiscal year ending June 30, 2014, and the fiscal year  
36 ending June 30, 2015, all expenditures by the Kansas department for aging

1 and disability services from the community based services – waiting list –  
2 I/DD account of the state general fund shall be for the purposes of  
3 providing services for persons on the waiting list for the home and  
4 community based services waiver for persons with developmental  
5 disabilities.

6 (c) During the fiscal year ending June 30, 2014, and the fiscal year  
7 ending June 30, 2015, all expenditures by the Kansas department for aging  
8 and disability services from the community based services – system  
9 capacity building – I/DD account of the state general fund shall be for  
10 increased rates of payment to service providers under the home and  
11 community based services waiver for persons with developmental  
12 disabilities.

13 Sec. 3. This act shall take effect and be in force from and after its  
14 publication in the statute book.
