1 AN ACT concerning domestic relations; relating to the Kansas family law  
2 code; child support guidelines; amending K.S.A. 2013 Supp. 20-165,  
3 23-2201, ~~23-2215~~, **23-2215**, 23-2216, 23-2223, 23-2224, 23-2707, 23-  
4 3002, 23-3005 and 23-3203 and repealing the existing sections; also  
5 repealing K.S.A. 2013 Supp. 23-2217, 23-2218 and 23-2225.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. K.S.A. 2013 Supp. 20-165 is hereby amended to read as  
9 follows: 20-165. (a) The supreme court shall adopt rules establishing  
10 guidelines for the amount of child support to be ordered in any action in  
11 this state including, but not limited to, K.S.A. 39-755 and K.S.A. 2013  
12 Supp. 23-2215, and amendments thereto, article 30 of chapter 23 of the  
13 Kansas Statutes Annotated, and amendments thereto, and K.S.A. 2013  
14 Supp. 23-2711, and amendments thereto.

15 (b) In adopting such rules, the court shall consider ~~the criteria in~~  
16 ~~K.S.A. 2013 Supp. 23-2215, and amendments thereto~~ *all relevant factors,*  
17 *including, but not limited to:*

- 18 (1) *The needs of the child;*
- 19 (2) *the standards of living and circumstances of the parents;*
- 20 (3) *the relative financial means of the parents;*
- 21 (4) *the earning ability of the parents;*
- 22 (5) *the need and capacity of the child for education;*
- 23 (6) *the age of the child;*
- 24 (7) *the financial resources and earning ability of the child;*
- 25 (8) *the responsibility of the parents for the support of others; and*
- 26 (9) *the value of services contributed by both parents.*

2 existence or nonexistence of the parent and child relationship is  
3 determinative for all purposes, but if any person necessary to determine  
4 the existence of a father and child relationship for all purposes has not  
5 been joined as a party, a determination of the paternity of the child shall  
6 have only the force and effect of a finding of fact necessary to determine a  
7 party's duty of support.

8 (b) If the judgment or order of the court is at variance with the child's  
9 birth certificate, the court shall order that a new birth certificate be issued,  
10 but only if any man named as the father on the birth certificate is a party to  
11 the action.

12 (c) Upon adjudging that a party is the parent of a minor child, the

20 *by written agreement approved by the court, to pay support beyond that*  
21 *time; (2) the child reaches 18 years of age before completing the child's*  
22 *high school education in which case the support shall not automatically*  
23 *terminate, unless otherwise ordered by the court, until June 30 of the*  
24 *school year during which the child became 18 years of age if the child is*  
25 *still attending high school; or (3) the child is still a bona fide high school*  
26 *student after June 30 of the school year during which the child became 18*  
27 *years of age, in which case the court, on motion, may order support to*  
28 *continue through the school year during which the child becomes 19 years*  
29 *of age so long as the child is a bona fide high school student and the*  
30 *parents jointly participated or knowingly acquiesced in the decision which*  
31 *delayed the child's completion of high school. The court, in extending*  
32 *support pursuant to subsection (c)(3), may impose such conditions as are*  
33 *appropriate and shall set the child support utilizing the guideline table*  
34 *category for 16-year through 18-year-old children. Provision for payment*  
35 *of support and educational expenses of a child after reaching 18 years of*  
36 *age if still attending high school shall apply to any child subject to the*  
37 *jurisdiction of the court, including those whose support was ordered prior*  
38 *to July 1, 1992. If an agreement approved by the court prior to July 1,*  
39 *1988, provides for termination of support before the date provided by*  
40 *subsection (c)(2), the court may review and modify such agreement, and*  
41 *any order based on such agreement, to extend the date for termination of*  
42 *support to the date provided by subsection (c)(2). If an agreement*  
43 *approved by the court prior to July 1, 1992, provides for termination of*

1 support before the date provided by subsection (c)(3), the court may  
2 review and modify such agreement, and any order based on such  
3 agreement, to extend the date for termination of support to the date  
4 provided by subsection (c)(3). For purposes of this section, "bona fide high  
5 school student" means a student who is enrolled in full accordance with  
6 the policy of the accredited high school in which the student is pursuing a  
7 high school diploma or a graduate equivalency diploma (GED). The  
8 judgment may require the party to provide a bond with sureties to secure  
9 payment. The court may at any time during the minority of the child  
10 modify or change the order of support, including any order issued in a title  
11 IV-D case, within three years of the date of the original order or a  
12 modification order, as required by the best interest of the child. If more  
13 than three years has passed since the date of the original order or  
14 modification order, a requirement that such order is in the best interest of  
15 the child need not be shown. The court may make a modification of  
16 support retroactive to a date at least one month after the date that the  
17 motion to modify was filed with the court. Any increase in support ordered  
18 effective prior to the date the court's judgment is filed shall not become a  
19 lien on real property pursuant to K.S.A. 60-2202, and amendments thereto.

20 (d) If both parents are parties to the action, the court shall enter such  
21 orders regarding *for legal* custody, residency and parenting time as the  
22 court considers to be in the best interest of the child *under article 32 of*  
23 *chapter 23 of the Kansas Statutes Annotated, and amendments thereto.*

24 If the parties have an agreed parenting plan it shall be presumed the  
25 agreed parenting plan is in the best interest of the child. This presumption  
26 may be overcome and the court may make a different order if the court  
27 makes specific findings of fact stating why the agreed parenting plan is not  
28 in the best interest of the child. If the parties are not in agreement on a  
29 parenting plan, each party shall submit a proposed parenting plan to the  
30 court for consideration at such time before the final hearing as may be  
31 directed by the court.

40 remain in home is contrary to the welfare of the child; or (C) immediate

1 emergency exists which threatens the safety of the child. In making such a  
2 residency order, the court shall give preference, to the extent that the court  
3 finds it is in the best interests of the child, first to awarding such residency  
4 to a relative of the child by blood, marriage or adoption and second to  
5 awarding such residency to another person with whom the child has close  
6 emotional ties. The court may make temporary orders for care, support,  
7 education and visitation that it considers appropriate. Temporary residency  
8 orders are to be entered in lieu of temporary orders provided for in K.S.A.  
9 2013 Supp. 38-2243 and 38-2244, and amendments thereto, and shall  
10 remain in effect until there is a final determination under the revised  
11 Kansas code for care of children. An award of temporary residency under  
12 this paragraph shall not terminate parental rights nor give the court the  
13 authority to consent to the adoption of the child. When the court enters  
14 orders awarding temporary residency of the child to an agency or a person  
15 other than the parent, the court shall refer a transcript of the proceedings to  
16 the county or district attorney. The county or district attorney shall file a  
17 petition as provided in K.S.A. 2013 Supp. 38-2234, and amendments  
18 thereto, and may request termination of parental rights pursuant to K.S.A.  
19 2013 Supp. 38-2266, and amendments thereto. The costs of the  
20 proceedings shall be paid from the general fund of the county. If a final  
21 determination is made that the child is not a child in need of care, the  
22 county or district attorney shall notify the court in writing and the court,  
23 after a hearing, shall enter appropriate custody orders pursuant to this  
24 section. If the same judge presides over both proceedings, the notice is not  
25 required. Any order pursuant to the revised Kansas code for care of  
26 children shall take precedence over any similar order under this section.

11 *directly to the attorney, who may enforce the order in the attorney's name*  
12 *in the same case.*

15       *(c) The court may order other expenses of the action, including blood*  
16 *genetic tests, to be paid by the parties in proportions and at times*

27 follows: 23-2223. *(a) Whenever the parents of a minor child desire that the*  
28 *child's birth certificate be amended to add the name of a parent, correct the*  
29 *name of either parent or of the child or change the child's last name to that*  
30 *of either parent, both parents shall appear before a judge of the district*  
31 *court or a hearing officer authorized by rule of the supreme court to accept*  
32 *voluntary acknowledgments of parentage. The parents shall execute*  
33 *affidavits in the presence of the judge or hearing officer, attesting to the*  
34 *fact that each is a parent of the child and that they desire to amend the*  
35 *birth registration of the child. If both parents are not residents of this state*  
36 *and are outside this state, both parents shall forward to such judge or*  
37 *hearing officer affidavits, sworn to before a judicial officer of the state in*  
38 *which they reside and attesting to the fact that each is a parent of the child*  
39 *and that they desire to amend the birth registration of the child.*
