1 AN ACT making and concerning appropriations for the fiscal years ending  
2 June 30, 2015, June 30, 2016, June 30, 2017, and June 30, 2018, for the  
3 Kansas department for aging and disability services; relating to home  
4 and community based services I/DD waiver.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. (a) For the fiscal years ending June 30, 2015, June 30,  
8 2016, June 30, 2017, and June 30, 2018, appropriations are hereby made,  
9 restrictions and limitations are hereby imposed, and transfers, fees,  
10 receipts, disbursements and acts incidental to the foregoing are hereby  
11 directed or authorized as provided in this act.

12 (b) This act shall not be subject to the provisions of subsection (a) of  
13 K.S.A. 75-6702, and amendments thereto.

14 (c) The appropriations made by this act shall not be subject to the  
15 provisions of K.S.A. 46-155, and amendments thereto.
