14 *Be it enacted by the Legislature of the State of Kansas:*

15 New Section 1. (a) This act shall be known and may be cited as the  
16 business entity standard treatment act.

17 (b) The provisions of this act shall apply to all documents related to  
18 corporations, limited liability companies, limited partnerships and limited  
19 liability partnerships required to be filed with the secretary of state  
20 pursuant to this act.

21 (c) This section shall take effect on and after January 1, 2015.

22 New Sec. 2. As used in this act:

23 (a) "Covered entity" means:

- 24 (1) A corporation;  
25 (2) a limited partnership;  
26 (3) a limited liability partnership; and  
27 (4) a limited liability company.

28 (b) "Foreign covered entity" means a covered entity whose internal  
29 affairs are governed by the laws of a jurisdiction other than this state.

30 (c) "Public organic document" means the filing of the public record  
31 which creates an entity and any amendment to or restatement of that  
32 record.

33 (d) "Governor" means a person by or under whose authority the  
34 powers of an entity are exercised and under whose direction the business  
35 and affairs of the entity are managed pursuant to the organic law and  
36 organic rules of the entity.

1 (e) "Organic law" means the statutes, if any, other than this act,  
2 governing the internal affairs of a covered entity.

3 (f) "Organic rules" means the public organic document and private  
4 organic rules of an entity.

5 (g) This section shall take effect on and after January 1, 2015.

13 New Sec. 7. ~~(a) The secretary of state shall by rules and regulations  
14 establish fees, but not exceeding \$50 in addition to a reasonable fee per  
15 page, for issuing certified copies, photocopies, certificates of good  
16 standing, certificates of fact and any other certificate or filing for which a  
17 filing or indexing fee is not prescribed by law.~~

18 ~~(b) The secretary of state shall establish a reasonable fee for a report  
19 of record search, but furnishing the following information shall not be  
20 considered a record search and no charge shall be made therefor: Name of  
21 the entity and the address of its registered office; name and address of the  
22 resident agent; the amount of its authorized capital stock, if any; the state  
23 of the entity's formation; the date of filing of its public organic document  
24 or annual report; and the date of expiration.~~

25 ~~(c) The secretary of state shall prescribe by rules and regulations any  
26 fees required by this act.~~

27 ~~(d)~~ The secretary of state is hereby authorized to adopt such rules and  
28 regulations as may be necessary to carry out the provisions of this act. No  
29 rule and regulation adopted pursuant to this section shall take effect prior  
30 to January 1, 2015.

31 New Sec. 8. All documents required by this act to be filed with the  
32 secretary of state shall be executed as follows:

33 (a) Documents related to corporations shall be executed in the  
34 following manner:

35 (1) The articles of incorporation for all corporations shall be signed  
36 by the incorporator or incorporators, and any other document to be filed  
37 before the election of the initial board of directors, if the initial directors  
38 were not named in the articles of incorporation, shall be signed by the  
39 incorporator or incorporators. If any incorporator is not available by reason  
40 of death, incapacity or refusal or neglect to act, then the document may be  
41 signed by any person for whom or on whose behalf such incorporator was  
42 acting as an employee or agent. The document shall state that the  
43 incorporator is not available and the reason therefore, that such

1 incorporator was acting as an employee or agent for or on behalf of such  
2 person and that such person's signature is authorized.

3 (2) All documents related to a corporation that are not addressed by  
4 subsection (a)(1), shall be signed: (A) By any authorized officer of the  
5 corporation; (B) if it appears from the document that there are no such  
6 officers, by a majority of the directors or by such directors as may be  
7 designated by the board; (C) if it appears from the document that there are  
8 no such officers or directors, by the holders of record, or such of them as  
9 may be designated by the holders of record, of a majority of all  
10 outstanding shares of stock; or (D) by the holders of record of all  
11 outstanding shares of stock.

12 (b) Documents related to limited liability companies shall be  
13 executed in the following manner: All documents shall be signed by one or  
14 more authorized persons. Unless otherwise provided in an operating  
15 agreement, any person may sign the articles, any certificate, any  
16 amendment thereof, or enter into an operating agreement or amendment  
17 thereof by an agent.

18 (c) Documents related to limited partnerships shall be executed in the  
19 following manner:

20 (1) An initial certificate of limited partnership must be signed by all  
21 general partners;

22 (2) a certificate of amendment must be signed by at least one general  
23 partner and by each other general partner who is designated in the  
24 certificate of amendment as a new general partner; and

25 (3) a certificate of cancellation must be signed by all general partners  
26 or, if there is no general partner, by a majority of the limited partners.

27 (d) Documents related to limited liability partnerships shall be  
28 executed by an authorized person.

29 (e) This section shall take effect on and after January 1, 2015.

30 New Sec. 9. (a) The execution of any document required to be filed  
31 by chapter 17 of the Kansas Statutes Annotated, and amendments thereto,  
32 and by this act with the secretary of state shall constitute an oath or  
33 affirmation, under the penalties of perjury, that the facts stated in the  
34 document are true and that any power of attorney used in connection with  
35 the execution is in proper form and substance.

36 (b) This section shall take effect on and after January 1, 2015.

37 New Sec. 10. When any document is required by this act to be filed  
38 with the secretary of state, such requirement means that:

39 (a) The original signed document shall be delivered to the office of  
40 the secretary of state, where the document shall be recorded in an  
41 electronic medium. Any signature on documents authorized to be filed  
42 with the secretary of state under the provisions of this act may be a  
43 facsimile, a conformed signature or an electronically transmitted signature;



1 (b) all taxes and fees authorized by law to be collected by the  
2 secretary of state in connection with the filing of the document shall be  
3 tendered to the secretary of state;

4 (c) upon delivery of the document, and upon tender of the required  
5 taxes and fees, the secretary of state shall certify that the document has  
6 been filed in the office of the secretary of state by endorsing upon the  
7 electronically-recorded document the word "Filed" and the date and hour  
8 of its filing. This endorsement is the "filing date" of the document and is  
9 conclusive of the date and time of its filing in the absence of actual fraud.  
10 The secretary of state shall thereupon record the endorsed document in an  
11 electronic medium and that electronic document shall become the original  
12 document; and

13 (d) the secretary of state shall return a certified copy of the recorded  
14 document to the person who filed the document or that person's  
15 representative, except this provision shall not apply to annual reports.

16 (e) This section shall take effect on and after January 1, 2015.

17 New Sec. 11. Any document that is required by this act to be filed  
18 with the secretary of state shall be effective upon its filing date. Any  
19 document may provide that it is not to become effective until a specified  
20 date subsequent to its filing date, but such date shall not be later than 90  
21 days after its filing date. If any document filed in accordance with this act  
22 provides for a future effective date and the transaction is terminated or its  
23 terms are amended to change the future effective date prior to the future  
24 effective date, the document shall be terminated or amended by the filing,  
25 prior to the future effective date, of a certificate of termination or a  
26 certificate of amendment of the original document, executed and filed in  
27 accordance with this section. The certificate shall identify the document  
28 which has been terminated or amended, and shall state that the document  
29 has been terminated or the manner in which it has been amended.

30 This section shall take effect on and after January 1, 2015.

31 New Sec. 12. When any document that is required by this act to be  
32 filed with the secretary of state has been so filed and is an inaccurate  
33 record of the covered entity action therein referred to, or was defectively  
34 or erroneously executed, such document may be corrected by filing with  
35 the secretary of state a certificate of correction of such document which  
36 shall be executed and filed in accordance with this act. The certificate of  
37 correction shall specify the inaccuracy or defect to be corrected and shall  
38 set forth the portion of the document in corrected form. In lieu of filing a  
39 certificate of correction, the document may be corrected by filing with the  
40 secretary of state a corrected document which shall be executed and filed  
41 in accordance with this act. A fee equal to the fee payable to the secretary  
42 of state if the document being corrected were then being filed shall be paid  
43 and collected by the secretary of state. The corrected document shall be

1 specifically designated as such in its heading, shall specify the inaccuracy  
2 or defect to be corrected, and shall set forth the entire document in  
3 corrected form. A document corrected in accordance with this section shall  
4 be effective as of the date the original document was filed, except as to  
5 those persons who are substantially and adversely affected by the  
6 correction and as to those persons, the corrected document shall be  
7 effective from the filing date.

8 This section shall take effect on and after January 1, 2015.

9 New Sec. 13. The secretary of state is not required to file any  
10 document that the secretary of state finds, on its face, does not conform to  
11 law. If any document required to be filed by this act with the secretary of  
12 state is filed and is inaccurately, defectively or erroneously executed or  
13 otherwise defective in any respect, the secretary of state shall not be liable  
14 to any person for the preclearance for filing, the acceptance for filing or  
15 the filing and indexing of such document.

16 This section shall take effect on and after January 1, 2015.

17 New Sec. 14. (a) Any document required to be filed by this act with  
18 the secretary of state may be filed by telefacsimile communication. If such  
19 telefacsimile communication is accompanied with the appropriate fees,  
20 and meets the statutory requirements, it shall be effective upon its filing  
21 date or future effective date as prescribed in the document. The secretary  
22 of state shall prescribe a telefacsimile communication fee in addition to  
23 any filing fees to cover the cost of the services. The fee must be paid prior  
24 to acceptance of a telefacsimile communication under this section. The  
25 telefacsimile communication fee shall be deposited into the information  
26 and services fee fund.

27 (b) As used in this act, "telefacsimile communication" means the use  
28 of electronic equipment to send or transfer a document. This section shall  
29 not be construed so as to require the secretary of state to accept any filing  
30 through electronic mail. The secretary of state may designate acceptable  
31 types or formats of telefacsimile communication for filing documents  
32 pursuant to this act.

33 (c) This section shall take effect on and after January 1, 2015.

34 New Sec. 15. Service of process in any action against a covered  
35 entity shall be made in the manner described in K.S.A. 60-304, and  
36 amendments thereto.

37 This section shall take effect on and after January 1, 2015.

38 New Sec. 16. Any person may sign any document filed with the  
39 secretary of state pursuant to this act by an attorney-in-fact, but a power of  
40 attorney to sign a certificate relating to the admission of a general partner  
41 must describe the admission. Powers of attorney relating to the signing of  
42 a document by an attorney-in-fact need not be filed in the office of the  
43 secretary of state but must be retained by the covered entity.

1 This section shall take effect on and after January 1, 2015.

2 New Sec. 17. If a person required by this act to execute any document  
3 fails or refuses to do so, any other person who is adversely affected by the  
4 failure or refusal may petition the district court to direct the execution of  
5 the document. If the court finds that it is proper for the document to be  
6 executed and that the person required to execute the document has failed  
7 or refused to do so, the court shall order the secretary of state to record an
