1 AN ACT concerning courts; relating to docket fees; amending K.S.A. 60-
2 729 ~~and 61-3502~~ and K.S.A. 2013 Supp. 20-367, 21-6614, 22-2410,
3 28-172a, 38-2312, 59-104, 60-256, 60-2001 and 61-2704 and repealing
4 the existing sections; also repealing K.S.A. 2013 Supp. 21-6614d, 38-
5 2312c and 60-2001b.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 New Section 1. (a) (1) On and after July 1, 2014, any party filing an
9 appeal with the court of appeals shall pay a fee in the amount of \$145 to
10 the clerk of the supreme court.

11 (2) On and after July 1, 2014, any party filing an appeal with the
12 supreme court shall pay a fee in the amount of \$145 to the clerk of the
13 supreme court.

14 (b) A poverty affidavit may be filed in lieu of a fee as established in
15 K.S.A. 60-2001, and amendments thereto.

16 (c) The fee shall be the only costs assessed in each case to services of
17 the clerk of the supreme court. The clerk of the supreme court shall remit
18 all revenues received from this section to the state treasurer, in accordance
19 with the provisions of K.S.A. 75-4215, and amendments thereto, for
20 deposit in the state treasury. The fee shall be disbursed in accordance with
21 subsection (f) of K.S.A. 20-362, and amendments thereto.

22 (d) Except as provided further, the fee established in this section shall
23 be the only fee collected or moneys in the nature of a fee collected for the
24 docket fee. Such fee shall only be established by an act of the legislature
25 and no other authority is established by law or otherwise to collect a fee.
26 On and after July 1, 2014, through July 1, 2015, the supreme court may
27 impose an additional charge, not to exceed \$10 per fee, to fund the costs of
28 non-judicial personnel.

29 New Sec. 2. There is hereby created in the state treasury the
30 electronic filing and *centralized case* management fund. All expenditures
31 from the electronic filing and *centralized case* management fund shall be
32 for purposes of creating, implementing and managing an electronic filing
33 and *centralized case* management system for the state court system and
34 shall be made in accordance with appropriation acts upon warrants of the
35 director of accounts and reports issued pursuant to vouchers approved by
36 the chief justice of the supreme court or by a person designated by the

1 chief justice.

17 Sec. 4. K.S.A. 2013 Supp. 21-6614 is hereby amended to read as
18 follows: 21-6614. (a) (1) Except as provided in subsections (b), (c), (d), (e)
19 and (f), any person convicted in this state of a traffic infraction, cigarette
20 or tobacco infraction, misdemeanor or a class D or E felony, or for crimes
21 committed on or after July 1, 1993, nondrug crimes ranked in severity
22 levels 6 through 10, or for crimes committed on or after July 1, 1993, but
23 prior to July 1, 2012, any felony ranked in severity level 4 of the drug grid,
24 or for crimes committed on or after July 1, 2012, any felony ranked in
25 severity level 5 of the drug grid may petition the convicting court for the
26 expungement of such conviction or related arrest records if three or more
27 years have elapsed since the person: (A) Satisfied the sentence imposed; or
28 (B) was discharged from probation, a community correctional services
29 program, parole, postrelease supervision, conditional release or a
30 suspended sentence.

31 (2) Except as provided in subsections (b), (c), (d), (e) and (f), any
32 person who has fulfilled the terms of a diversion agreement may petition
33 the district court for the expungement of such diversion agreement and
34 related arrest records if three or more years have elapsed since the terms of
35 the diversion agreement were fulfilled.

36 (b) Any person convicted of prostitution, as defined in K.S.A. 21-
37 3512, prior to its repeal, convicted of a violation of K.S.A. 2013 Supp. 21-
38 6419, and amendments thereto, or who entered into a diversion agreement
39 in lieu of further criminal proceedings for such violation, may petition the
40 convicting court for the expungement of such conviction or diversion
41 agreement and related arrest records if:

42 (1) One or more years have elapsed since the person satisfied the
43 sentence imposed or the terms of a diversion agreement or was discharged

1 from probation, a community correctional services program, parole,
2 postrelease supervision, conditional release or a suspended sentence; and

3 (2) such person can prove they were acting under coercion caused by
4 the act of another. For purposes of this subsection, "coercion" means:
5 Threats of harm or physical restraint against any person; a scheme, plan or
6 pattern intended to cause a person to believe that failure to perform an act
7 would result in bodily harm or physical restraint against any person; or the
8 abuse or threatened abuse of the legal process.

9 (c) Except as provided in subsections (e) and (f), no person may
10 petition for expungement until five or more years have elapsed since the
11 person satisfied the sentence imposed or the terms of a diversion
12 agreement or was discharged from probation, a community correctional
13 services program, parole, postrelease supervision, conditional release or a
14 suspended sentence, if such person was convicted of a class A, B or C
15 felony, or for crimes committed on or after July 1, 1993, if convicted of an
16 off-grid felony or any nondrug crime ranked in severity levels 1 through 5,
17 or for crimes committed on or after July 1, 1993, but prior to July 1, 2012,
18 any felony ranked in severity levels 1 through 3 of the drug grid, or for
19 crimes committed on or after July 1, 2012, any felony ranked in severity
20 levels 1 through 4 of the drug grid, or:

21 (1) Vehicular homicide, as defined in K.S.A. 21-3405, prior to its
22 repeal, or K.S.A. 2013 Supp. 21-5406, and amendments thereto, or as
23 prohibited by any law of another state which is in substantial conformity
24 with that statute;

25 (2) driving while the privilege to operate a motor vehicle on the
26 public highways of this state has been canceled, suspended or revoked, as
27 prohibited by K.S.A. 8-262, and amendments thereto, or as prohibited by
28 any law of another state which is in substantial conformity with that
29 statute;

30 (3) perjury resulting from a violation of K.S.A. 8-261a, and
31 amendments thereto, or resulting from the violation of a law of another
32 state which is in substantial conformity with that statute;

33 (4) violating the provisions of the fifth clause of K.S.A. 8-142, and
34 amendments thereto, relating to fraudulent applications or violating the
35 provisions of a law of another state which is in substantial conformity with
36 that statute;

37 (5) any crime punishable as a felony wherein a motor vehicle was
38 used in the perpetration of such crime;

39 (6) failing to stop at the scene of an accident and perform the duties
40 required by K.S.A. 8-1602, 8-1603, prior to its repeal, or 8-1604, and
41 amendments thereto, or required by a law of another state which is in
42 substantial conformity with those statutes;

43 (7) violating the provisions of K.S.A. 40-3104, and amendments

1 thereto, relating to motor vehicle liability insurance coverage; or

2 (8) a violation of K.S.A. 21-3405b, prior to its repeal.

3 (d) No person may petition for expungement until 10 or more years
4 have elapsed since the person satisfied the sentence imposed or the terms
5 of a diversion agreement or was discharged from probation, a community
6 correctional services program, parole, postrelease supervision, conditional
7 release or a suspended sentence, if such person was convicted of a
8 violation of K.S.A. 8-1567, and amendments thereto, including any
9 diversion for such violation.

10 (e) There shall be no expungement of convictions for the following
11 offenses or of convictions for an attempt to commit any of the following
12 offenses:

13 (1) Rape, as defined in K.S.A. 21-3502, prior to its repeal, or K.S.A.
14 2013 Supp. 21-5503, and amendments thereto;

15 (2) indecent liberties with a child or aggravated indecent liberties
16 with a child, as defined in K.S.A. 21-3503 or 21-3504, prior to their repeal,
17 or K.S.A. 2013 Supp. 21-5506, and amendments thereto;

18 (3) criminal sodomy, as defined in subsection (a)(2) or (a)(3) of
19 K.S.A. 21-3505, prior to its repeal, or subsection (a)(3) or (a)(4) of K.S.A.
20 2013 Supp. 21-5504, and amendments thereto;

21 (4) aggravated criminal sodomy, as defined in K.S.A. 21-3506, prior
22 to its repeal, or K.S.A. 2013 Supp. 21-5504, and amendments thereto;

23 (5) indecent solicitation of a child or aggravated indecent solicitation
24 of a child, as defined in K.S.A. 21-3510 or 21-3511, prior to their repeal,
25 or K.S.A. 2013 Supp. 21-5508, and amendments thereto;

26 (6) sexual exploitation of a child, as defined in K.S.A. 21-3516, prior
27 to its repeal, or K.S.A. 2013 Supp. 21-5510, and amendments thereto;

28 (7) aggravated incest, as defined in K.S.A. 21-3603, prior to its
29 repeal, or K.S.A. 2013 Supp. 21-5604, and amendments thereto;

30 (8) endangering a child or aggravated endangering a child, as defined
31 in K.S.A. 21-3608 or 21-3608a, prior to their repeal, or K.S.A. 2013 Supp.
32 21-5601, and amendments thereto;

33 (9) abuse of a child, as defined in K.S.A. 21-3609, prior to its repeal,
34 or K.S.A. 2013 Supp. 21-5602, and amendments thereto;

35 (10) capital murder, as defined in K.S.A. 21-3439, prior to its repeal,
36 or K.S.A. 2013 Supp. 21-5401, and amendments thereto;

37 (11) murder in the first degree, as defined in K.S.A. 21-3401, prior to
38 its repeal, or K.S.A. 2013 Supp. 21-5402, and amendments thereto;

39 (12) murder in the second degree, as defined in K.S.A. 21-3402, prior
40 to its repeal, or K.S.A. 2013 Supp. 21-5403, and amendments thereto;

41 (13) voluntary manslaughter, as defined in K.S.A. 21-3403, prior to
42 its repeal, or K.S.A. 2013 Supp. 21-5404, and amendments thereto;

43 (14) involuntary manslaughter, as defined in K.S.A. 21-3404, prior to

1 its repeal, or K.S.A. 2013 Supp. 21-5405, and amendments thereto;

11 (f) Notwithstanding any other law to the contrary, for any offender
12 who is required to register as provided in the Kansas offender registration
13 act, K.S.A. 22-4901 et seq., and amendments thereto, there shall be no
14 expungement of any conviction or any part of the offender's criminal
15 record while the offender is required to register as provided in the Kansas
16 offender registration act.

17 (g) (1) When a petition for expungement is filed, the court shall set a
18 date for a hearing of such petition and shall cause notice of such hearing to
19 be given to the prosecutor and the arresting law enforcement agency. The
20 petition shall state the:

21 (A) Defendant's full name;

22 (B) full name of the defendant at the time of arrest, conviction or
23 diversion, if different than the defendant's current name;

24 (C) defendant's sex, race and date of birth;

25 (D) crime for which the defendant was arrested, convicted or
26 diverted;

27 (E) date of the defendant's arrest, conviction or diversion; and

28 (F) identity of the convicting court, arresting law enforcement
29 authority or diverting authority.

30 (2) Except as otherwise provided by law, a petition for expungement
31 shall be accompanied by a docket fee in the amount of ~~\$100~~ \$176. On and
32 after ~~April 12, 2012, through June 30, 2013~~ July 1, 2013, through July 1,
33 2015, the supreme court may impose a charge, not to exceed \$19 per case,
34 to fund the costs of non-judicial personnel. The charge established in this
35 section shall be the only fee collected or moneys in the nature of a fee
36 collected for the case. Such charge shall only be established by an act of
37 the legislature and no other authority is established by law or otherwise to
38 collect a fee.

39 (3) All petitions for expungement shall be docketed in the original
40 criminal action. Any person who may have relevant information about the
41 petitioner may testify at the hearing. The court may inquire into the
42 background of the petitioner and shall have access to any reports or
43 records relating to the petitioner that are on file with the secretary of

1 corrections or the prisoner review board.

2 (h) At the hearing on the petition, the court shall order the petitioner's
3 arrest record, conviction or diversion expunged if the court finds that:

4 (1) The petitioner has not been convicted of a felony in the past two
5 years and no proceeding involving any such crime is presently pending or
6 being instituted against the petitioner;

7 (2) the circumstances and behavior of the petitioner warrant the
8 expungement; and

9 (3) the expungement is consistent with the public welfare.

10 (i) When the court has ordered an arrest record, conviction or
11 diversion expunged, the order of expungement shall state the information
12 required to be contained in the petition. The clerk of the court shall send a
13 certified copy of the order of expungement to the Kansas bureau of
14 investigation which shall notify the federal bureau of investigation, the
15 secretary of corrections and any other criminal justice agency which may
16 have a record of the arrest, conviction or diversion. After the order of
17 expungement is entered, the petitioner shall be treated as not having been
18 arrested, convicted or diverted of the crime, except that:

19 (1) Upon conviction for any subsequent crime, the conviction that
20 was expunged may be considered as a prior conviction in determining the
21 sentence to be imposed;

22 (2) the petitioner shall disclose that the arrest, conviction or diversion
23 occurred if asked about previous arrests, convictions or diversions:

24 (A) In any application for licensure as a private detective, private
25 detective agency, certification as a firearms trainer pursuant to K.S.A.
26 2013 Supp. 75-7b21, and amendments thereto, or employment as a
27 detective with a private detective agency, as defined by K.S.A. 75-7b01,
28 and amendments thereto; as security personnel with a private patrol
29 operator, as defined by K.S.A. 75-7b01, and amendments thereto; or with
30 an institution, as defined in K.S.A. 76-12a01, and amendments thereto, of
31 the *Kansas* department for ~~children and families~~ *aging and disability*
32 *services*;

33 (B) in any application for admission, or for an order of reinstatement,
34 to the practice of law in this state;

35 (C) to aid in determining the petitioner's qualifications for
36 employment with the Kansas lottery or for work in sensitive areas within
37 the Kansas lottery as deemed appropriate by the executive director of the
38 Kansas lottery;

39 (D) to aid in determining the petitioner's qualifications for executive
40 director of the Kansas racing and gaming commission, for employment
41 with the commission or for work in sensitive areas in parimutuel racing as
42 deemed appropriate by the executive director of the commission, or to aid
43 in determining qualifications for licensure or renewal of licensure by the

1 commission;

2 (E) to aid in determining the petitioner's qualifications for the
3 following under the Kansas expanded lottery act: (i) Lottery gaming
4 facility manager or prospective manager, racetrack gaming facility
5 manager or prospective manager, licensee or certificate holder; or (ii) an
6 officer, director, employee, owner, agent or contractor thereof;

7 (F) upon application for a commercial driver's license under K.S.A.
8 8-2,125 through 8-2,142, and amendments thereto;

9 (G) to aid in determining the petitioner's qualifications to be an
10 employee of the state gaming agency;

11 (H) to aid in determining the petitioner's qualifications to be an
12 employee of a tribal gaming commission or to hold a license issued
13 pursuant to a tribal-state gaming compact;

14 (I) in any application for registration as a broker-dealer, agent,
15 investment adviser or investment adviser representative all as defined in
16 K.S.A. 17-12a102, and amendments thereto;

17 (J) in any application for employment as a law enforcement officer as
18 defined in K.S.A. 22-2202 or 74-5602, and amendments thereto; or

19 (K) for applications received on and after July 1, 2006, to aid in
20 determining the petitioner's qualifications for a license to carry a concealed
21 weapon pursuant to the personal and family protection act, K.S.A. 2013
22 Supp. 75-7c01 et seq., and amendments thereto;

23 (3) the court, in the order of expungement, may specify other
24 circumstances under which the conviction is to be disclosed;

25 (4) the conviction may be disclosed in a subsequent prosecution for
26 an offense which requires as an element of such offense a prior conviction
27 of the type expunged; and

28 (5) upon commitment to the custody of the secretary of corrections,
29 any previously expunged record in the possession of the secretary of
30 corrections may be reinstated and the expungement disregarded, and the
31 record continued for the purpose of the new commitment.

32 (j) Whenever a person is convicted of a crime, pleads guilty and pays
33 a fine for a crime, is placed on parole, postrelease supervision or
34 probation, is assigned to a community correctional services program, is
35 granted a suspended sentence or is released on conditional release, the
36 person shall be informed of the ability to expunge the arrest records or
37 conviction. Whenever a person enters into a diversion agreement, the
38 person shall be informed of the ability to expunge the diversion.

39 (k) (1) Subject to the disclosures required pursuant to subsection (i),
40 in any application for employment, license or other civil right or privilege,
41 or any appearance as a witness, a person whose arrest records, conviction
42 or diversion of a crime has been expunged under this statute may state that
43 such person has never been arrested, convicted or diverted of such crime.

1 (2) Notwithstanding the provisions of subsection (k)(1), and except as
2 provided in subsection (a)(3)(A) of K.S.A. 2013 Supp. 21-6304, and
3 amendments thereto, the expungement of a prior felony conviction does
4 not relieve the individual of complying with any state or federal law
5 relating to the use, shipment, transportation, receipt or possession of
6 firearms by persons previously convicted of a felony.

7 (1) Whenever the record of any arrest, conviction or diversion has
8 been expunged under the provisions of this section or under the provisions
9 of any other existing or former statute, the custodian of the records of
10 arrest, conviction, diversion and incarceration relating to that crime shall
11 not disclose the existence of such records, except when requested by:

12 (1) The person whose record was expunged;

13 (2) a private detective agency or a private patrol operator, and the
14 request is accompanied by a statement that the request is being made in
15 conjunction with an application for employment with such agency or
16 operator by the person whose record has been expunged;

17 (3) a court, upon a showing of a subsequent conviction of the person
18 whose record has been expunged;

19 (4) ~~the secretary of the department for children and families for aging~~
20 ~~and disability services~~, or a designee of the secretary, for the purpose of
21 obtaining information relating to employment in an institution, as defined
22 in K.S.A. 76-12a01, and amendments thereto, of the *Kansas* department
23 for ~~children and families for aging and disability services~~ of any person
24 whose record has been expunged;

25 (5) a person entitled to such information pursuant to the terms of the
26 expungement order;

27 (6) a prosecutor, and such request is accompanied by a statement that
28 the request is being made in conjunction with a prosecution of an offense
29 that requires a prior conviction as one of the elements of such offense;

30 (7) the supreme court, the clerk or disciplinary administrator thereof,
31 the state board for admission of attorneys or the state board for discipline
32 of attorneys, and the request is accompanied by a statement that the
33 request is being made in conjunction with an application for admission, or
34 for an order of reinstatement, to the practice of law in this state by the
35 person whose record has been expunged;

36 (8) the Kansas lottery, and the request is accompanied by a statement
37 that the request is being made to aid in determining qualifications for
38 employment with the Kansas lottery or for work in sensitive areas within
39 the Kansas lottery as deemed appropriate by the executive director of the
40 Kansas lottery;

41 (9) the governor or the Kansas racing and gaming commission, or a
42 designee of the commission, and the request is accompanied by a
43 statement that the request is being made to aid in determining

1 qualifications for executive director of the commission, for employment
2 with the commission, for work in sensitive areas in parimutuel racing as
3 deemed appropriate by the executive director of the commission or for
4 licensure, renewal of licensure or continued licensure by the commission;

5 (10) the Kansas racing and gaming commission, or a designee of the
6 commission, and the request is accompanied by a statement that the
7 request is being made to aid in determining qualifications of the following
8 under the Kansas expanded lottery act: (A) Lottery gaming facility
9 managers and prospective managers, racetrack gaming facility managers
10 and prospective managers, licensees and certificate holders; and (B) their
11 officers, directors, employees, owners, agents and contractors;

12 (11) the Kansas sentencing commission;

13 (12) the state gaming agency, and the request is accompanied by a
14 statement that the request is being made to aid in determining
15 qualifications: (A) To be an employee of the state gaming agency; or (B)
16 to be an employee of a tribal gaming commission or to hold a license
17 issued pursuant to a tribal-gaming compact;

18 (13) the Kansas securities commissioner or a designee of the
19 commissioner, and the request is accompanied by a statement that the
20 request is being made in conjunction with an application for registration as
21 a broker-dealer, agent, investment adviser or investment adviser
22 representative by such agency and the application was submitted by the
23 person whose record has been expunged;

24 (14) the Kansas commission on peace officers' standards and training
25 and the request is accompanied by a statement that the request is being
26 made to aid in determining certification eligibility as a law enforcement
27 officer pursuant to K.S.A. 74-5601 et seq., and amendments thereto;

28 (15) a law enforcement agency and the request is accompanied by a
29 statement that the request is being made to aid in determining eligibility
30 for employment as a law enforcement officer as defined by K.S.A. 22-
31 2202, and amendments thereto;

32 (16) the attorney general and the request is accompanied by a
33 statement that the request is being made to aid in determining
