## SENATE BILL No. 63

1 AN ACT concerning elections; relating to voting; regarding penalties for  
2 voting crimes; concerning prosecution of election crimes; amending  
3 K.S.A. 25-2409, 25-2416, 25-2423~~and~~, 25-2431 **and 25-4153b** and  
4 K.S.A. 2012 Supp. 25-1128 and 25-2507 and repealing the existing  
5 sections.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 ~~*{New Section 1. (a) Except as provided in subsection (b), the*~~  
9 ~~*secretary of state shall not establish any political committee, a major*~~  
10 ~~*purpose of which is to expressly advocate the nomination, election or*~~  
11 ~~*defeat of a clearly identified candidate for the legislature or statewide*~~  
12 ~~*office or make contributions or expenditures for the nomination,*~~  
13 ~~*election or defeat of a clearly identified candidate for the legislature or a*~~  
14 ~~*statewide office.*~~

15 ~~*(b) The provisions of this section shall not apply to any political*~~  
16 ~~*committee which is established to expressly advocate for the election of a*~~  
17 ~~*candidate for the office of secretary of state or to make contributions or*~~  
18 ~~*expenditures for the election of a candidate for the office of secretary of*~~  
19 ~~*state.*~~

20 ~~*(c) Any political committee currently in existence, which is in*~~  
21 ~~*violation of subsection (a), is hereby abolished.*~~

22 ~~*(d) The provisions of this section shall be part of and supplemental*~~  
23 ~~*to the campaign finance act.*~~

24 New Section 1. ~~{Sec. 2.}~~ **NEW SECTION 1.** (a) Voting more than once is  
25 knowingly *intentionally*:

26 (1) Voting or ~~offering~~ *attempting* to vote more than once in the same  
27 jurisdiction or voting in more than one jurisdiction in the United States in  
28 an election held on a particular date.

29 (2) Inducing or aiding any person to vote more than once in the same  
30 jurisdiction or voting in more than one jurisdiction in the United States in

1 an election held on a particular date.

2 (b) Voting more than once is a severity level ~~7~~ 9, nonperson felony.

3 (c) ***This section shall be part of and supplemental to article 24 of***  
4 ***chapter 25 of the Kansas Statutes Annotated, and amendments thereto.***

5 New Sec. ~~2-131~~ 2. (a) Independent authority to prosecute any person  
6 who has violated or attempted to violate any act that constitutes a Kansas  
7 elections crime defined in K.S.A. 25-2401 through 25-2433, and  
8 ~~amendments thereto, and including this act 25-1128 or article 24 of~~  
9 ***chapter 25 of the Kansas Statutes Annotated, and amendments thereto,***  
10 shall be vested in:

11 (1) The district attorney or county attorney of the county where such  
12 violations occurred;

13 (2) the Kansas attorney general; or

14 (3) the Kansas secretary of state.

15 (b) If one of the officers listed in section (a) has commenced the  
16 prosecution of a person who has violated or attempted to violate any act  
17 that constitutes a Kansas election crime, the other officers listed in section  
18 (a) may provide assistance to the prosecuting officer but may not  
19 commence a separate prosecution.

20 Sec. ~~3-141~~ 3. K.S.A. 2012 Supp. 25-1128 is hereby amended to read  
21 as follows: 25-1128. (a) No voter shall knowingly mark or transmit to the  
22 county election officer more than one advance voting ballot, or set of one  
23 of each kind of ballot, if the voter is entitled to vote more than one such  
24 ballot at a particular election.

25 (b) Except as provided in K.S.A. 25-1124, and amendments thereto,  
26 no person shall knowingly interfere with or delay the transmission of any  
27 advance voting ballot application from a voter to the county election  
28 officer, nor shall any person mail, fax or otherwise cause the application to  
29 be sent to a place other than the county election office. Any person or  
30 group engaged in the distribution of advance voting ballot applications  
31 shall mail, fax or otherwise deliver any application signed by a voter to the  
32 county election office within two days after such application is signed by  
33 the applicant.

34 (c) Except as otherwise provided by law, no person other than the  
35 voter, shall knowingly mark, sign or transmit to the county election officer  
36 any advance voting ballot or advance voting ballot envelope.

37 (d) Except as otherwise provided by law, no person shall knowingly  
38 sign an application for an advance voting ballot for another person. This  
39 provision shall not apply if a voter has a disability preventing the voter  
40 from signing an application or if an immediate family member signs an  
41 application on behalf of another immediate family member with proper  
42 authorization being given.

43 (e) No person, unless authorized by K.S.A. 25-1122 or K.S.A. 25-

1 1124, and amendments thereto, shall knowingly intercept, interfere with,  
 2 or delay the transmission of advance voting ballots from the county  
 3 election officer to the voter.

4 (f) No person shall knowingly and falsely affirm, declare or subscribe  
 5 to any material fact in an affirmation form for an advance voting ballot or  
 6 set of advance voting ballots.

7 (g) A voter may return such voter's advance voting ballot to the  
 8 county election officer by personal delivery or by mail. Upon written  
 9 designation by the voter, a person other than the voter may return the  
 10 advance voting ballot by personal delivery or mail. Any such person  
 11 designated by the voter shall sign a statement that such person has not  
 12 exercised undue influence on the voting decisions of the voter and agrees  
 13 to deliver the ballot as directed by the voter.

14 (h) Violation of any provision of this section is a ~~class C~~  
 15 ~~misdemeanor~~ **severity level 9, nonperson felony class A misdemeanor.**

16 Sec. ~~4-5-1~~ **4.** K.S.A. 25-2409 is hereby amended to read as follows:  
 17 25-2409. (a) Election bribery is conferring, offering or agreeing to confer,  
 18 or soliciting, accepting or agreeing to accept any benefit as consideration  
 19 to or from any person either to vote or withhold any person's vote, or to  
 20 vote for or against any candidate or question submitted at any public  
 21 election.

22 (b) *This section shall not apply to a business or organization that*  
 23 *provides a product of a value less than \$3.00 to any person who asserts*  
 24 *that such person has voted, without regard to the voter's vote for or*  
 25 *against any candidate or issue.*

26 (c) Election bribery is a severity level 7, nonperson felony.

27 Sec. ~~5-16-1~~ **5.** K.S.A. 25-2416 is hereby amended to read as follows:  
 28 25-2416. (a) Voting without being qualified is knowingly ~~and willfully~~  
 29 ~~(a):~~ (1) Voting or attempting to vote ~~at~~ *in* any election *district* when not a  
 30 lawfully registered voter: *in such election district; or*

31 ~~(b)(2) Voting or offering to vote more than once at the same~~  
 32 ~~election~~ *voting or attempting to vote at any election by a person who is not*  
 33 *a citizen of the United States or who does not otherwise meet the*  
 34 *qualification of an elector.*

35 ~~(e)(b) Inducing or aiding any person to vote more than once at the~~  
 36 ~~same election.~~ Voting without being qualified is a ~~class A misdemeanor~~  
 37 **severity level 7 9, nonperson felony.**

38 Sec. ~~6-17-1~~ **6.** K.S.A. 25-2423 is hereby amended to read as follows:  
 39 25-2423. (a) Election tampering is, while being charged with no election  
 40 duty, making or changing any election record.

41 (b) Election tampering is a severity level ~~8-7~~ **8**, nonperson felony.

42 Sec. ~~7-18-1~~ **7.** K.S.A. 25-2431 is hereby amended to read as follows:  
 43 25-2431. (a) False impersonation of a voter is representing oneself as

1 another *person whether real or fictitious* and ~~thereas thereby~~ voting or  
2 attempting to vote.

3 (b) False impersonation of a voter is a severity level 98 9, nonperson  
4 felony.

5 **New Sec. 8. In addition to any sentence that may be imposed for a**  
6 **violation of article 24 of chapter 25 of the Kansas Statutes Annotated,**  
7 **and amendments thereto, the court shall order the right of the**  
8 **convicted person to vote be disenfranchised for a period of four years.**  
9 **The court shall direct that a copy of the order disenfranchising the**  
10 **right to vote be delivered to the election officer of the county of**  
11 **residence of the convicted person and the secretary of state for the**  
12 **purpose of removing the defendant from the official records for voter**  
13 **registration.**

14 ~~Sec. 8. {9.}~~ K.S.A. 2012 Supp. 25-2507 is hereby amended to read as  
15 follows: 25-2507. (a) "Poll book" means a book in which each voter may  
16 sign the voter's signature and a number is assigned by one of the clerks of  
17 the election board when the voter is given a ballot or set of ballots. If the  
18 county election officer determines that voters shall sign the poll book, such  
19 book shall also contain on each page the declaration prescribed by  
20 subsection (d).

21 (b) "Registration book" means: (1) A book or list containing the  
22 names and other information relating to registered voters. Registration  
23 books shall have the names entered therein before the same or copies  
24 thereof are delivered to the supervising judges. Registration books may  
25 also contain blank lines on which each voter shall sign the voter's  
26 signature. If the county election officer determines that voters shall sign  
27 the registration book, such book shall also contain on each page the  
28 declaration prescribed by subsection (d); or

29 (2) a book meeting the requirements of K.S.A. 25-2507 (b)(1), and  
30 amendments thereto; containing blank lines on which each voter shall sign  
31 the voter's signature; containing on each page the declaration prescribed  
32 by subsection (d); and containing the numbers assigned by one of the  
33 clerks of the election board when voters are given ballots or sets of ballots.

34 (c) "Party affiliation lists" means a list containing the names of all  
35 registered voters of a county who have lawfully designated a party  
36 affiliation.

37 (d) "Declaration" means the following: "I, the undersigned, declare  
38 under penalty of perjury that I am a registered voter in the state of Kansas,  
39 county of \_\_\_\_\_, that I have not signed a name other than my own in  
40 order to represent myself as any other registered voter, and that I am  
41 qualified to vote and have not previously voted and will not vote again ~~at~~  
42 ~~this election~~ *in the election held on this date, in this or any other*  
43 *jurisdiction in the United States, for any offices or ballot issues."*

1       **Sec. 10. K.S.A. 25-4153b is hereby amended to read as follows:**  
2       **25-4153b. (a) No political committee, a major purpose of which is to**  
3       **expressly advocate the nomination, election or defeat of a clearly**  
4       **identified candidate for the legislature or to make contributions or**  
5       **expenditures for the nomination, election or defeat of a clearly**  
6       **identified candidate for the legislature, shall be established by a**  
7       **member of the legislature.**

8       *(b) Any such political committee existing prior to the effective date of*  
9       *this act is hereby abolished. {Any funds remaining in such political*  
10       **committee may be donated in its entirety to a political party.}**

11       Sec. ~~9-110~~ **11.** K.S.A. 25-2409, 25-2416, 25-2423 ~~and~~, 25-2431 **and**  
12       **25-4153b** and K.S.A. 2012 Supp. 25-1128 and 25-2507 are hereby  
13       repealed.

14       Sec. ~~10-111~~ **12.** This act shall take effect and be in force from and  
15       after its publication in the statute book.
